Hi Rachel

Keith Tracey-Patte requested I send you a timeline to confirm the critical dates relating to Vibe. The following are the key dates:

- 6 June 2014 - Minsub signed by Minister Dutton with the decision to cease funding to Vibe as from 30 June 2014.
- 10 June 2014 - WA State Office informed of Ministers' decision and asked to contact Gavin Jones.
- 10 June 2014 - John Tunney (WA Director) rang Gavin Jones with the news that funding would cease as of 30 June 2014.
- 13 June 2014 - Gavin Jones emailed Ministers Scullion and Dutton requesting an urgent meeting to discuss the decision and implications of funding cessation.
- 16 June 2014 - John Tunney wrote to Gavin Jones with the formal advice that funding was to cease as from 30 June 2014.
- 24 June 2014 - Gavin Jones met with Minister Nash.
- 26 June 2014 - Minsub signed by Minister Dutton to approve 'bridging funding' of \$550,000 (GST Inclusive) to Vibe Australia for the period June to December 2014.
- 27 June 2014 - WA State Office informed of Minister's decision for transition funding to December 2014. We were informed that Gavin had been notified by Central Office of the news.
- 30 June 2014 - The Reg 9 for the \$550,000 (GST Inclusive) was recommended by Robyn Brunker and signed by Masha Somi.
- 2 July 2014 - John Tunney rang Gavin Jones to discuss the six months transition funding and what this means with regards project aims for this period of time.
- 2 July 2014 - WA State Office emails draft Project Aims and Description for Gavin Jones to review before finalising.
- 3 July 2014 - Gavin Jones replies by email to say that he was happy with the Project Aims and Description.
- 8 July 2014 - Letter of Offer (signed by John Tunney) for the transition funding of \$550,000 (GST Inclusive) was sent to Gavin Jones.
- 9 July 2014 - John Tunney speaks to Gavin Jones to discuss Dov and project.
- 10 July 2014 - Gavin Jones returns the signed Deed of Variation (DoV) to WA State Office.

- 10 July 2014 - John Tunney signs and executes the DoV.
- 10 July 2014 - Acknowledgement letter with executed DoV emailed to Gavin Jones.
