I have spoken with the section who have responsibility for the headspace initiative. I am told that the blueprint model that Prof Hickie refers to has been developed by him and a number of others, and the Department has not been involved in the development of this.

Prof Pat McGorry, another of the authors of the blueprint model, describes the document as being 'a Blueprint for Mental Health reform consisting of measures that the Australian Government can and should invest in at the May budget.'

As such I am seeking direction as to whether a response to Prof Hickie is required, and if so what focus this response should include.
