Thank you for sending this draft report on Tuesday.

I have a few comments and suggested edits which are included as track changes in the attached document. The work order is very close to being finalised- than you very much.

I would like to work towards publication of the preliminary Review Findings (including publication of this report) early in 2014 .

.....Notes on the work order.....

1. Revise the Occupational Health And Safety Assessment Of Fenthion (First draft August 2001 revised May 2005 and Sept 2010) to:
 - a. Replace the following POEM assessments with suitable PHED estimates: DONE – thank you for incorporating the current permit uses
 - b. Scenario (9) Spot-on application for cattle use of surrogate cattle spot-on study DONE
 - c. Confirm whether the 117 g/L home pest control product meets the MORAG– DONE and the PHED assessment of this use pattern does not support the product -
 - d. Advise whether the Fenthion dust product is a 're-entry issue' when applied in domestic ceiling voids (up to 9 hours) need to mention the CEILING VOIDS, WALL VOIDS AND CRAWL SPACES – PDF Label attached to show the use patterns on this label – some may be unacceptable – if so can the report recommend this ?
2. Incorporate these revisions into the existing report to produce a report suitable for publication. DONE

Note on the track marked changes and comments – hoping that your system will happily display and search these.

1. – page 6 Need to clarify the acceptability or otherwise of ceiling voids, wall voids, crawl spaces.

2. – further down page 6 marked cracks and crevices only
3. – page 7 - Need to clarify the acceptability or otherwise of ceiling voids, wall voids, crawl spaces.
4. – page 23 and 24 Table 9 and text following – don't need the first 2 rows as the EC 117 g/L product is for spiders, ants, mosquitoes – it does not need to be included in this table for horticultural air blast uses
5. - page 25 and 26 Table 9 and text following – as the EC 117 g/L product is for spiders, ants, mosquitoes – it does not need to be included in this table for horticultural boom spray uses
6. - page 29 x 2 and page 31 x 2– typo - added the “n” to open
7. – page 29 in Table 15 - the description for ornamental plants has accidentally been copied into the 110 g/L fenthion paint table
8. – page 32 – marked where may need to clarify the acceptability or otherwise of ceiling voids, wall voids, crawl spaces.
9. – page 34 - Table 17 and text following – as the EC 117 g/L product is for spiders, ants, mosquitoes – it does not need to be included in this table for horticultural air blast uses
10. - page 35 - Table 18 and text following – as the EC 117 g/L product is for spiders, ants, mosquitoes – it does not need to be included in this table for horticultural boom spray uses
11. – page 37 typo – added an n to shown
12. – page 38 typo OSC for OCS
13. - page 39 x 2 and page 40 x 2– typo - added the “n” to open
14. - page 42 in Table 23 - the description for ornamental plants had accidentally been copied into the 110 g/L fenthion paint table.
15. – page 43 and pages following. I would like to clarify the list of crops for re-entry intervals. My recollection is that stonefruit are grouped in with the other deciduous fruits (apples, pears etc) and I would like to be sure of this so that we apply the correct REI for stonefruit. Also can we use the term citrus instead of grapefruit, lemons? – “citrus” is the crop description on the WA permit.
16. Appendix 2 – changed the tense to make it up to date – currently there are no approved uses in the USA that I can find.
