Proposed Deletion on the Stoma Appliance Scheme

The applicant, Omnigon, sought the deletion of the entire product range from the current listing of Omnigon Welland Hyperseal Washer (SAS Code 80074K) in subgroup 9(l) of the Stoma Appliance Scheme (SAS) Schedule, as it is no longer manufactured. The product, including 5 variants, is currently listed at a unit price of \$4.532 with a maximum monthly quantity of 30 units.
