## BE COVIDSAFE

# Information for passengers arriving on a flight from China, Hong Kong and Macau without the relevant COVID-19 test having been obtained.

It is an Australian Government requirement that an individual must be able to produce to a relevant official evidence of a negative COVID-19 test.

#### NAAT test and other approved tests

An individual must be able to produce evidence of a negative NAAT test or other approved test.

### Rapid Antigen Test (RAT)

The RAT must be carried out, by or under the supervision of a medical practitioner.

An individual must be able to produce a certificate that contains the following information:

- (a) the date and time of the test;
- (b) the name of the individual tested;
- (c) the type of test conducted;
- (d) the brand and make of the test;
- (e) that the specimen for the test was collected, and the test was carried out, by or under the supervision of a medical practitioner;
- (f) the result of the test;
- (g) the signature of the medical practitioner providing the certificate.
- The Australian Government's requirements are that you must be able to produce to a relevant official evidence in a specified form of a negative COVID-19 test.
- If you do not have evidence of a negative test result the Australian Government may commence proceedings against you which may result in a monetary penalty of up to 30 penalty units which is \$8250 AUD.
- If the Australian Government considers that there are sufficient grounds to justify commencing proceedings against you for not complying with the requirement, you will be notified within six weeks of this date.
- At that time you will be provided with an opportunity to present any mitigating circumstances or reasons for an exemption which will be considered.
- If you feel unwell while in Australia, you should get tested for COVID-19 and seek advice from local health authorities.

#### Privacy and your personal information

- Your personal information is protected by law, including the *Privacy Act 1988* and the Australian Privacy Principles, and is being collected by the Department of Agriculture, Fisheries and Forestry for the primary purpose of providing information to the Department of Health and Aged Care regarding your compliance with the entry requirements to provide evidence of a negative COVID-19 test. Your information may be used and disclosed to other government agencies for purposes including providing information about and taking action in relation to non-compliance with the entry requirements to provide evidence of a negative COVID-19 test.
- If you do not provide this information the Australian Government may commence proceedings against you which may result in a monetary penalty of up to 30 penalty units which is \$8250 AUD.
