


Vaccine milestone charts




Australia's COVID-19 Vaccine Program




Vaccinations by age and location

Number of people vaccinated by age







Explanatory Notes

The Australian Immunisation Register (AIR). The Australian Immunisation Register is a national register that records all vaccines given to all people in Australia.

People received at least x dose/s. The count of unique people who have received at least x dose/s of a COVID-19 vaccine. People with at least x dose/s encompasses people who received x dose/s or more. Please note, to capture a person's current level of protection, this methodology includes any doses an individual received overseas where they have been uploaded into the Australian Immunisation Register, and where the vaccine brand is recognised by the TGA. Some people may not be included in this count where they are viewed as no longer in scope of the vaccination rollout (for example, where a person has permanently left Australia, or they have passed away).

Coverage calculations. First and second dose rates are calculated by taking the number of unique people who have received the corresponding dose from the Australian Immunisation Register and dividing this by the Australian Bureau of Statistics Estimated Residential Population (2021). For doses that are third in sequence or above, the coverage rates often refer to the *eligible* population – that is, the number of people with the dose over the number of people who meet the criteria for that dose in the Australian Immunisation Register. Vaccine coverage uses the state of residence (based on a person's Medicare address).

Eligible population. Eligible population refers to the number of these individuals who meet the criteria for a given dose based on completion of previous doses, age, and time period elapsed since last dose. Please note that the Australian Immunisation Register cannot identify immunocompromised individuals.

Vaccine doses administered. The total number of COVID-19 doses administered refers to the number of doses administered rather than the number of people who have received a COVID-19 vaccine. In most cases (unless otherwise specified) all doses are included (regardless of age of recipient or the dose number), and when these numbers are provided by state, it is typically the state that the dose was physically administered in as opposed to the state where the person resides on a usual basis.

Aboriginal and Torres Strait Islander Peoples. The Aboriginal and Torres Strait Islander population refers to the number of individuals that identify as Aboriginal and Torres Strait Islander in the Australian Immunisation Register. Identifying as Aboriginal and Torres Strait Islander is optional, and the estimated population may be under reported. Numbers include all Aboriginal and Torres Strait Islander peoples who have received a vaccination and are not limited to those administered in an ACCHS setting.
