# **Local Government Area (LGA) COVID-19 Vaccine Rates**

**09 March 2023**

## Data caveats

Note on areas with large remote and very remote areas:

The process of geocoding addresses in very remote areas and remote areas can lead to artificially low vaccine dose count records in those areas (as addresses cannot be 'pinpointed' to a specific client location, and therefore LGA). The areas have been highlighted to indicate they are remote or very remote.

Methodology underpinning LGA Remoteness classification:

LGA 'remoteness' is calculated by assigning a modal remoteness value for each LGA, based on where the majority of the population in each LGA live - using 2021 Census meshblock population counts. Remote and Very Remote classifications accord with the same values if using the Modified Monash Model of remoteness.

# Metadata

**People with at least one dose.** The count of all people who have received at least one dose of an eligible vaccine. People with at least one dose encompasses people received two or more doses and people with only one dose.

**People received two doses.** Total people with two doses of any vaccine type.

**People eligible with three doses.** Total people received 3 or more doses by the number of individuals eligible to receive a third dose in the region.

**People eligible with four doses.** Total people received 4 or more doses by the number of individuals eligible to receive a fourth dose in the region.

**Estimated Resident Population (ERP).** The official measure of the population of Australia, based on their usual residence. It refers to all people, regardless of nationality, citizenship or legal status, who usually live in Australia, with the exception of foreign diplomatic personnel and their families. The ERP includes usual residents who are overseas for less than 12 months and excludes overseas visitors who are in Australia for less than 12 months.

**Local Government Area (LGA).** Local Government Areas are an ABS approximation of gazetted local government boundaries as defined by each State and Territory Local Government Department. Local Government Areas cover incorporated areas of Australia. Incorporated areas are legally designated parts of a State or Territory over which incorporated local governing bodies have responsibility. The major areas of Australia not administered by incorporated bodies are the northern parts of South Australia, and all of the Australian Capital Territory and the Other Territories. These regions are identified as 'Unincorporated' in the ASGS Local Government Areas structure.
