Dear Ms Diversi and Mr Tooth

Thank you for our conversation of 24 March 2022, and thank you for your leadership of the Northern Queensland Primary Health Network (NQPHN). As discussed, in 2021 the Department engaged PricewaterhouseCoopers (PwC) to undertake a baseline maturity assessment of all Primary Health Networks (PHNs) as part of the Department's PHN Assurance Framework. Following that baseline assessment, the Department will be commissioning performance and financial audits of around three PHNs each year to support continued improvement in the PHN program.

In the context of recent events, the Department considers it timely to conduct an audit of the NQPHN to help support its continuing stability and effective performance into the future. As discussed, there has been a history of tensions in the governance of the PHN between the organisation's members and its Board and among the various professions and sectors in the local health system. The Board's recent actions to commission its own independent review of governance and to address perceptions of conflict of interest are welcome. The Department would like to build on that review with our own independent audit to ensure full confidence in the NQPHN, including among the professions and the public.

Consistent with clause 6 of the Terms and Conditions of the 2015 Primary Health Networks Core Funding Agreement, the Department has decided to procure an auditor to conduct the review. The review will build upon the recent Baseline Maturity Assessment Process and will report on the effectiveness of NQPHN's arrangements for: financial management; governance; organisational capacity and capability; and probity and commissioning practices. The auditor will be asked to make recommendations to support the continued effective performance of NQPHN particularly relating to the governance roles of the PHN membership and its board, and to the management of relationships with the professions and other stakeholders in the region.

Once an auditor is appointed I will write further to confirm the timing of the review and its scope.

Performance and Financial Management Review North Queensland Primary Health Network

Terms of Reference

Purpose of the Review

To determine the extent to which the NQPHN has complied with its performance and financial management obligations under the Funding Agreement, including its structure, decision making processes and other arrangements relating to these. This performance and financial review will build on the findings of the baseline maturity assessment of NQPHN which assessed the organisation against six key qualitative domains: policies and procedures; people; governance and systems; risk and issues management; complaints management; and performance monitoring and reporting.

The review will have a particular focus on the governance and decision making processes of the organisation noting continuing instability of the Board over several years, and allegations of undue influence from particular professions and/or members of the organisation.

The review will also consider compliance and performance of NQPHN in the following areas:

- · Governance and decision making processes;
- Financial management, planning and reporting;
- Organisational capacity; and
- · Probity and commissioning practices.

Scope

For the purposes of determining compliance with, and performance under, the Funding Agreement, the scope will include, but is not limited to, the following items and activities.

Governance

A comprehensive review of NQPHN's corporate governance, systems, control frameworks, policies and procedures. This will include the following:

- Board capability (appointments are appropriately skilled, are independent and there are no significant gaps in the required skills/experience, training has been provided);
- roles and responsibilities are clearly stated and understood;
- professional conduct of the Board and senior staff, including professional behaviours and clear and ethical decision making processes;
- stability and effectiveness of the Board;
- circumstances and any relevant documentation regarding recent resignations of Board members;
- constitution and associated rules are adhered to;
- strategic plans in place and are regularly reviewed/revised;
- relevant and appropriate governance systems in place and functioning well;
- risk management plan in place and being monitored;
- · compliance with the Funding Agreement with the Department, including all Activities; and
- engagement and consultation is occurring with Clinical Councils and Community Advisory Committees to the clinicians and communities' satisfaction.

Financial management, planning and reporting

Undertake a review of the effectiveness of NQPHN's financial planning, management systems, internal control frameworks, policies and procedures.

The review will include an assessment of the following:

- financial governance/controls;
- · delegations and authorisations;
- budget management;
- activities and associated costs funded through self-generated income (not by the Department or other funders) to determine any cross-subsidisation;
- compliance with any financial legislative responsibilities;
- accounts payable/receivable;
- statutory liabilities;
- risk management;
- asset management;
- procurement practices;
- receipts, banking, investments;
- · adherence to the requirements of the Funding Agreement with the Department; and
- reporting.

Organisational capacity and capability

Confirm that NQPHN is on track with the review of its polies and procedures, including the effectiveness of key internal control frameworks. This will include the following:

- · policies and procedures are appropriate and adhered to;
- stability of workforce; and
- local stakeholders are satisfied with NQPHNs performance, including but not limited to, the general practice community and local Aboriginal health organisations.

Probity and commissioning practices

Undertake a review of operational systems to support the efficient and effective identification of needs and commissioning of services including key internal control frameworks, policies and procedures. This will include the following:

- policies and procedures are in place and appropriately and adhered to;
- programs and services are appropriately managed, resourced and monitored;
- probity arrangements are in place for clear, transparent and ethical decision making in relation to the commissioning and funding practices of the PHN; and
- the PHN has documented how value for money was achieved.
