Supporting people with disability to access COVID-19 vaccination

The Department of Health and Aged Care has published a [video](#) on how disability support providers can help people with disability to access COVID-19 vaccination. Service Finder: replacing Vaccine Clinic Finder

Vaccine Clinic Finder has been replaced by the Healthdirect Australia [Service Finder](#). All links to Vaccine Clinic Finder have been redirected and all vaccine services have moved to Service Finder.

The Service Finder's new and improved platform is available in 16 languages and connects people to healthcare services online. This includes finding and booking influenza and COVID-19 vaccinations for the 2023 winter season.

COVID-19 vaccination rollout data – updated format

From 31 March, the Australian Government's reports on vaccine uptake has changed. Reporting now matches the Australian Technical Advisory Group on Immunisation's [advice](#) for time-based instead of numbered doses. The [weekly statistics](#) will report on how many adults:

- have received a 2023 booster dose
- have received a dose in the past 6 months
- have received one more than 6 months ago, and
- are completely unvaccinated.

Expanded access to oral treatment Paxlovid

The Australian Government has expanded eligibility for the oral treatment Paxlovid, under the Pharmaceutical Benefits Scheme (PBS). From 1 April 2023, over 160,000 people aged 60 to 69 have access to Paxlovid.

The change means Australians in this age group with only one risk factor for severe illness – instead of 2 – will get access to PBS-subsidised Paxlovid.

People should discuss early with their doctor or nurse practitioner about whether an oral antiviral treatment suits their health needs. This discussion should also cover developing a COVID-19 plan if they test positive.

COVID-19 Vaccination In-Reach Services

The Department of Health and Aged Care is working with Primary Health Networks (PHNs) across Australia to communicate with disability service providers about the 2023 COVID-19 booster roll out.

PHNs will help sites by finding primary care vaccination options in the first instance, including in-reach services provided on site. Primary care providers such as General Practitioners and Pharmacists will administer COVID-19 vaccinations for people with disability, including those in accommodation settings.

Extra help is available, in limited circumstances, through the Vaccine Administration Partners Program.
