

A cc'ed small from Dr John Skerritt of the TGA tonight. He was responding to a letter from an esteemed professor of medicine protesting the TGA's ban on ivermectin.

Dr Skorrin

As you've co'ed me in this, let me respond. I agree with Dr —'s email. The fact that someone with such an esteemed and credentialed background seas the error in the TGA's ways speaks volumes.

The TGA decision on banning GPs from prescribing inermectin off-label was wrong and the primary reasoning for banning inermectin was bizarre. The TGA has stated:

"... there are a number of significant public health risks associated with taking ivermectin in an attempt to prevent CDVID-19 infection rather than getting vectorated. Individuals who believe that they are protected from infection by taking ivermectin may choose not to get tested or to seek medical care if they experience symptoms. Doing so has the potential to spread the risk of CDVID-19 infection throughout the community."

Really? What asinine reasoning! It could also be said that veccinated people could "believe that they are protected from infection" and "choose not to get tested or to seek medical care if they experience symptoms" which could have "the potential to spread the risk of COVID-19 infection throughout the community." Perhaps the TGA wants to ban vaccines if this is the rationale you put up for ivermectin?

It seems to me like the TGA has made the decision to coerce more people into what was supposed to be a voluntary vectination program. The constant dosing of doors to those who don't want to take the vaccine has gone too far. And this decision is yet another one of those doors closed.

From your response to Dr —, I can see you have a completely closed mind in regards to all the literature out there on ivermectin so it's no use going through any of the evidence with you or the TGA. But I would note that the TGA does not have a monopoly on medical opinion and that many esteemed doctors, professors in medicine and immunologists I have spoken to see the benefit in ivermectin.

I am going to rage against this decision until it is changed. I have already spoken with Minister Hunt and the Deputy Prime Minister and will use whatever leverage I can in parliament to bring about a change. The TGA should leave the prescription of medicines that are freely available in Australia up to GPs and not engage in such heavy handed behaviour.

And, on a personal note, if one of my relatives or loved ones contracts COVID-19 and cannot get an Inermectin treatment to them as a result of the TGA decision and they subsequently die then I will begin legal action against the TGA and all of its individual members involved in the decision. Many more people might do the same.

The TGA and it's members should be thinking very carefully about the consequences of their decisions on people's lives. Quite frankly, I no longer think they do that anymore and so any confidence I had in the TGA as a reputable regulator is now gone. I'm not the only one who thinks like that.


Secondly, completely understand our boosted post was a social issue hence why it was rejected initially, however, I am unsure how this ad was not picked up by the automation and rejected given the topic and the images used, yet our ad was rejected. There seems to be some inconsistency in the tool and completely aware of the millions of ads that get boosted/posted, however, I would have thought some key words of public figures would automatically trigger a review.

Can you please:

- provide some advice as to how this ad was approved please so we can pass this along to the Minister's
 Office.
- confirm the ad had been removed and the account has been deactivated for impersonating a government official/government account.

Unfortunately I do not have a permalink to this ad, only the screenshot, as it was sent to our Minister from a constituent.

Also, we noticed an increase in activity of spamming accounts pretending to be Australian Government Departments (and now our Minister). The two other departments involved are Services Australia and ATO (screenshots attached of the messages from our monitoring tool – I was unable to locate a permalink for two of the three examples). This activity seems to be increasing.

Our concern is the reputation of the Australian Government and our respective departments, especially as we don't want people to be scammed under the guise of our department/government. What options are available to protect our reputations? Is it possible for Meta to put a ban on certain account names to stop these accounts being used as false accounts or at least make sure they need to be reviewed when created to be deemed legitimate? As you can

see by the examples, the accounts are using government names and branding to in an attempt to give legitimacy to their account. Any guidance on this would be greatly appreciated.
