# Dansac Skin Lotion Wipes – DA#01MAY2023

### Variation on the Stoma Appliance Scheme

In 2018 the Stoma Product Assessment Panel (Panel) reviewed cleanser wipe products listed in subgroup 9(d) to correct anomalies in restrictions and inconsistencies of maximum monthly quantities.

The Panel recommended decreasing the maximum monthly quantity of cleanser wipe products to 60 units per month in subgroup 9(d) and to either include a R1 Restriction or change from a R2 to a R1 restriction to correct anomalies and standardise the restrictions of these products. A R1 Restriction requires authorisation from a Stomal Therapy Nurse, Nurse Practitioner, Registered Nurse or Registered Medical Professional.

#### Recommendation

The Panel considered the listing on the Stoma Appliance Scheme (SAS) Schedule of Dansac Skin Lotion Wipes (SAS Code 3568T) in subgroup 9(d) and recommended decreasing the maximum monthly quantity from 100 to 60 units per month and to include a R1 restriction for this product. The product, including one variant, is currently listed at a unit price of \$0.477.
