Proposed Listing on the Stoma Appliance Scheme

The applicant, Dansac, sought listing of the Dansac Tre Seal 27mm as an additional variant in an existing product range in subgroup 9(I) of the Stoma Appliance Scheme (SAS) Schedule. The one additional variant was proposed for listing at a unit price of \$4.531, with a pack size of 10 and a maximum monthly quantity of 30 units.

Comparator

The applicant nominated Dansac Tre Seal 18mm (SAS Code 80162C) as the comparator. The comparator product (one variant) is currently listed in subgroup 9(I) of the SAS Schedule at the unit price of \$4.531, with a pack size of 10 and a maximum monthly quantity of 30 units.

Background

This application was to add one variant to the existing product range of Dansac Tre Seal (SAS Code 80162C). The product was first listed on the SAS Schedule on 1 May 2018.

Clinical Place for the Product

The proposed product is an alternative for users requiring a hydrocolloid seal.

Clinical Analysis

The Panel noted that this application was to add one variant to an existing product range to include an additional seal size of 18mm.

Economic Analysis

The Panel noted that the listing of an additional variant of this existing product at the same price and the same maximum monthly quantity as currently listed products in the same subgroup will result in the same monthly cost on the SAS Schedule.

Financial Analysis

Listing of one additional variant of this product is unlikely to have a budgetary impact for the SAS as it will be listed at the same price and the same maximum monthly quantity as currently listed products in the same subgroup will result in the same monthly cost on the SAS Schedule.

Panel Recommendation

The Panel recommended that the Dansac Tre Seal 27mm be listed in subgroup 9(I) of the SAS Schedule as an additional variant of an existing product range, at a unit price of \$4.531, with a pack size of 10 and a maximum monthly quantity of 30 units. The product code for the new variant to be added under SAS Code 80162C is 072-57.

Context for Recommendation

The Panel provides advice on whether stoma products should be subsidised and, if so, the conditions of their subsidisation in Australia. Applications are considered in this context. The



Panel is an advisory committee and as such its recommendations are non-binding on Government. All Panel recommendations are subject to Government approval.

Applicant's Comment

Proposed Variation on the Stoma Appliance Scheme

The applicant, Dansac, sought a change to the product description of the current listing of the Dansac Tre Seal (SAS Code 80162C) in subgroup 9(I) of the Stoma Appliance Scheme (SAS) Schedule. The product, including one variant, is currently listed at a unit price of \$4.531, with a pack size of 10 and a maximum monthly quantity of 30 units.

Variants to be added

The applicant requested a change to the product description. The change was to include the seal size of 18mm.

Background

This product was first listed on the SAS Schedule on 1 May 2018.

Financial Analysis

The variation to the product description of this product will not impact the product price or maximum quantity. Therefore, this variation is unlikely to have a budgetary impact for the SAS.

Recommendation

As this was an administrative change, this application was considered by the Panel secretariat in line with the SAS *Application and Assessment Guidelines*. The Panel secretariat recommended the addition of one variation to the current product range (one variant) for Dansac TRE seal (SAS Code 80162C) listed in subgroup 9(I) of the SAS Schedule at the unit price of \$4.531, with a pack size of 10 and a maximum monthly quantity of 30 units. The Panel noted the secretariat's recommendation at the October 2023 meeting.

Context for Recommendation

The Panel secretariat, in accordance with the SAS *Application and Assessment Guidelines*, can process variations to products where there is no change to classification, pricing, maximum quantity or composition. All recommendations are subject to Government approval.
