As mentioned, the Department of Health and Aged Care have received some correspondence, referred from PM&C, relating to the implementation status of recommendations from the *House of Representatives Standing Committee* on *Health, Aged Care and Sport inquiry into biotoxin-related illnesses in Australia*.

The Health Portfolio is responsible for monitoring the implementation of all the recommendations.

We are seeking an update in relation to the implementation status of **Recommendation 2** of the Inquiry which relates to Standards and/or accreditation requirements for mould testing and remediation industries. This recommendation was referred to State and Territory Building Ministers and the Australian Industry and Skills Committee (AISC). The recommendation in full reads:

The Committee recommends that the Australian Government work with the states and territories to conduct further research into, and develop standards and/or accreditation requirements for the mould testing and remediation industries, which should include consideration of:

- the most effective methods of testing and remediation of buildings affected by mould and/or moisture;
- appropriate accreditation requirements for professionals working in these fields; and options for greater regulatory oversight of these industries

This includes developing a biotoxins (indoor damp and mould) clinical pathway to assist general practitioners and other health professionals with the diagnosis, treatment and management of patients with biotoxin-related illnesses.

The clinical pathway has been developed in consultation with medical practitioners, medical professional organisations and patient and consumer groups and is expected to be published on the department's website in coming months.

In addition, a fact sheet on the health effects of mould has been developed by the Environmental Health Standing Committee, a standing committee of the Australian Health Protection Principal Committee. The fact sheet consolidates current jurisdictional advice on the health effects of mould and is available at www.health.gov.au/resources/publications/enhealth-guidance-potential-health-effects-of-mould-in-the-environment?language=en.

Thank you for your replay, no worries I am happy to wait for input.

Could you please forward the attached mycotoxin clinical report to the Minister for Health and Hon Anthony Albanese MP. The attached clinical mycotoxin report has been de-identified for our privacy, however it is relevant and I would like the Health Minister and Prime Minister to be aware of the results that we hold on our mould exposure.

The WHO fungal priority pathogens list to guide research, development and public health action is attached. In this report Annex 1 page 14, it details the overall pathogens ranking across the MCDA stages. Of the critical priority group, Aspergillus fumigatus is listed.

Aspergillus fumigatus is a species of fungus in the genus Aspergillus and this is documented in our building mycology reports showing Aspergillus/ Penicillium in extremely contaminated surface levels in locations throughout the home. Gliotoxin causative organism are – Aspergillus versicolor, **Aspergillus fumigatus.** The effects inhibit macrophage phagocytosis, induces macrophage apoptosis blocks T and B cell Activation, Immunosuppression, invivo displays anti-inflammatory activity.

I located on the DOH website, the Enhealth-guidance-potential-health-effects-of-mould-in-the-environment (see attached). Please refer to section "Should I test for mould in my home" on page 3. This is of great concern to me and does not address the risks of mould being a biohazard and testing options for water damaged buildings.

The Australian Government needs to fund laboratories, to have the capability of testing for mould exposure of humans in water damaged buildings within Australia for disease prevention.

In addition if the IICRC guidelines were to be adopted by Government or its States and Territories, there needs to be further evidence based research into actual remediation of buildings and the removal of mould and its root structures in building elements within Australia.

I would greatly appreciate any assistance, as mould remediation of a water damaged / mould impacted building is just awful to navigate.

We have received some correspondence, referred from PM&C, relating to the implementation status of recommendations from the *House of Representatives Standing Committee on Health, Aged Care and Sport inquiry into biotoxin-related illnesses in Australia*.

On 4 March 2020, the Australian Government tabled its response (the <u>Response</u>) to the Standing Committee's report and its seven recommendations. The Health Portfolio is responsible for monitoring the implementation of all the recommendations.

We are seeking an update in relation to the implementation status of **Recommendation 2** of the Inquiry which relates to Standards and/or accreditation requirements for mould testing and remediation industries. This recommendation was referred to State and Territory Building Ministers and the Australian Industry and Skills Committee (AISC). The recommendation in full reads:

The Committee recommends that the Australian Government work with the states and territories to conduct further research into, and develop standards and/or accreditation requirements for the mould testing and remediation industries, which should include consideration of:

- the most effective methods of testing and remediation of buildings affected by mould and/or moisture;
- appropriate accreditation requirements for professionals working in these fields; and options for greater regulatory oversight of these industries

If possible, I would greatly appreciate any updates you may have in relation to the second dot point above and your review of our draft wording below. We have also contacted Department of Industry Building policy team and Australian Building Codes Board to help inform our reply correspondence.

Hi \$22 thanks for getting in touch.

Yes, I recall discussing this Inquiry and the two recommendations with \$22 last year. However, please note that we cannot comment on progress regarding **recommendation 2** - standards and/or accreditation requirements for mould testing and remediation industries:

- DISR considers that the adoption of a new professional standard for the remediation of mould problems is outside the remit of the National Construction Code, and does not fit well with the Australian Building Codes Board (ABCB) or Building Ministers. This is already reflected in the draft response, but I wanted to confirm that any related content needs to be cleared with another team.
- In our view, the proposed professional standards that are required fit better with the Education/Employment portfolio, as they relate to the vocational education and training (VET) system, rather than Building Ministers. I gave \$22 a contact to follow-up with last year, although we haven't spoken to that team since early 2022.

That said, please see our input as follows. I gather ABCB has contacted you separately, and may have provided similar detail:

- The Australian Building Codes Board (ABCB) is responsible for updating and maintaining the National Construction Code (NCC), which provides minimum requirements for the <u>design and construction of</u> <u>buildings</u>. However, the ABCB does not regulate matters of remediation or professional accreditation.
- To assist industry to decrease the risks related to mould, the ABCB has published a *Condensation in Buildings Handbook* (updated most recently in June 2023). This handbook provides guidelines to assist architects, designers and builders in the assessment and the management of the risk of condensation and its consequences. The handbook can be found on the ABCB's website at www.abcb.gov.au.
- The ABCB has consulted with stakeholders on further amendments to the NCC to decrease the risk associated
 with mould and moisture caused by weatherproofing failures and condensation. These measures were included
 in the 2022 edition of the NCC, which took effect from 1 May 2023. Further measures will be considered for
 inclusion in NCC 2025. These measures are intended to decrease the risk of moisture and mould in buildings, but
 will not eliminate risks.
 - Please note that adoption of the NCC into relevant building regulations (and any transitional arrangements for those provisions) is a matter for individual states and territories. Details on the adoption of NCC 2022 can be found on the ABCB website www.abcb.gov.au/ncc-2022-state-and-territory-adoption-dates.*

The Department of Health and Aged Care is developing a Biotoxins (indoor damp and mould) Clinical Pathway to assist general practitioners and other health professionals with the diagnosis, treatment and management of patients with biotoxin-related illnesses. The clinical pathway has been developed based on high quality published medical and scientific literature and in consultation with medical and consumer representatives. The clinical pathway is expected to be published on the department's website in coming months.
