I apologise for my delayed reply to this. Too many 'opportunities', too little time!

In regard to the expiry of the agreement you will note that the 'duration' section of the <u>Community Health and Hospitals Program for Victoria</u> agreement specifies that the schedule '...is expected to expire on 30 June 2025 or on completion of the projects...'. Consequently it doesn't actually expire until all deliverable are complete.

Regarding your request for the Commonwealth (\$22 to confirm their support with amending the milestones via a return email, I cannot provide definitive confirmation as the ultimate decision as to whether to agree a variation is one for the Minister. However that said the department's advice would nevertheless be to consider any variation proposed by Victoria within the existing funding envelope that would support or assure delivery of the relevant project. That would be our advice here, particularly where the election commitments (when integrated with the deliverable agreed with the Commonwealth) ultimately result in a better outcome for the health system overall.

Thank you for your letter requesting the Department of Health's endorsement to defer the milestones for two capital projects funded primarily under the Commonwealth Community Health and Hospitals Program (CHHP), and support with developing an entity service plan for ambulatory and community-based services at the Wodonga campus of Albury Wodonga Health (AWH). I apologise for the delay in responding.

My recent visit and Board meeting on 30 August 2023 provided valuable insight into the challenges faced by AWH in delivering these.

I note that the two projects to be delivered by AWH, the Wodonga sub-acute mental health facility and community outpatient specialist hub (COSH), are still in the planning phase.

My department has consulted with our Commonwealth counterpart who is supportive of the proposed approach in principle, noting final acceptance of the proposal is with the Minister.

Considering the announcement by the Victorian and NSW governments to invest \$558 million to redevelop the Albury campus, the Victorian Government supports your request to defer the CHHP project milestones to 2024-25. This will ensure service integration with the broad hospital redevelopment and the most effective use of the funds.

I also acknowledge the challenges and impacts faced by AWH from COVID-19 in delivering the projects since the Commonwealth's announced funding in December 2020

I understand work is progressing on the Wodonga campus entity service plan, due for completion in early 2024, that will consider the service profile for a community health facility that is consistent with identified community needs and identify integrated delivery pathways that complement the bed-based care provided at the Albury campus.

I note that this service plan will depend on the final scope of the redevelopment of the Albury campus to ensure that there is no duplication of services across sites. Further, any future development at the Wodonga site will be subject to government authorisation in line with usual State Budget processes.

Additionally, I note 2025 is the earliest expected commencement date for the Albury campus redevelopment and acute services will remain on the Wodonga campus until the new clinical services building is completed in 2028.

My department has been working with your department on delivery of our CHHP projects and have provided project updates below.

# Projects affected by Victorian election commitments

# 1. Albury Wodonga Health

Albury Wodonga Health is a unique cross-border health care service spanning the border of Victoria and New South Wales. Both the Victorian and NSW governments are working together to build new health infrastructure, including a new emergency department and short-stay unit that is currently in construction. In October 2022, both governments committed \$558 [million for the development of a new clinical services tower at Albury. Following this commitment, we are working closely with New South Wales (as lead for the project) and Albury Wodonga Health on the necessary planning and development process to enable design and construction commence.

This commitment has an interrelationship with the mental health rehabilitation unit at the Wodonga Campus. My department is currently working with Albury Wodonga Health to better understand the impacts and will provide further updates to your department once these are better known and there is a greater understanding of the program of works.





# **Key Matters:**

The Government is making a significant investment in the Albury-Wodonga region to support the public health and hospital services for the local community. The Australian Government is also committed to supporting a sustainable high-quality aged care sector, including in regional communities.

The National Health Reform Agreement (NHRA) recognises that state and territory governments are the system managers of their public hospital systems, responsible for planning and funding capital and for the day-to-day operations of their public hospitals. Decisions concerning infrastructure, staffing, service provision and patient transport in the Albury-Wodonga region rests with the Victorian and New South Wales (NSW) Governments.

Any Australian Government contribution to the proposed redevelopment Victorian State Government's Bright Hospital precinct, operated by Alpine Health, would need to be considered in the context of the availability of future capital grant funding opportunities, which will include additional support being made available for aged care for regional and remote Australia.



# **Key Points:**

Albury-Wodonga Hospital

 Albury-Wodonga Health Local Hospital Network, which administers the Albury-Wodonga Hospital, received \$33.8 million in Australian Government Activity Based Funding for public hospital services in 2020–21. This is an increase of \$12.1 million, or 56 per cent, since 2012–2013 (\$21.7 million).

- In 2019-20, The Australian Government made a block funded contribution of \$11.2 million to the Albury-Wodonga Health LHN for services such as those provided by small rural hospitals.
- An estimated \$329 million of health spending in 2019-20 is attributable to Commonwealth health programs in Albury-Wodonga and the surrounding areas.

- Albury-Wodonga Health (AWH) is Australia's only cross-border public health service and
  operates under an agreement between the NSW and Victorian Government. AWH
  provides health services to more than 250,000 people. The Government's public
  hospital funding for AWH is provided through two Local Hospital Networks: AlburyWodonga Health (in respect of Victoria) and Albury NSW Local Health District (in
  respect of NSW).
- AWH is a 337 bed health service that treated over 61,000 emergency presentations, more than 40,000 inpatients, and delivered 1650 babies in the last 12 months.
   Services are provided from 17 sites. There are 30 sub-acute beds, 95 mental health beds, five intensive care beds, seven operating theatres, and 117 general beds.
   The Victorian Minister for Health and Aged Care has confirmed AWH as one of nine Victorian COVID-19 hospital vaccination hubs.
- The Australian Government also provides funding and support for the AWH and for specific health services in the Albury-Wodonga region more generally through several programs, including public hospitals, Medicare benefits, community health infrastructure, Primary Health Networks, and health workforce assistance.

# Community Health & Hospitals Program

- Through the \$1.25 billion Community Health and Hospitals Program and other 2019–20
  Budget measures, the Australian Government is investing in projects and services in
  every state and territory that support patient care while reducing pressure on
  community and hospital services. Of this funding, Victoria is receiving close to
  \$420 million and NSW over \$409 million towards priority projects identified for those
  states.

# Response:

The Australian Government is committed to improving access to hospital and community health services to ensure that members of the Australian community have access to health care in all jurisdictions, when and where they need it.

- Through the National Health Reform Agreement (NHRA), the Government provides a significant funding contribution to assist states and territories with the costs of delivering public hospital services.
- The Government's funding contribution for public hospitals in all states and territories under the NHRA has grown from \$13.3 billion in 2012–13 to \$22.6 billion in 2019–20, or by 70 per cent. This funding is projected to continue to grow under the 2020-25 NHRA to \$133.6 billion between 2020-21 and 2024-25.
- Albury Wodonga Health is Australia's only cross-border public health service and operates under an agreement between the New South Wales and Victorian Governments. 



## **Key Matters:**

The Government is making a significant investment in the Albury-Wodonga region to support state government public health and hospitals system services for the local community.

The Department of Infrastructure, Transport, Regional Development and Communications, which administers the Albury-Wodonga Regional Deal, has advised that early feasibility studies on a number of potential opportunities, including in health, are being considered through the Australian Government's initial \$3.2 million investment, with a final Deal expected to be announced in mid-2021.

- Responsibility for planning and funding health infrastructure in the Albury-Wodonga region, for example making decisions on the potential for a Public Private Partnership, rests with the Victorian and NSW Governments.
- I have written to Minister Marino advising that health elements of the Albury-Wodonga Regional Deal should leverage and complement a number of existing Australian Government investments and initiatives in the region.

## **Sensitivities or Contentious Issues:**

- In early 2021, Minister Ley also met with the Assistant Minister for Regional Development and Territories, the Hon Marino MP, to discuss the Deal and opportunities for investment in the healthcare sector in Victoria.
- The Department understands that the Department of Infrastructure, Transport, Regional Development and Communications is now focussing on targeted areas of possible assistance rather than supporting a large scale infrastructure redevelopment of the AWH.

## **Background:**

Albury-Wodonga Regional Deal

- On 9 July 2020, following negotiations with the NSW Government, Victorian Government, Albury City and City of Wodonga, the Albury Wodonga Regional Deal Statement was signed, to support economic development and improved liveability over the next decade.
- Education and Health is a key priority, with the Statement seeking opportunities to improve and deliver quality, integrated health facilities and services that attract high quality health and education professionals.
- Through the Regional Deal, the Australian Government could seek to negotiate with the states for them to also lead a major initiative to develop a 'Health Hub', including potentially a new consolidated Albury-Wodonga Hospital, as part of the long-term investment in the deal by the NSW and Victorian Governments.

## National Health Reform Agreement (NHRA) & Albury-Wodonga Health (AWH)

- The NHRA recognises that state and territory governments are the system managers of their public hospital systems, responsible for the day-to-day operations and performance of their public hospitals and for planning and funding capital.
- AWH is Australia's only cross-border public health service and operates under an
  agreement between the NSW and Victorian Governments. AWH provides health services to
  more than 250,000 people. The Government's public hospital funding for AWH is provided
  through two Local Hospital Networks: Albury Wodonga Health (in respect of Victoria) and
  Albury NSW Local Health District (in respect of NSW).
- AWH is a 337 bed health service that treated over 61,000 emergency presentations, more than 40,000 inpatients, and delivered 1650 babies in the last 12 months. Services are provided from 17 sites. There are 30 sub-acute beds, 95 mental health beds, five intensive care beds, seven operating theatres, and 117 general beds. The Victorian Minister for Health and Aged Care has confirmed AWH as one of nine Victorian COVID-19 hospital vaccination hubs.

## Community Health & Hospitals Program

- The Albury Wodonga Mental Health Rehabilitation Unit project will support the transition from inpatient care to the community, and provide an alternative to acute inpatient and emergency department admission, as well as significantly improving the transition of mental healthcare between acute and community services.
- Funding for this project was due to commence in 2022-23, however, the Australian Government is bringing forward funding over three years from 2020-21 in response to the significant impacts of the bushfire emergency in the Albury Wodonga region in early 2020.
- The National Partnership for Streamlined Agreements between the Commonwealth and the state of Victoria for the CHHP and other initiatives, which includes funding for the Wodonga Hospital, was executed on 31 January 2021.

I refer to your letter of 3 September 2020 concerning a Regional Deal in Albury Wodonga, to ensure the region prospers with minimal cross-border complications.

I note in the Deal's Statement of Intent the key priority area of Quality Regional Education and Health and welcome the invitation to identify project opportunities. The focus of this key priority area is to explore opportunities to improve and deliver quality, integrated health facilities and services that attract high quality health and education professionals to the region to meet the demands and challenges of a growing and ageing population. This focus should leverage and complement the following existing Australian Government investments and initiatives in the region from my portfolio:

- The Government is providing \$14.5 million to the Albury Wodonga Health, Wodonga Hospital Campus over three years from 2020–21:
  - \$12 million to support the development of a new 20 bed Mental Health Rehabilitation Unit
  - \$2.5 million to support specialist clinics at the Wodonga Hospital site.
- The Government provides ongoing training programs aimed at increasing accessibility of health services in rural and remote areas:
  - The Rural Health Multidisciplinary Training program is designed to encourage the recruitment and retention of rural and remote health professionals, including through providing effective rural training experiences for health students medical, nursing and allied health students
  - The Murray-Darling Medical Schools Network is providing funding of \$74.4 million from 2018–19 to 2021–22 to establish five rurally based medical school programs in the Murray-Darling region of New South Wales and Victoria
  - The Australian General Practice Training program provides vocational training for medical graduates wishing to specialise in general practice
  - The Specialist Training Program (STP) provides Commonwealth supported training placements for non-GP specialist registrars, with vocational training for participants in regional, rural, and remote locations.

- In 2019, the Government funded 4.35 Full Time Equivalent (FTE) places under the STP in Albury Wodonga as follows:
  - 2.35 FTE in Anaesthesia, Community Child Health, Dermatology and Emergency Medicine positions in Albury
  - o 2 FTE in Medical Administration and Obstetrics and gynaecology in Wodonga.

As you may be aware, the Government supports Primary Health Networks (PHN) to work to reorient and reform the primary health care system by taking a patient-centred approach to medical services in their regions. One of PHNs' key roles is to work collaboratively to integrate health services at the local level to create a better experience for patients, encourage better use of health resources, and eliminate service duplication.

I understand Murray PHN, which covers the Albury Wodonga region, has been consulted and engaged on the sidelines throughout this process, by various members of the deal's Health and Social Services Reference Group. The Murray PHN has implemented a number of projects and activities to address cross-border access issues and barriers and variations to healthcare. For example:

- a preventable hospitalisation project across Albury Wodonga
- an established and commissioned chronic disease model of care focussed on diabetes, chronic obstructive pulmonary disease and cardiovascular disease
- commissioned a stepped model of mental health care across the region.





Albury Wodonga Health and the need for a new hospital in the North East Victorian Region

- The Government's public hospital funding for Albury Wodonga Health (AWH) is provided through two Local Hospital Networks: Albury Wodonga Health (in respect of Victoria) and Albury NSW Local Health District (in respect of NSW). The two AWH LHNs received a combined \$124 million in Australian Government funding contribution towards the costs of public hospital services in 2021-22.
- The AWH Clinical Services Plan, released on 21 April 2021, recommends a major referral
  hospital be constructed in the region over the next twenty years to deliver
  contemporary regional healthcare, reduce service duplication, and to co-locate scarce
  specialist resources. A site for this hospital has not been proposed and any decisions
  on the need for a major referral hospital remains with the respective jurisdictions.

- The department understands that, following a review by the Victorian and NSW Governments, AWH is undertaking further work on its long-term draft Master Plan to determine the infrastructure required to meet its Clinical Services Plan on the future needs of the cross-border community.
- The department has not been involved in the development of these plans.



## Overview

- Albury Wodonga Health (AWH) is Australia's only cross-border public health service and operates under an agreement between the New South Wales (NSW) and Victorian Governments.
- The Australian Government provides funding and support for the AWH and for specific health services in the Albury Wodonga region more generally through several programs, including public hospitals, Medicare benefits, community health infrastructure, Primary Health Networks, and health workforce assistance.
- An estimated \$329 million of health spending in 2019–20 is attributable to Commonwealth health programs in Albury Wodonga and the surrounding areas.
- The Government announced a pilot Regional Deal for Albury Wodonga on 20 March 2019, overseen by the Department of Infrastructure, Transport, Regional Development and Communications (DITRDC). The DITRDC, working with the Department of Health, is developing a proposal under this Regional Deal to establish a framework for better coordinated health services in the region that will involve Commonwealth, state government, local government, and private healthcare providers.
- The Department is not aware of any current issues with cross border funding between the NSW and Victorian Governments in relation to AWH.

## **Public Hospitals and the National Health Reform Agreement**

• The Government's public hospital funding for AWH is provided through two Local Hospital Networks: Albury Wodonga Health (in respect of Victoria) and Albury NSW Local Health District (in respect of NSW). AWH operates under the jurisdiction of the Victorian Department of Health and Human Services (DHHS).

- Albury Wodonga Health and Albury NSW Local Health District received a combined \$77.9 million in Australian Government Activity Based Funding for public hospital services in 2020–21. This is an increase of \$56.2 million since 2012–13 (\$21.7 million).
- Albury Wodonga Health received a combined \$103.0 million in Victorian and New South Wales Government Activity Based Funding through the National Health Funding Pool for public hospital services in 2020–21. This is an increase of \$78.8 million since 2012–13 (\$24.2 million).



## **Community Health and Hospitals Program**

- Through the \$1.25 billion Community Health and Hospitals Program (CHHP) and other 2019–20 Budget measures, the Government is investing in projects and services in every state and territory that support patient care while reducing pressure on community health and hospital services.
- As part of CHHP, the Victorian Government will receive \$14.5 million for the Albury Wodonga Health Wodonga Hospital Campus to develop a Mental Health Rehabilitation Unit and deliver an expanded range of consulting clinical suites at Wodonga Hospital.
- CHHP also includes funding for the Wodonga Hospital, with an agreement executed on 31 January 2021 and payment of \$2.5 million made in May 2021. The payment schedule for the remaining \$12 million for Wodonga Hospital will be made following receipt of their progress reports, with expected payment dates of 1 September 2021 (\$6 million) and 1 September 2022 (\$6 million).
