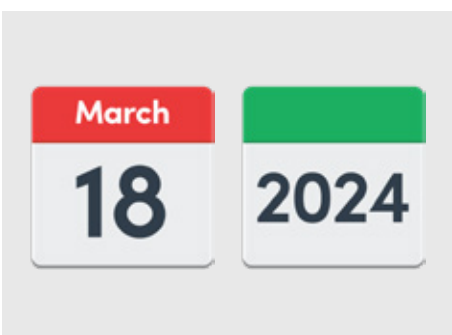


These are the **minutes** from the Roadmap Implementation Governance Group meeting.

We say **RIGG** for short.

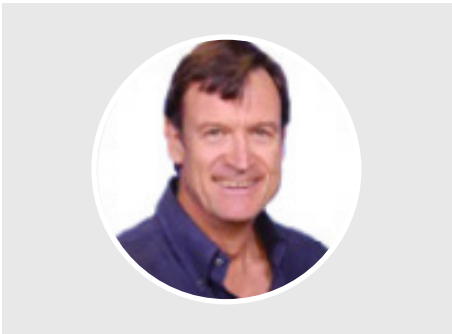


Minutes are notes that say what we talked about in the meeting.



The meeting was on 18 March 2024.

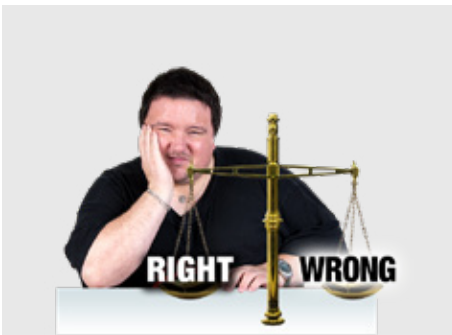
What we talked about at the meeting

Health workers need to know how to care for people with intellectual disability.

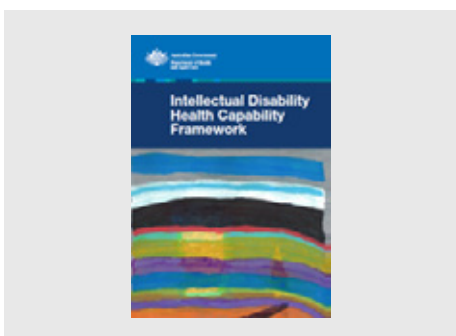
Curriculum development project

- We need to help universities understand why it would it would be good for them to use the Framework.

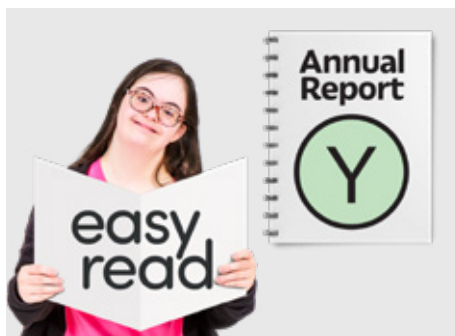
Roadmap annual progress report



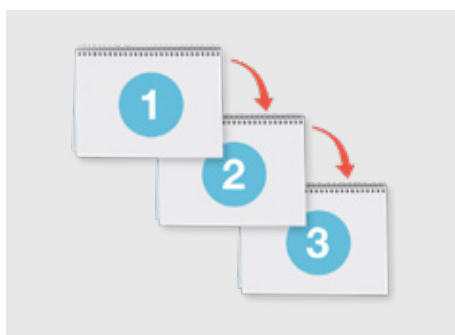
We heard about the 2023 **Roadmap annual progress report**.

RIGG members will be in the small group.

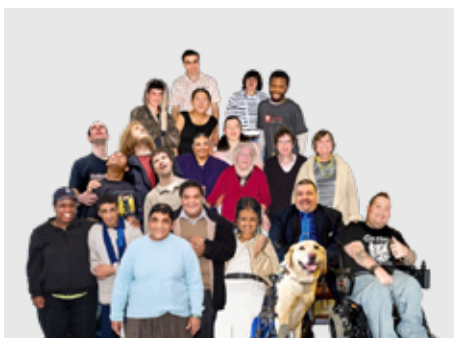
Other business
