Dear Senator Colbeck,

I am writing to you as Minister for Youth and Sport seeking your assistance in an ongoing dispute I have with the AFL.

The AFL are currently using the Final 8 System that I devised and sent to them in 1994. At that time the AFL told me my system was flawed and they would not be interested in using it.

I spent the next five years attempting to get the AFL to change their minds on this matter. Along the way I received written support from many AFL Clubs and had media reports published detailing my system and calling for its introduction.

In 2000 the AFL were forced to change to my system. Inexplicably when they did this they claimed my system as their own idea, refusing to acknowledge the considerable time and effort I had put in to provide them with a Final 8 System that was fair, easily understood and has proven to be popular with supporters.

If you look at the AFL's stated values you will find they dictate that the AFL should acknowledge the efforts of others and treat people with honesty, integrity and transparency.

I have been afforded none of these values in my efforts to have the AFL tell the truth about the origin of the current Final 8 System. This is not good enough from a National Sporting League that should set the highest standards for others to follow.

Last year the AFL Integrity Department started investigating my complaint. When they saw the documentation I have supporting my claims they suspended the investigation telling me "it could be taken no further".


I then forwarded the same documentation to the AFL's Official Historian Col Hutchinson. \$47F

Every other Final 8 System that has been used throughout the history of the AFL has been named after its author, the person who invented it. Why won't the AFL do the same with my system which they have now used for twenty years, second only to the McIntyre-Page Final 4 in terms of longevity?

This matter has previously been raised in Parliament by Brian Mitchell MP who called on the AFL to do the right thing and acknowledge my system. Brian also wrote to the AFL Chief Executive officer Gill McLachlan asking him to address this issue. Two and a half years later and the AFL still has not had the decency to respond to this letter!

As Minister for Sport can you raise this issue with the AFL, ensuring that they uphold their own values and truthful acknowledge the origin of the current Final 8 System?
