Introduction

About 60-day prescriptions

There are now almost 300 Pharmaceutical Benefits Scheme (PBS) medicines available for 60-day prescriptions. This will give many Australians twice the amount of their medication on a single prescription.

To qualify, patients must:

- live with a stable, ongoing health condition
- have discussed their medication with their prescriber and be assessed as suitable
- have received a new 60-day prescription.

Patients buying PBS medicines will save more than \$1.6 billion over the next 4 years from 60-day prescriptions.

Patients taking only 60-day prescription medicines may halve their doctor and pharmacy trips to renew and fill their scripts, freeing up millions of GP visits.

The changes follow advice from the independent Pharmaceutical Benefits Advisory Committee (PBAC). The PBAC recommended it was clinically safe and suitable to allow 60-day prescriptions for eligible patients.

Medicines available for 60-day prescriptions

The list of medicines available for 60-day prescriptions supports patients who are living with stable ongoing health conditions including:

- acne
- androgen deficiency
- anxiety disorders
- arthritis
- breast cancer
- bipolar disorder
- chronic obstructive pulmonary disease (COPD)
- constipation
- Crohn's disease
- depression
- diabetes
- epilepsy
- gastro-oesophageal reflux disease (GORD)
- · glaucoma and dry eyes
- gout
- heart disease
- high cholesterol
- hypothyroidism
- incontinence
- menopause
- migraine
- osteoporosis
- Parkinson disease
- prostate cancer
- prostate enlargement
- ulcerative colitis.

How to check if a medicine is included

Frequently asked questions

Will a patient need a new prescription to obtain a 60-day supply of their current medication?

Yes, to qualify, patients must:

- live with a stable, ongoing health condition
- have discussed their medication with their prescriber and be assessed as suitable
- have received a new 60-day prescription.

Patients with a stable, ongoing health condition should talk to their prescriber to find out if they are eligible for a 60-day prescription. Prescribers will use their best professional judgement to prescribe medicines for either 30 or 60-days.

How are patients saving with 60-day prescriptions?

Patients will receive twice the medication on a single prescription for almost 300 medicines. When a PBS medicine can be prescribed for 60-days patients may save:

- up to \$189.60 a year, per medicine for Medicare card holders (non-concessional)
- up to \$46.20 a year, per medicine for concession card holders.

A patient taking only medicines that have a 60-day prescription may halve their number of trips to the pharmacy to fill a script for those medicines. This may also free up appointments with prescribers to focus on other aspects of patient care.

How does this work with the PBS Safety Net?

The PBS Safety Net helps you pay less for medicines after you've reached a certain amount in a calendar year. This qualifying amount is called the Safety Net threshold.

The threshold is lower for concession card holders. Both the general and concessional thresholds will increase each year in line with the consumer price index.

You and/or your family only need to reach the threshold once in a calendar year. If you qualify for the Safety Net you pay a lower amount for PBS medicines, and concession card holders receive PBS medicines for free, for the rest of that year (plus any applicable premiums). With 60-day prescriptions, some patients won't reach the PBS Safety Net due to the savings on their medicines throughout the year. Others will reach the Safety Net later in the year, having spread their medicine costs over a longer period.

The benefit for patients is that their total annual medicines cost will be spread out over a greater period of time, resulting in a lower monthly medicines cost. If patients don't reach, or hit the threshold later in the year, it means they have saved money throughout the year.

Do patients require a concession card to be eligible for a 60-day prescription?

No, patients do not need a concession card to access a 60-day prescription. Doctors retain full clinical discretion over what quantity of medicine is prescribed for their patients based on their assessment of their patient's condition at the time.

Will 60-day prescriptions negatively impact the supply of medicine?

Moving to 60-day prescriptions has not affected the supply of medicine. Consumers still purchase the same amount of medicine each year. While eligible people can now get twice the medication on a single prescription, this will last them for a longer period of time. This means overall demand for medicines will stay the same.

Most medicines recommended by PBAC for 60-day prescriptions are not in short supply in Australia. If shortages do occur, alternative brands and/or strengths of the same medicine are usually available. The Department of Health and Aged Care monitored the list of recommended medicines for inclusion in each stage to reduce the risk of shortage.

More medicines can continue to become available for 60-day prescriptions after they have been deemed suitable and recommended by the Pharmaceutical Benefits Advisory Committee (PBAC), as part of routine monthly changes to the PBS.

Pharmaceutical companies must tell the Therapeutic Goods Administration (TGA) of expected <u>medicine shortages</u>. The <u>Medicines Supply Security Guarantee</u> changes commenced on 1July 2023. Medicine manufacturers must have more stock onshore for some brands of PBS medicine, helping ensure any temporary rise in demand for those brands is met.

Wholesalers must deliver to any pharmacy in 24 hours (excluding weekends or public holidays) if they are running low on medicine. This applies for most medicines.

60-day prescriptions are available for many Australians

There are now almost 300 Pharmaceutical Benefits Scheme (PBS) medicines available for 60-day prescriptions. This will give many Australians twice the amount of their medication on a single prescription.

Patients with a 60-day prescription for a PBS medicine may save:

- up to \$189.60 a year, per medicine for Medicare card holders (non-concessional)
- up to \$46.20 a year, per medicine for concession card holders.

This also means many patients with stable, ongoing health conditions may halve their trips to their doctor or pharmacy to renew and fill their prescriptions.

Patients buying PBS medicines will save more than \$1.6 billion over the next 4 years due to 60-day prescriptions.

To qualify, patients must:

- live with a stable ongoing health condition
- have discussed their medication with their prescriber and be assessed as suitable
- have received a new 60-day prescription.

Patients living with stable ongoing health conditions should chat to their doctor or healthcare professional to see if they are eligible for a 60-day prescription. Doctors will use their best professional judgement to prescribe medicines for either 30 or 60 days.
