27 November 2024

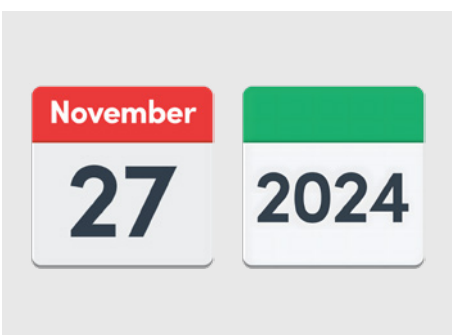


These are the **minutes** from the Roadmap Implementation Governance Group meeting.

A **conflict of interest** means something in your life stops you from making fair decisions for the group.



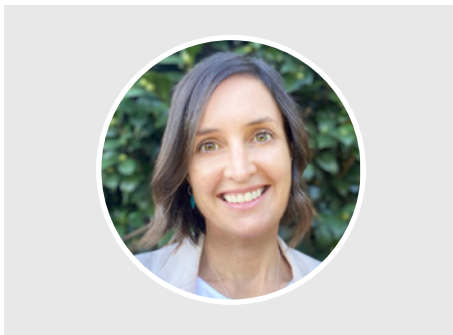
Everyone was happy with the minutes from the last meeting.

The PHNs worked with doctors to make information.



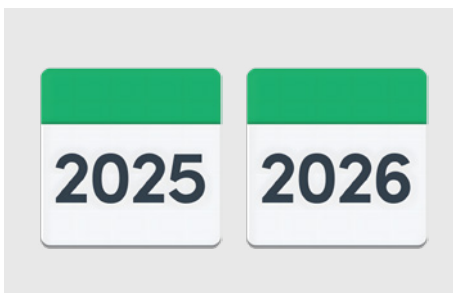
The information is about how to give good health care to people with intellectual disability.



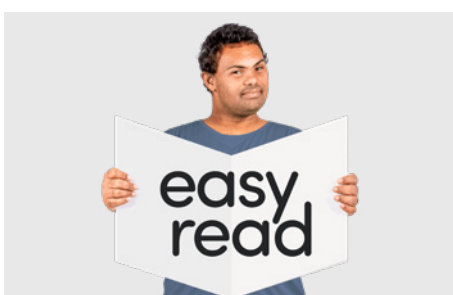
We did an **evaluation** of the PCEP in September 2024.

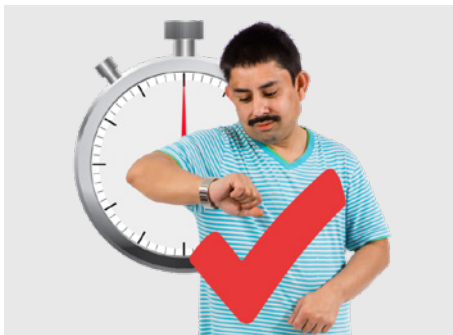


We will do another evaluation after 2 years about how PCEP went.

Short term actions are things in the Roadmap we want to do fast.

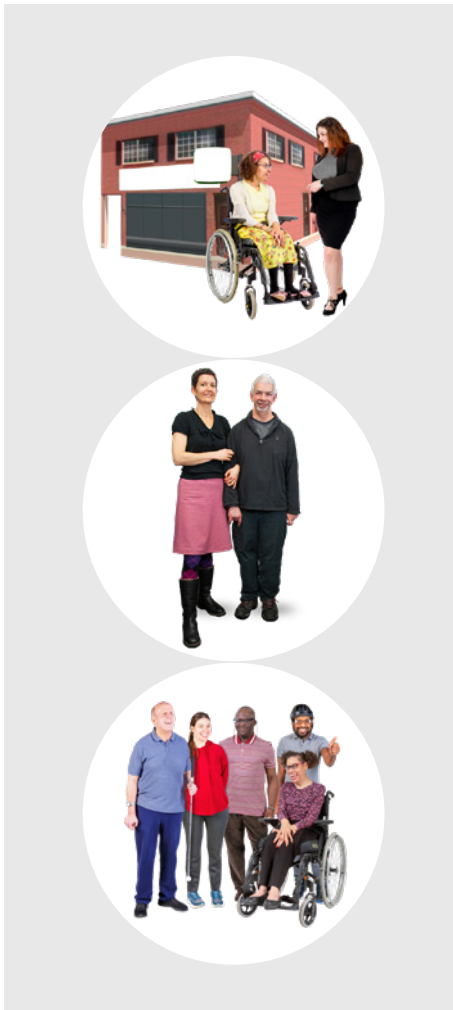


The **Department of Health and Aged Care** is looking at information on intellectual disability health care.

- People with disability.

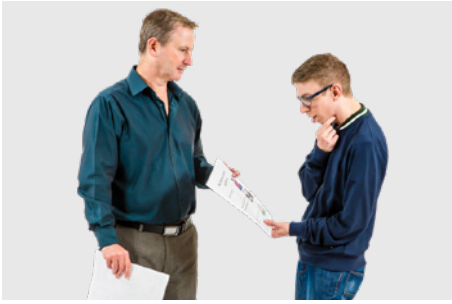


The Department will work with the **National Centre of Excellence in Intellectual Disability Health.**

We will say the **Centre** for short.



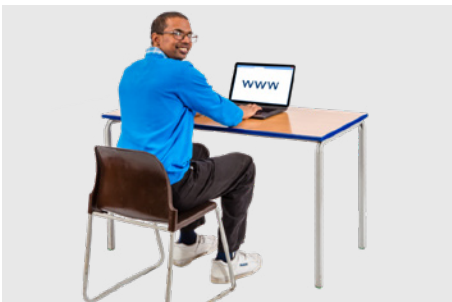
They will work together to find and share the information.

We heard about the **Child Dental Benefits Schedule**.

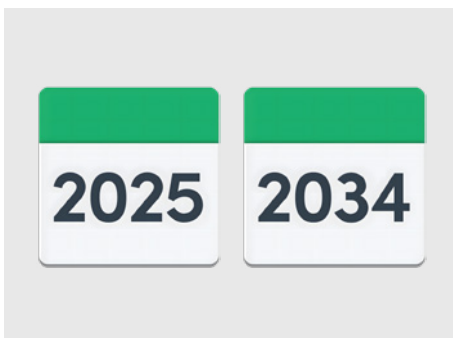
This is called **CDBS** for short.



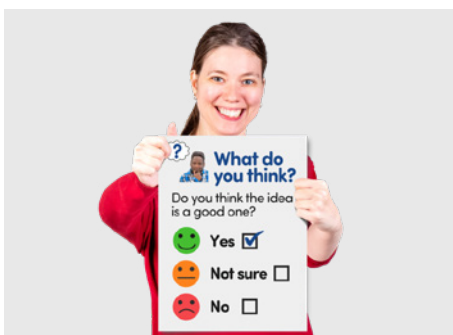
The CDBS helps people pay for some of their child's oral care.

The Department will let us know how RIGG members can do that.

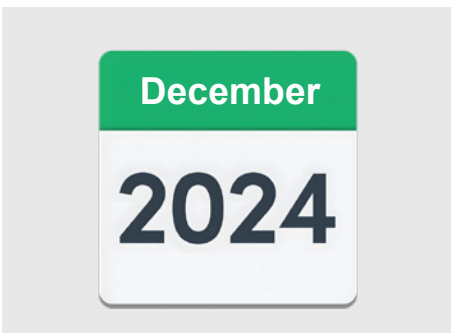


Jodi Cassar from the Department of Social Services talked about the **National Disability Data Asset**.

The NDDA can share information with researchers in December 2024.

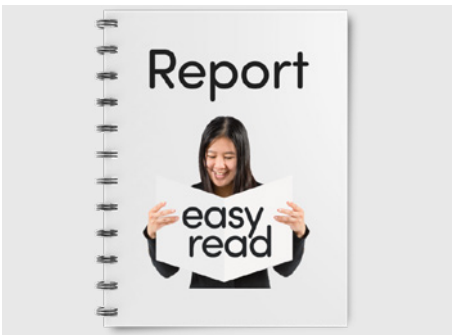


This will help people with disability get better supports and services.

An annual report says all the things what we did the past year.

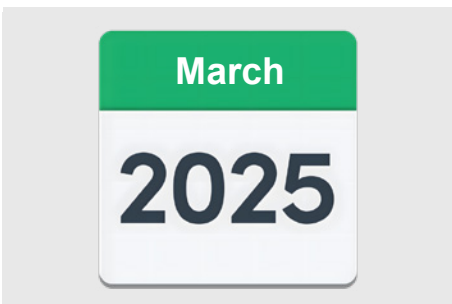


We will ask RIGG members to tell us what they are doing for the Roadmap.
