Re: Health triage and settlement coordination for recently arrived Palestinians

We are writing to express our deep concern about the lack of an appropriate health triage and coordination response to address the complex health needs of recently arrived individuals and families fleeing the humanitarian crisis in Gaza. We call on the government to fund and establish interim health coordination roles and/or initiatives until a permanent visa pathway for this group is finalized.

DOCUMENT 1.1

The Victorian Refugee Health Network (the Network) enhances health service access and responsiveness for refugees and asylum seekers through coordination, collaboration, and policy advocacy. In recent years, the Network has taken a lead coordination role in Victoria to ensure that people arriving directly from conflict affected regions such as Kabul, Afghanistan (2021) and Ukraine (2022) are well supported by the Commonwealth and State health systems and services.

Consistent with this remit to address the needs of people fleeing humanitarian crises, over the past eight months the Network has convened a series of meetings with the refugee and asylum seeker health sector to coordinate a response. These forums have helped the sector to understand specific cultural contexts, presenting complex health needs, situational demands and mobilization of health and community organizations. A key priority need presented has been health triage and coordination support for recently arrived Palestinians.

Since October 2023, over 1,300 Palestinians have arrived in Australia on Visitor visas (subclass 600), with approximately 36% of this cohort arriving in Victoria¹. Individuals and families arriving in Victoria have presented with a range of complex health needs, and the health triage needs have been time critical, complex and crucial.

Health issues that this cohort are presenting with include but are not limited to:

- Infected shrapnel and other war related wounds
- Compound (open) fractures
- Acute malnutrition and nutritional deficiencies, especially in children
- Hepatitis A and other viral and bacterial infections
- Acute somatic symptoms due to trauma including insomnia, incontinence and pain, especially in children
- Chronic health conditions requiring immediate monitoring and medication including dialysis, epilepsy, cardiovascular diseases and type 1 and type 2 diabetes
- Complex health conditions across the lifespan including developmental delays, cognitive disability and geriatric conditions such as dementia.

The Network has significant concerns that the Visitor visas offered to people fleeing the humanitarian crisis in Gaza and the Occupied Palestinian Territories are not fit for purpose; that is, the visa does not allow eligibility for essential health and humanitarian support that addresses the complex needs of this group.

We welcome the news that the Albanese Government is exploring permanent visa options for people who have arrived from Gaza, in recognition that return to Gaza is not feasible.

We ask that the Australian Government offer a visa pathway that provides access to the Humanitarian Settlement Program (HSP) and Medicare, both of which are strong enablers of responsive health triage and settlement coordination, as well as access to Special Benefits and work rights.

In the absence of formalized Commonwealth Government support, health triage and settlement coordination activities in Victoria are currently provided by unfunded community organizations, including a core group of probono GPs from the Australian Islamic Medical Association (AIMA). Since November 2023, these GPs, along with the extended families of the recently arrived, have been volunteering to assist over 200 recent arrivals from Gaza. Their support includes coordinating a group of over 100 pro-bono GPs, linking new arrivals to primary care, advocating for those without access to support, and organizing community volunteers to provide transport for medical appointments. The Victorian Government continues to support free access to other healthcare in line with existing asylum seeker and refugee health access policies².

Ten months into this community response, this pro-bono model of support is well beyond its capacity. With the increase in numbers and the cumulative coordination of arrivals, the Network is increasingly concerned about the sustainability of this response and the risk of burn out for this group of GPs.

We recognize the importance of community-led organisations and initiatives in the current health response for recently arrived Palestinians; while formal support is crucial, connections to informal supports and established communities are equally vital for long-term recovery and belonging. However, the Network believes that addressing health needs of humanitarian evacuees requires adequate resourcing for health triage and coordination and cannot solely be reliant on supportive communities.

We strongly encourage the Department of Home Affairs to have stronger linkage and coordination to community organisations and the Department of Health to respond collaboratively to this community's needs. This could include funded positions either embedded in, or with strong direct linkage to, health and community-based services currently providing support. These roles would have responsibility for overseeing and coordinating referral into existing state-based health services.

We note that there are existing platforms at a Commonwealth level to address the health needs of priority populations, such as the Primary Health Network's (PHNs) Multicultural Health Access initiatives. It is with the Commonwealth Government's ongoing leadership and continued commitment to humanitarian and health issues that we urge you to consider a formalized visa pathway for this cohort that allows eligibility to critical humanitarian settlement and health support.

We are available to discuss these matters or to help facilitate a meeting with key agencies if required.


