We are currently in a transition period following expiration of the Future Fit contract with Miles Morgan Australia (MMA) on 31 December 2023. In January the department put in place a transitional contract with MMA to close out the project, and to fully transition any MMA administration at Whitehorse, while consideration was given by government to the next steps in the reform program.

These next steps in the meals reform space include a feasibility study to define a meal that meets nutritional standards, a clear understanding of the value of social capital contributed by the MoW model (and others), and a funding model for both to be applied consistently across the country. In December last year the board of MOW Australia unanimously supported that such a study be enabled by MMA, with some caveats. Other options include sector grants for meals providers to undertake aspects of this work. The approach chosen will be a matter for government.

Thanks for your advice on Monday that concerns have been raised with Senator Rice by a member of the Newcastle MOW (NMOW) board regarding arrangements at Whitehorse during this transition.

We can advise in response:

s47C		

- We reached out to NMOW following your call, and in response the NMOW board has requested support from the department to help facilitate transition arrangements due to these challenging relationships. We will provide this support.
- We also reached to MMA who advise it is outlining necessary changes to operations to ensure full MMA withdrawal by 10 March (in line with the agreed transition timeline)
- NMOW provided the department with a list of 6 transition issues, summarised below along with agreed actions:

1. Website:

- MMA advise the page has no operational link. It is a vehicle for downloading a menu and registering interest in becoming a volunteer. No ordering process.
- The department has requested a pragmatic approach to removing the content.
- MMA have confirmed they will decommission the Future Fit webpages, on 10 March 2024, but is amenable to retaining the Whitehorse content for a short period of time to allow sufficient time for NMOW to work through replacements.
- ACTION: MMA to confirm logistics/feasibility of keeping Whitehorse content available on www.mowfuturefit.com.au over march (completed)



- 3. Operational reporting spreadsheets:
 - MMA to transfer all operational reporting spreadsheets to NMOW in a format that can be integrated into NMOW's new system.
 - MMA advise that this should not be a problem, as there are limited offline documents.
 - Action: MMA to action by 19 February 2024.

4. Menu structures:

- MMA to stop the roll out of any new menu structures, pending further advice from NMOW, noting current plan was to review the menu shortly to streamline menu options (based on client feedback/choice).
- MMA to transfer information related to suppliers (including any supplier agreements) and changes to menu structures i.e., standard operating procedures that outline how NMOW can continue with periodically reviewing the meals being offered, based on popularity as advised by data from suppliers.
- MMA to handover relevant training to NMOW including any online training/handover, as required.
- 5. Paying specified wages up to 6th Dec 2023:
 - NMOW and MMA will need to come to an agreement on how to move forward with this undocumented issue.
- 6. Transition meetings
 - NMOW Transition team and onsite NMOW staff to be invited.
 - Action: the department has requested a commitment from MMA to work collaboratively with NMOW staff, including any new staff coming on board in the near future (provided)
 - New NMOW staff being onboarded this Thursday and on Feb 19th.

While it's very disappointing that the transition has not been as orderly as we would have expected, we remain confident that the back of house changes suppoted by Future Fit (IT, operations, menu mgmt) will stand NWOW in good stead and mitigate potential for client disruption.

1. BACKGROUND/CONTEXT

- The Department entered into an agreement with MMA for the provision of transitioning the WMOW operations to NMOW on 19 January 2024 (PO 4500154545) together with relevant expenditure to a maximum of \$1,534,428.68 (GST Exclusive) / \$1,687,871.55 (GST Inclusive).
- This procurement was conducted through a Limited Tender. As the procurement is over the relevant threshold (\$80k GST Inc), condition 10.3.d.iii of the CPRs for "when the goods and services can be supplied only by a particular business and there is no reasonable alternative or substitute" was used. This LT condition was used <u>due to an absence of competition for technical reasons</u>. Noting that MMA have been heavily involved in the business transformation and technology modernisation project from 2021.
- The contract variation is required to update specific deliverables due to unforeseen changes in the scope of the project.
- On 31 January, MMA notified the department they no longer had capacity to be involved in the broader Future Fit work which included the implementation/deployment of new technology (the Enterprise Resource Planning software). As such, the Whitehorse pilot site will no longer be using the ERP and the software will need to undergo a decommissioning process to remove any client information and transition the software to the department.
- To date the supplier has satisfactorily completed Milestone 1 and Milestone 2. However, this
 excludes software licensing and sustainment as part of Milestone 1, which needs to be amended
 as part of the variation.
