

Final draft of the Aged Care Rules

31 Jul 2025

Aged Care Rules and Transitional Rules will support operation of the Aged Care Act 2024 from 1 November 2025.

Passage of Bills through Parliament 24 Jul to 4 Sep 2025 Introduction of the Aged Care and Other

Legislation Amendment Bill 2025 and the Aged Care (Accommodation Payment Security) Levy Consequential Amendment Bill 2025.

Royal Assent

Royal assent by the Governor General, if given the Bill becomes an Act of Parliament.

Rules registered on Federal Register of Legislation

24 Sep 2025

Aged Care Rules to support operation of the Aged Care Act 2024 formally registered on Federal Register of Legislation.

Start of the Aged Care Act 2024

1 Nov 2025

Aged Care Act 2024 officially comes into effect, transforming Australia's aged care system into a rights-based framework.

Update price list to include Support at Home pricing

1 May - 30 Oct 2025

Aged care providers update their price list to reflect Comprehensive guidance for assessment their Support at Home pricing and upload into the My Aged Care Service and Support Portal.

Reporting period for the expanded Quality **Indicators starts**

and/ 1 - 21 July 2025

Reporting period for the expanded Quality Indicators, which introduced three new staffing quality indicators on 1 April 2025 (Q4), opens for aged care providers to submit staffing data by 21 July 2025 (Q4).

Service Agreement Guidance

Released guidance materials to help aged care providers set up and manage service agreements with Home Care Package recipients transitioning to the Support at Home program.

Aged Care Provider Requirements Search tool launched

15 Sep 2025

Search for the conditions of registration, obligations and duties that apply to different kinds of aged care providers under the Aged Care Act 2024 and associated Rules.

Support at Home Program Manual v4.0 released 15 Sep 2025

Operational manual to outline rules and procedures, provider obligations, assessment and classification processes. This iteration will reflect any additional legislative changes following passage through parliament.

Draft and final My Aged Care (MAC) Assessment Manual v8.0

19 Sep 2025 and 1 Nov 2025

Means Testing communications

Oct to Nov 2025

Support for providers to understand means testing changes building on materials and tools released including revised Fee Estimator on My Aged Care.

22 Sep - 31 Oct 2025

Providers can contact trained My Aged Care staff for help with changes under the Aged Care Act 2024, including support for navigational and new systems and processes.

Commonwealth Home Support Program Manual v2.0 published

31 Oct 2025

Commonwealth Home Support Program (CHSP) manual updated to reflect changes to eligibility and delivery requirements under the Aged Care Act 2024.

National Aboriginal and Torres Strait Islander Flexible Aged Care Program (NATSIFACP) manual published

1 Nov 2025

New NATSIFACP manual and online information published to reflect changes to requirements under the Aged Care Act 2024.

My Aged Care Service and Support Provider Portal login for Support at Home service and pricing

3 to 7 Nov 2025

Service information and pricing entered to be displayed on the My Aged Care website, Find a Provider tool. Includes introduction of Specialisation Verification Framework to Support at Home providers, and process effective 1 November.

19 Sep 2025

The new Standards aim to strengthen provider financial governance and sustainability, so they can deliver high-quality care and services and maintain continuity of care for older people.

Providers can view Support at Home estimated contribution rates in the Aged Care Provider Portal, aligned with the Aged Care Act 2024 to support service agreement discussions.

New registration forms and supporting materials (guides, checklists, FAQs) published to help potential providers understand their requirements and submit applications.

Guide to Aged Care Law

26 Aug - 31 Oct 2025

Simple explanation of the Act to support providers interpret changes impacting their operations. Key sections include Introduction to the Act, new quality and safety standards and provider obligations. Staged release of chapters will occur from late-August onwards.

Single Assessment training

Sep - Oct 2025

Training released in September and October for single assessment workforce includes, clinical delegations, end-of-life-pathways for Support at Home as well as systems training on new workflows to enable the workforce to conduct aged care needs assessments under the *Aged Care Act 2024*.

Support at Home online workshops

Sep - Nov 2025

Workshops will help Home Care Package providers prepare for transition to Support at Home. EY will deliver the workshops as part of the Aged Care Business and Workforce Advisory Service, particularly small to medium providers.

To support integrated claiming, final specifications will build on already released drafts.

1 Nov 2025

Provider Register will list registered aged care providers and key details. The public view allows anyone to search and view provider information, supporting transparency.
