Disability Royal Commission



The **Disability Royal Commission** looked at how people with disability are treated.

We call it **DRC** for short.



DRC wrote a report.

The report was in 12 parts.

They are called volumes.



The report had **recommendations**.

Recommendations are ideas to do things better.



The report had a lot of recommendations.

This will help things be better for people with disability.



We want Australia to be a place where people with disability

Are safe



• Have their **rights** protected

Rights are **rules** about treating everyone

- Fair
- Equally.

Are respected



Can make their own choices



• Live the lives that they want to.

ADS is the governments way of working together to support people with disability to live good lives.

We do this by working with

 with Disabilities.

We call it **CRPD** for short.

ADS Review



1 recommendation was for all governments to **review** ADS.



A review is when you check what

- Works
- Needs to change.



All governments have done this.



The review looked at

• Issues found by the DRC



• Feedback from the community from the last 3 years

Feedback is when you tell someone what you think about something.

Feedback can be telling someone that the help they give you is

- Good
- Bad.

It will help

- Find problems
- Make it better in the future.



• How well ADS is going.



Lots of people took part in the review.

Some of the people who took part were



• ADS advisory council

An advisory council is a group of people who know a lot about something.



• People from the community

This is called **public consultation**.



Disability Representative Organisations

We call them **DRO** for short.

• On 29 January 2025 after the review.

TAPs



• Making new Targeted Action Plans

We call them **TAPs** for short.

TAPs are the small plans that work on ADS.



 Having more accessible communication

Accessible communication is information that everyone can use.

Like Easy Read.



• Sharing more reports



- Working more to support people
 - o By making more homes
 - Who are homeless.

Homeless means you do **not** have a home to live in.



We have finished working on this recommendation.

CRPD



The United Nations Convention on the Rights of Persons with Disability is an agreement between different countries.

We call it the CRPD for short.



The CRPD explains how people with disability have the same rights as everybody else.



All governments are working on the CRPD.



- The Attorney Generals Department
- The Department of Health Disability and Ageing

They are called **DHDA** for short.

Work together on the CRPD.

They have different **responsibilities**.

Responsibilities are the things that you need to do.



The Attorney Generals Department reports to the **United Nations**.

We call it **UN** for short.



They tell the UN how Australia is putting the CRPD into action.




The DHDA is responsible for disability **policies** in Australia.

Policies are plans for how to do things.



DRC said all state and territory governments should have parts that focus on the CRPD too.

They are working on this.



- Australian Government
- State and territory governments

Are working together to share information.



They will also make **guidance** documents.

Guidance is advice on how to

- Do something
- Fix a problem.



This will help all governments to focus on parts of the CRPD they need to work on.



This will help Australia follow the CRPD better.



Governments are still doing work on this recommendation.
