#### **Disability Royal Commission**



The **Disability Royal Commission** looked at how people with disability are treated.

We call it **DRC** for short.



DRC wrote a report.

The report was in 12 parts.

They are called **volumes**.



The report had **recommendations**.

Recommendations are ideas to do things better.



The report had a lot of recommendations.

This will help things be better for people with disability.

Are safe



• Have their **rights** protected

Rights are **rules** about treating everyone

- Fair
- Equally.



We want Australia to be a place where people with disability

Are respected



Can make their own choices



• Live the lives that they want to.



This would make Australia an **inclusive** place for everyone.

Inclusive is when everyone

It has the main things we are working on.

- Have started making changes
- Need more time to finish this work

- Getting money for the work you do.




• Housing.

 Stopping segregated employment by 2034



Segregated means keeping certain people separate from others.

Like keeping people with disability separate from people **without** disability.



 Stopping people with disability being homeless when moving from services.

Homeless means you do **not** have a home to live in.

The Australian Government has made new **resources** for


#### Educators

#### • An intellectual disability

An intellectual disability can make it difficult to

- Learn new things
- Solve problems
- Communicate
- Do things on your own.



#### • A cognitive disability

A cognitive disability can affect how you

- Think
- Learn new things
- Make decisions
- Pay attention.



#### • A learning delay

A learning delay is when someone takes a bit longer to learn.



Teachers can use the resource to make maths programs inclusive.



We have **more work** to do on this recommendation.

#### People with disability working



The recommendation said

 Governments should have plans for how many more people with disability are working.



There needs to be more jobs for people with disability.



The government has set up a working group.

Working groups are a group of people working together on a topic.



#### They will share

- Ideas
- Information

About how to work on this recommendation.



Most governments have started working on this.

They have looked at how many people with disability are working.



The number of people with disability working will be different in states and territories.



The Australian Government is working on step 1 of the **Disability Royal Commission Discovery Project**.



They are talking to

People with disability



• Their boss



• The people they work with.



This will help us to learn about their experience

Starting their job



• Setting goals

Goals are things you want to do.



The different things you want to do for your job

This can be called your job pathway.



This project will help the government decide what changes need to be made.



We are still doing work on this recommendation.

#### Segregated employment



The recommendation said governments should

• Stop segregated employment



• Pay people with disability more money.



The government is still thinking about how to work on this recommendation.



The government has asked for ideas from the community about

Paying people with intellectual disability more money



 Making workplaces more inclusive to support people with intellectual disability



 Closing all segregated employment in by 2034.



The Australian Government made a new fund in 2023.

It is called a Structural Adjustment Fund.



It helps more people with high support needs to have a job.



We also made a new service for people with disability to

- Know their rights
- Have better information.



It helps people **advocate** for themselves.

Advocating for yourself is when you can speak up for your rights.



We give money to run expos.

#### Expos

- Give lots of information about jobs
- Helps you meet new people
- Can give you ideas about different types of work.



We will write a report about these services.

We will say how well they worked.



- Australian Government
- State and territory governments

Worked together to make supported employment better.

They did this in 2023.



There is a new disability employment program starting in November 2025.

It is called **Inclusive Employment Australia**.

We call it **IEA** for short.



IEA will have

New rules



• Support people with high support needs to get a job.

### Stop people with disability being homeless



The recommendation said people should have a home when they leave

• Hospitals



Mental health services



• The **justice** system.





- The law
- Police
- The courts
- Prisons.



The government is working to make sure services

- Work together
- Make a plan together.



This will mean that people with disability will have somewhere to go when they leave.



It is important for everyone to know what part of the plan they need to do.



The **National Disability Insurance Agency** is doing work on this.

We call it **NDIA** for short.

They look after the NDIS.



The NDIA can work with people with disability when they are ready to leave

Hospital



• The justice system.





They are called **Health and Justice Liaison Officers**.



NDIA stopped looking at the day people leave the justice system to make a plan.

They stopped doing this in January 2025.



There will be more information about this in the future.



We have **more work** to do on this recommendation.
