The **Disability Royal Commission** looked at how people with disability are treated.

We call it **DRC** for short.



DRC wrote a report.

The report was in 12 parts.

The recommendation said

 All governments need to work with First Nations people on the DSSP.



DSSP is a plan on how to make the **community controlled disability supports** better.



Community controlled disability supports are there to

 Support the rights of First Nations people with disability



• Help them be included.

Community controlled means run by Aboriginal and Torres Strait Islander people and their communities.



Governments are looking at the DSSP.

This will help us to decide what to do next.



The government is **funding** the National Disability Footprint program.

Funding is **money** to take part in programs.



The program was made by **First Peoples Disability Network**.

We call it **FPDN** for short.

The DSSP says that the program is important.

We call it NDIS for short.




Practice Standards.
