#### 5 March 2025




These are the **minutes** from the Roadmap **Implementation Governance Group** meeting.

Mark Roddam started the meeting.


Mark is the meeting chair.

The department needs to make sure workers can make decisions to do their job well.




Blair answered some questions from RIGG members.

# Talk from a member with lived experience



We heard from Naomi Lake.

Naomi is an advocate with lived experience.



**Lived experience** is when you know what something is like because it happened in your life.



Naomi spoke about her job as a Health Ambassador for Down Syndrome Australia.



She does lots of advocacy for the rights of people with intellectual disability.



Naomi said it is important that we look more into **oral health** and **mental health**.



**Oral health** means looking after your teeth and mouth.



**Mental health** means taking care of your mind and feelings.

The **Roadmap annual report** tells us how we went with Roadmap actions in 2024.



The department met with lots of people to get information for the report.

Julian Trollor spoke about the **National Centre** of Excellence in Intellectual Disability Health.


We will say **the Centre** for short.

The Centre is looking at how to use **research** in intellectual disability health.




**Research** means looking into and learning about new things.

Julian said a team from the Centre is making teaching tools for the Framework project.



Some tools were made with people with intellectual disability and their supporters.



The teaching tools will be used by teachers at universities.



The tools will help health care students learn about intellectual disability health.

The next project we heard about was the **Annual Health Assessment** project.



An **Annual Health Assessment** is a big health check with your doctor every year.



Kristen Kalkman from Inclusion Australia told us about the **It's Doctor Time! Campaign**.



The **It's Doctor Time! Campaign** tells people with intellectual disability to have a yearly health check.



It's Doctor Time! has been going for 5 months.



Inclusion Australia have heard that people like the campaign.

**Social media** is a way for people to connect and share things online.



Professor Nick Lennox from the department talked to us.



He talked about about helping doctors to use the **CHAP** form to do yearly health checks.




The **CHAP** form helps the doctor learn about you and your health.
