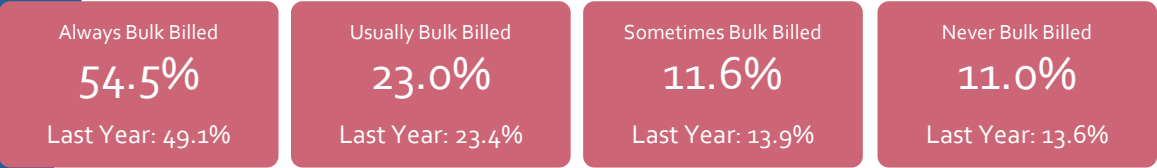


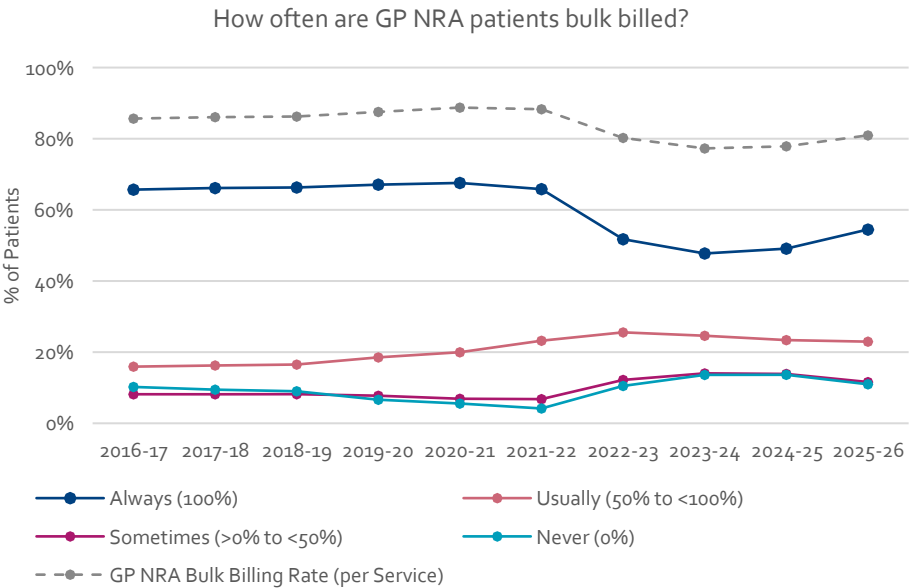
GP Non-Referred Attendances (GP NRA) per Patient Bulk Billing Ranges, 2025-26

(including temporary COVID-19 Vaccines items)

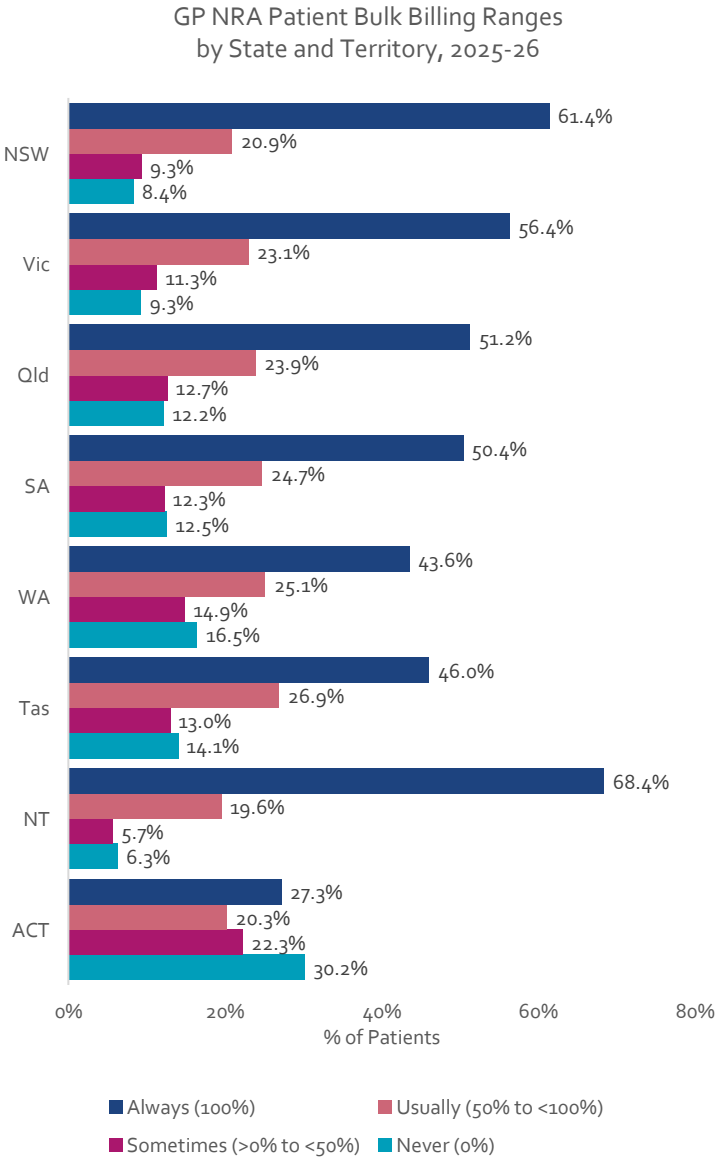


Many patients have more than one GP NRA service during the year. This page shows the proportion of patients who were always, usually, sometimes, or never bulk billed across **all** of their GP NRA services.

In 2025-26, the proportion of GP NRA patients who were always or usually bulk billed **increased from 72.5% to 77.4%** while the proportion of patients who were never bulk billed **decreased from 13.6% to 11.0%**.



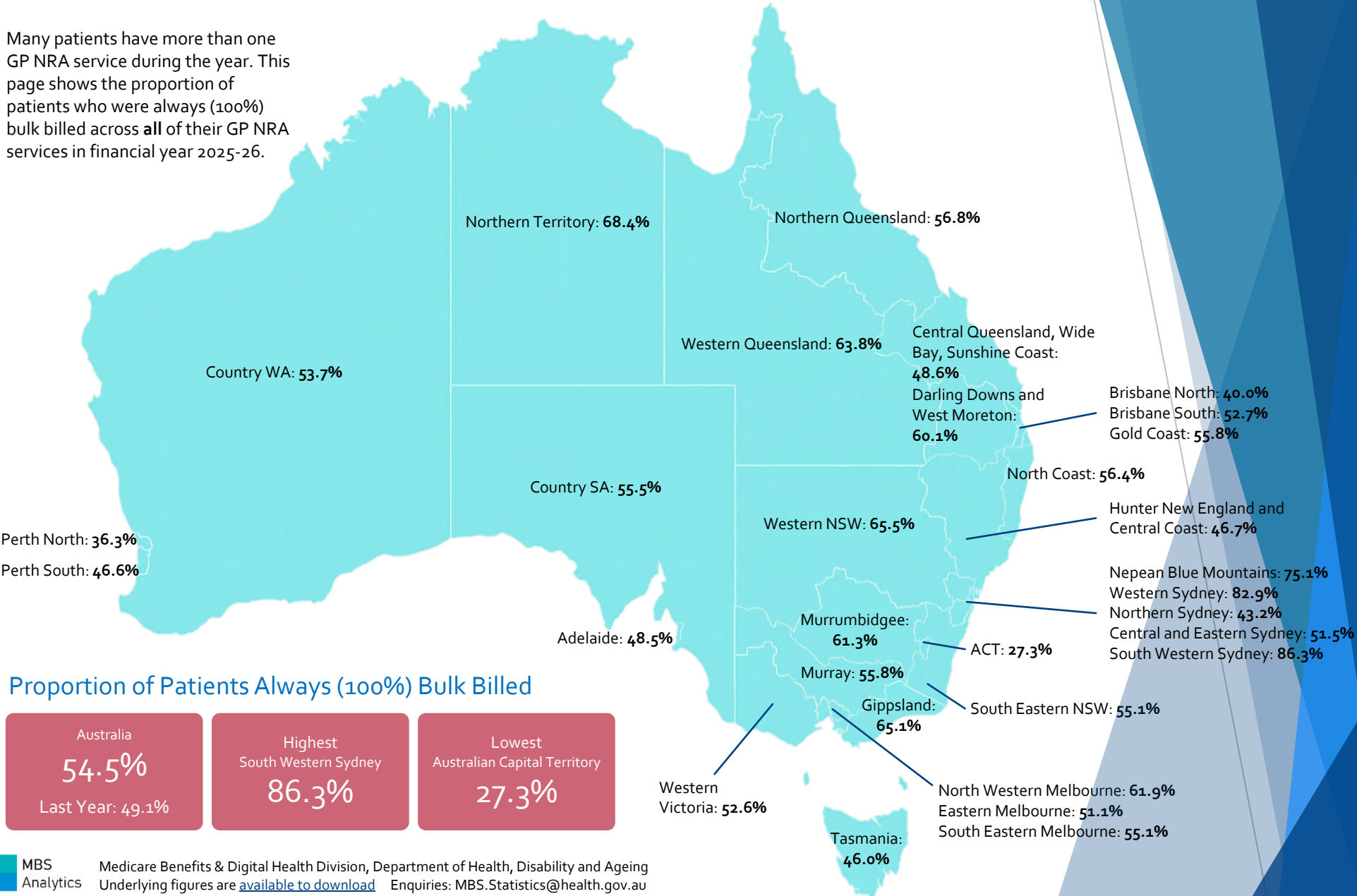
The proportion of patients always (100%) bulk billed tends to be lower than the bulk billing rate because patients with, for example, 9 out of 10 services (90%) bulk billed are classified as “usually” bulk billed.

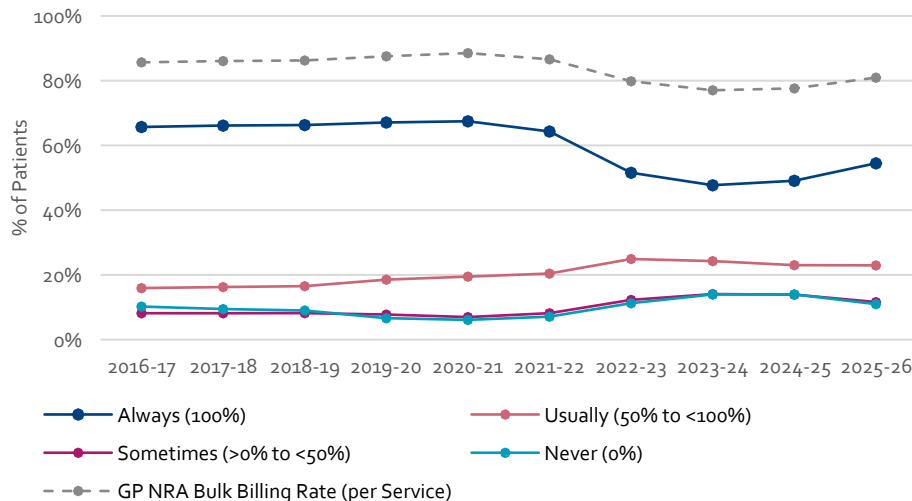

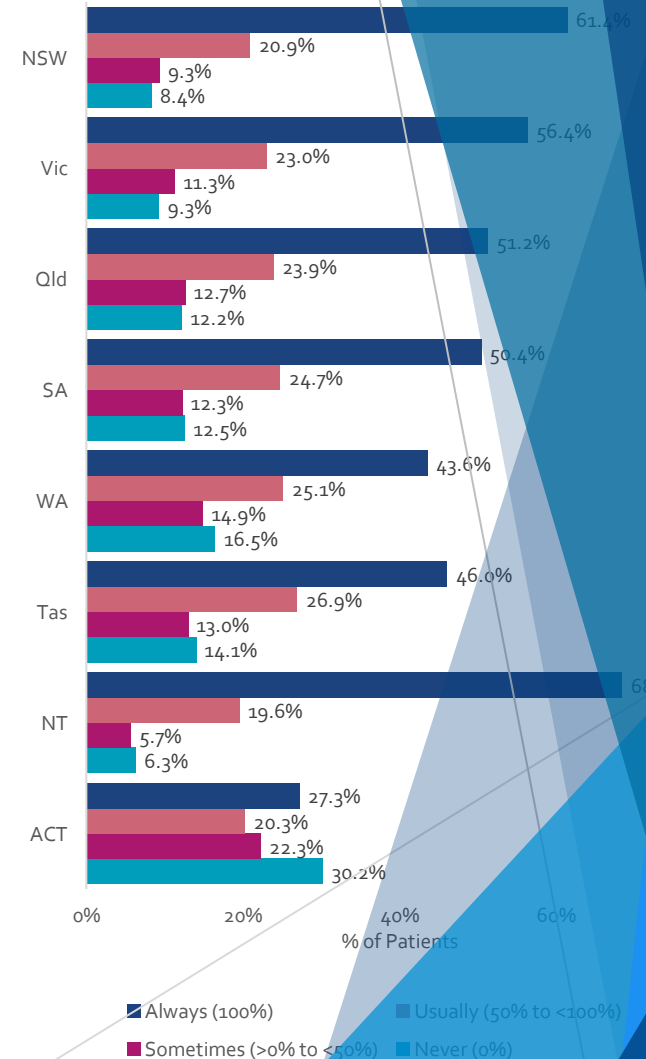
