Future Fit Collective represents a coalition of Meals on Wheels Services who were previously involved in a government funded reform program "Future Fit".

Future Fit's aim was to provide Government with a consistent service model and basic backbone infrastructure with the objective that Government can adequately map, fund and develop meal services across Australia. The Future Fit program was funded by Australian taxpayers for the benefit of older Australians.

Future Fit was unlike any other, in that grass roots meal services were engaged to provide their knowledge, experience and time, outside of management of their individual services and commitment to their respective local communities. In the past Peak Bodies, with no real day to day exposure to service delivery, have been engaged by Government for information.

The resultant technology from the Future Fit program could not have been built without this knowledge, experience and input. Since the decision to halt the Future Fit program, the connections made through the experience has seen the birth of Future Fit Collective to continue to build and grow shared resources across the network, hence Open Care Tech.

Our aim is for Open Care Tech to be open-source software. We believe that this collaborative approach will foster innovation, reinforce a strengthened sense of community, drive improvements, and ultimately support our common goal, which is to enhance the quality of in-home care.

The Future Fit program was designed to support Meals on Wheels (MoW) organisations by codesigning an accurate funding model and policy parameters, a new definition of a meal, and quantifying the social capital elements of service delivery. Overall, the primary objective was to maintain the viability of services that offer social supports alongside meals delivery through a volunteer workforce, and, most importantly, support older Australians to access nutritious meals. In line with the Commonwealth Procurement Rules, the Department of Health and Aged Care approached Miles Morgan Australia Pty. Ltd. (MMA) through a panel arrangement which was established through an open tender process. At the time, MMA had already been working closely with Meals on Wheels Australia (MoWA) and had a thorough understanding of some of the challenges being faced by the MoW service delivery model.

As part of the original contract, MMA designed and tested customer resource management software which was codesigned with frontline MoW organisations across Queensland, New South Wales and Tasmania. In addition, Future Fit delivered:

- A consistent definition of a meal.
- A strengthened network of MoW providers who can learn from each other's operations and share valuable resources in order to meet growing demand from older people.
- A six-month pilot of an alternative service-level delivery model. The pilot focused on improving client choice while maintaining the social connection with clients.

In line with the terms and conditions of the MMA contracts, the department is of the view that the Commonwealth owns the intellectual property in the contract material created under them. However, the department is currently investigating conflicting claims for intellectual property ownership. **Until these claims are resolved, the department is unable to provide access to the software.**

The department aims to continue working with the meals sector, including MOW Australia and non-MOW meals service providers, to finalise the underlying policy parameters for meals services such as further testing the new definition of a meal and quantifying the social capital elements of service delivery.

The Future Fit website was decommissioned with the finalisation of the project. The department is committed to being open and transparent in relation to the Future Fit project and is considering publishing Future Fit program artefacts such as discussion papers and reports in the near future. Other websites referenced are not a result of any contractual arrangements between the department and MMA and not the responsibility of the Commonwealth.

The current contract with MMA provides funding to wind-up Future Fit activities including funding for the transfer of IT systems and the Future Fit operating model, tested in Whitehorse between July

2023 and February 2024, to Newcastle MoW (NMOW) as the grant recipient of Whitehorse MoW. The end date of this contract is 31 May 2024, with final arrangements in relation to the final report to be completed. The final report will include a summary of the project and an analysis of the outcomes.

In relation to the payment of subcontractors, the department has not been contacted by any subcontractors regarding outstanding payments. This issue has been raised by other parties and the department is seeking confirmation from MMA that its subcontractors are not out-of-pocket for work completed for the Future Fit program.

Hi all,

I am writing a feature for this weekend's *The Saturday Paper* about aged care transformation broadly but specifically about the series of contracts that went to Miles Morgan Australia as part of the Future Fit program to work with Meals on Wheels and the recent contract 'extension' of \$1.6 million to transition Meals on Wheels Newcastle / the Whitehorse site "away from the intensive assistance that was being delivered through the Miles Morgan arrangement".

As I'm sure you would appreciate, there are a number of questions. I am mostly interested in the contracting arrangements and work performed or supposed to have been performed by Miles Morgan Australia.

AusTender lists the procurement method for CN3839409 as an "open tender" but documents released under FoI, including the ministerial submission signed by then aged care minister Richard Colbeck, repeatedly state that Miles Morgan Australia were approached directly by the Department of Health due to their previous engagement advising Meals on Wheels Australia. Why did the Department state otherwise publicly?

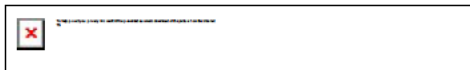
