

# **Value for Money Assessment**

This document describes the evaluation process used to determine value for money for procurements where <u>one</u> <u>supplier has been approached</u>. The findings and recommendations of the evaluation are recorded below.

# Background

In October 2018, the Department received a research proposal from the National Centre for Epidemiology and Population Health (NCEPH), Australian National University by email to undertake a public health assessment of e-cigarette use in Australia. The Minister announced that \$750,000 (GST exclusive) would be allocated over two financial years for this important work. In progressing this work the Department sought further details from the NCEPH and comprehensive proposal was received on 2 January 2019 followed by an amended proposal on 23 January 2019.

The process followed for this procurement has complied with the *Commonwealth Procurement Rules* and with our agency's internal requirements.

# Findings of the Evaluation

The quotation received was compliant and fully assessed.

## Recommendation

The evaluation team unanimously recommends that NCEPH be contracted for \$825,000 (GST inclusive) to undertake a public health assessment of e-cigarette use in Australia.

This decision is based on the evaluation assessment that the offer from NCEPH provides the best value for money outcome.
