Dear Mr Morrison

I would like to arrange a meeting with you to discuss THR policy reform. Much has moved internationally on this issue in recent years, though not in Australia.

As you may be aware, people living in the lowest socioeconomic areas of Australia are nearly three times more likely to smoke than those living in the highest socioeconomic areas. As such, while this is an important issue for your constituents, this matter is also relevant to your portfolio and the broader policy agenda with respect to the opportunity to improve public health, while reducing health inequalities and the need to raise revenue to cover health expenditure over the short, medium and long term.

I **enclose** a briefing note as background and would be pleased to meet with you to discuss this (in Canberra or Sydney) at your convenience.
