## INSTRUMENT OF VARIATION

THIS INSTRUMENT OF VARIATION is made the ... day of ... July 2002

## BETWEEN

THE COMMONWEALTH OF AUSTRALIA ('the Commonwealth') as represented by the Minister for Health and Ageing ('the Minister')

AND

ALCOHOL EDUCATION AND REHABILITATION FOUNDATION LIMITED (ABN 91 096 854 385) ('The Foundation')

#### WHEREAS:

- A. The Commonwealth and the Foundation entered into an agreement dated 15 November 2001 ('the Primary Agreement');
- B. The Commonwealth and the Foundation wish, by this Variation, to vary the Primary Agreement and intend that this Variation shall form part of the Primary Agreement and shall be governed by the terms and conditions of the Primary Agreement.

# NOW IT IS HEREBY AGREED:

### VARIATION

1. Clause 21.3. of the Primary Agreement is hereby varied by deleting the sentences reading:

"The Foundation must provide the Commonwealth's Liaison Officer with progress Reports containing the information specified in **clause 21.4** every six months by 30 June and 31 December for the term of this Agreement, but with the last progress report being due on 30 June 2005. The Foundation must provide a final report containing the information specified in clause **21.5** by 31 July 2005.

and inserting the following sentence:

"The Foundation must provide the Commonwealth's Liaison Officer with progress Reports containing the information specified in **clause 21.4** every six months by 30 September and 30 March for the term of this Agreement, but with the last progress report being due on 30 September 2005. The Foundation must provide a final report containing the information specified in **clause 21.5** by 30 September 2005."

- 2. Clause 22.1 of the Primary Agreement is hereby varied by deleting "\$11,500,000.00" wherever appearing and inserting "\$12,650,000.00 (GST inclusive)".
- 3. Clause 23.6 of the Primary Agreement is hereby varied by deleting the words "rule 4.1" and replacing it with the words "rule 5.1".

- 4. Clause 25.1 of the Primary Agreement is hereby varied by deleting "\$103,500,000.00" and inserting "\$113,850,000.00 (GST inclusive)".
- 5. Clause 25.2 of the Primary Agreement is hereby varied by deleting "\$103,500,000.00" and inserting "\$113,850,000.00 (GST inclusive)".
- 6. Item A of Schedule 1 of the Primary Agreement is hereby varied by deleting the words:

- 8. Schedule 2 of the Primary Agreement is hereby varied by deleting the paragraphs under the heading "Payment of Funds" commencing with the words "The Commonwealth will pay..." up to and including the words "On 1 April 2005 \$10.25 million", and replacing them with the following paragraphs:

"The Commonwealth will pay the Administrative Funds and the Account Trust Funds to the Foundation in the following instalments, which are inclusive of GST:

"The Foundation must by 31 July in 2002, 2003, 2004 and 2005 provide a report to the Minister for tabling in Parliament."

and replacing it with the following:

"The Foundation must by 30 September in 2002, 2003, 2004 and 2005 provide a report to the Minister for tabling in Parliament."

Schedule 3 of the Primary Agreement is hereby varied by deleting the words "rule 4" and replacing it with the words "rule 5".
