- Each state and territory is responsible for legislating who can and cannot administer vaccines in their individual state and territory, including with National Immunisation Program vaccines.
- The issue of pharmacists administering vaccinations has progressed in each jurisdiction at the discretion of state and territory health ministers. All eight states and territories have revised legislation to allow pharmacists to administer vaccines.
- A Working Group has been established and work is progressing through the Australian Health Protection
  Principal Committee to develop options to work towards national consistency and to provide advice and
  recommendations to COAG Health Council.
