#### Welcome

The CMO welcomed members and gave a brief update on the current situation with nCoV worldwide cases and noted that there needs to be a clear narrative around people with mild disease.

There has been growth in cases and deaths in Hubei Provence – 2% CFR

- Total cases 28,262
- Cases Aus 14
  - QLD stable at the moment.
  - VIC in hospital for isolation.
  - 5 discharged from hospital
- Deaths 565

### **AUSMAT Deployment – Christmas Island**

Ms Rhonda Owen provided members with a brief update on the 12 member, AUSMAT Team 2, who will be leaving for Christmas Island tomorrow.

#### The CMO advised that:

- two people on Christmas Island who have been tested for nCoV have been confirmed negative;

- the isolation pods can take up to 50 people;
- authorities are trying to improve facilities for the passengers staying there.

### **CDNA Update**

Dr Sonya Bennett provided members with a brief update on the work currently being undertaken by CDNA.

#### Modelling scenarios for nCoV

Professor James McCaw provided members with an overview of the modelling currently being undertaken on different scenarios for the novel coronavirus over the next 3-6 months and what would happen if containment fails. Professor McCaw thanked those involved for assisting and enabling the interim report to be delivered in such a short time frame.

The advice is based on scenarios and not predictions. Literature has informed the best efforts of transmission.

#### Questions

KC – good for separate work on those expected to present unwell. Seeking health services that could be general practice.

JM – this will take another week or so to complete.

The CMO advised members that the Health team has been working on an implementation plan based on the AHMPPI. The "coronavirus pandemic plan" will incorporate the modelling into the decision making process.

#### **Cruise Ships**

Members discussed expectations for the clarity of actions for cruise ships following advice from the Foreign Minister that another cruise ship from Taiwan is in quarantine in Hong Kong. Information coming through mentions 15 Australians sick on board the ship.

#### **IPCAG** update

Professor Lyn Gilbert gave an update on the work being undertaken by the group including the use of P2 masks in the healthcare setting and the use of PPE on retrieval aircraft.

Members noted that emphasis needs to be placed on the importance of not using P2 masks unnecessarily and that messaging needs to be consistent and specific. Members also noted that there is a shortage of masks due to the major disruption in supply chains and limited resources around the world.

Professor Kelly noted that policy on the use of masks needs to be developed.
