Prof Murphy opened the meeting with an update on the current case numbers and noted concerns around the situation in Italy and Iran. He noted that there has been no acceleration of cases in provinces other than Hubei, however, numbers continue to grow in Hubei.

CDNA

Dr Bennett reported from today's meeting. She echoed the concerns around Italy and Iran, noting that Italy is not as alarming as the index case had travelled to China and mobility restrictions have been implemented but there is evidently second or third generation transmission.s33

Members noted that the behaviour of the disease is difficult as epi is therefore based only on severe cases as mild cases are not being reported and/or monitored.

Repatriation Update

Dr Stephens advised Members that all passengers are settled and currently well at Howard Springs with no further cases at this stage.

A/Prof Spurrier raised concerns around risk of reinfection of people who have had COVID-19. Prof Murphy advised that both PHLN and CDNA are considering this issue in consultation with Paul Armstrong. A decision is to be made out-of-session and provided to AHPPC.

Release of AHPPC Statement

Members discussed a draft AHPPC statement Prof Murphy would like to release today. The statement is to advise the public of the evolving global situation and the changes to assessment of risks to Australia. All members that the statement should be released today. Some minor changes were suggested. A final draft is to be circulated at 4pm prior to the release at 5pm.

Members noted the importance of the balance between reassurance to the public and being upfront about the likelihood of a global pandemic. The messaging may need to be stronger in a staged approach as the situation changes. All Members agreed to the need for consistent messaging to ensure public confidence. Jurisdictions communications to mirror the CMO's AHPPC Statement.

It was agreed that the situation would be reviewed at each meeting with the possibility of staged public advice twice a week.

ACTION: The Secretariat will circulate the updated version of the AHPPC Statement at 4pm. Comments to be consolidated prior to release at 5pm.

ACTION: Global situation to be review with update of the AHPPC Statement twice weekly.

Actions from AHPPC meeting with Ministers

Prof Murphy will be providing Ministers with a COVID-19 update at Friday's CHC meeting.

Prof Murphy confirmed that travel advisories for Japan and South Korea have been increased to Level 2.

Ms Street advised that supplies of flu vaccine in the NIP are satisfactory but will advise further regarding private provider supplies. She also advised that she will advise of the launch date for the Flu vaccine strategy
