- MBS benefits are payable for clinically relevant services but services must also comply with state and territory legislation in the state or territory in which the service is provided.
- Access to termination services is a state and territory responsibility and the Australian Government has no constitutional powers in this area. The laws relating to pregnancy termination vary by jurisdiction.

- The Australian Government is committed to ensuring that all Australians are able to access timely and affordable health care by providing Medicare Benefits Schedule (MBS) rebates for clinically necessary medical treatments.
- There are three Medicare Benefits Schedule (MBS) items (item 16530, item 16531, and item 35643) which could be used to provide rebates for the surgical termination of pregnancy.
- These items are not specific to pregnancy termination and may be used ٠ for procedures to the uterus when performed for a range of other reasons, including miscarriage.
