Your Organisation is provided with the Agreement which must be signed.

When the Department has executed the Agreement, it will return one executed copy of the Agreement to Your Organisation for Your Organisation's records.

A grant agreement starts on the Commencement Date and ends on the Completion Date, those dates being defined in the Terms and Conditions for the Standard Grant Agreement.

If Your Organisation believes that it will have difficulty complying with any part of the grant agreement, it will need to resolve those difficulties before signing the Agreement. If Your Organisation is uncertain about any aspects of the funding agreement it should seek independent legal advice before signing the Grant Agreement.
