In our working with the HCP1 prostheses usage data we have come across a number of billing codes which I have been unable to match to an item on the Prostheses List itself. I have followed this up but per the response below it seems that it is unclear what some of these codes specifically refer to and may require going back to the insurer or hospital themselves.

Some of these codes seem to have a considerable amount of payments against them so it would be good to know what this expenditure relates to. In particular, the following codes are of interest:

- DT007 s 38
  - Seems to be only related to MPL
- P0305 s 38
  - Seems to be only related to HCF
- 999999 s 38
  - o Related to numerous insurers, though primarily MPL
- P0574 \$ 38
  - Seems to be only related to HCF
- P0152 S 38
  - Seems to be only related to HCF

Would it be possible to follow up further on these items to confirm what they relate to? Thanks very much again for all the help.

## I've been provided with the following response:

The quick answer to the question is that "billing codes" turn up in the HCP1 collection that are not found in the Prostheses List for a variety of reasons:

- · Coding error by the hospital or insurer
- Insurer has paid benefits on an ex gratia basis and given the device an identifier of its own
- Who knows???

We usually have no need to check out what these codes relate to so we just ignore them. It would be good to be able to find out what the codes relate to that have significant benefits expenditure. You might want to check with the CASEMIX data people to see if they can track back through the data to find out where they originated (hospital or insurer) and then contact them to find out.

It's probably not the most helpful of responses – but it probably does explain why there is such a difference in billing codes. It may be that the '99999' wasn't a default or an error code, but rather somewhere along the line a convention was developed that if there was uncertainty, that's the code you should use.

Thank you for offering to follow up on this for me.

Since my last email, I realised that there were some instances of billing codes on the list that matched the pattern I described in my last email (e.g. A1004). However, there remain a decent number of codes that I am unable to match to a version of the Prostheses List (Parts A, B, or C). Overall, it is a minor issue but for the sake of covering all bases it would be good to understand what might be going on – especially for a couple of codes in particular.

I have attached to this email a summary of the billing codes I have been unable to match to the list as a reference – however, I am certainly not asking to have the full list clarified! There are just a few key questions that I am interested in having cleared up:

- What is the DT007 code? This had s 38 paid out for FY18/19 but I am unable to find it on the list and there seems to be a large variety in the benefit amounts being paid (suggesting that something else may be going on than a typical prostheses list item)
- Can I confirm that 99999 is a default 'error' or 'unknown' code? How does such a code arise?
- The only other codes I am unable to determine that have had considerable usage are P0305, P0574 and P0152 – do you know what these codes refer to?
- Is there anything else I should be aware of that might explain why the codes listed do not seem to appear on the Prostheses List but appear in the HCP1 Prostheses dataset?
