Dear Professors Kapur and Milroy

Following our discussion last week on the Million Minds Mission teleconference scheduled for tomorrow afternoon, we thought that we would provide you with a status update:

We have reviewed the statistics that the NHMRC have provided us re: Conflict of Interest for this first round of funding and out of the 15 advisory panel members:

- Eight have a direct conflict of interest (listed with a CI role);
- An additional four have an indirect conflict of interest (employed for an organisation that has an interest in a proposal);
- Only three advisory panel members have no conflict of interest. This includes both lived experience representatives and one other.

Given this we are proposing that the draft framework that we discussed last week is no longer relevant and instead we are proposing to draft up a series of talking points to support the discussions and are aiming to send these to you later this afternoon.
