Issues:

- Your approval is sought to the commitment of \$101.805 million (GST exclusive) for projects up to six years (2019-20 to 2024-25) under CHHP and other health measures from the 2019-20 Budget, outlined in the assessment summary at <u>Attachment A</u>.
- If approved, the Department will be able to offer grant agreements for the projects to be progressed as part of Round 3 CHHP activity, including the ability to effect variations to the grants which are not significant in nature (such as application of GST where applicable, minor changes to the grant value or project scope or parameters), subject to the funded activities continuing to promote the program outcomes.
- Specific issues relating to three projects (Bellarine Community Health, Pharmaceutical Rehabilitation Services and Wishlist) are noted below. In addition, risks for some proposals have been identified and approaches to mitigating these risks are outlined in <u>Attachment A.</u>

- All of the AOD projects have been the subject of Budget consideration and given authority to proceed by the Prime Minister. On this basis, the Department proposes to execute the agreements in line with Cabinet authority,
 - funding for each specific project has already been agreed by Government and all projects have been announced;
 - while there is some risk of adverse commentary from the Australian National Audit
 Office and from any parties opposed to the expenditure, delaying or not proceeding
 with projects also carries risk given stakeholder commitments on the basis of Budget
 announcements;
 - c. given these are one-off grants, the likelihood of them being legally challenged is low; and
 - d. s42 will be mitigated to some extent through strong grants management processes established to run through the life of each agreement, to ensure that funds are spent for the intended purpose

Background:

The CHHP is part of the 2018-19 Mid-Year Economic and Fiscal Outlook (MYEFO) measure and the 2019-20 Budget. This spending proposal contributes to the objectives of the CHHP.

Between 13 and 24 March 2019, the Prime Minister, the Hon Scott Morrison MP, agreed the projects to be funded through a series of letters as part of the 2019-20 Budget.

Spending and Grant Rules

Consistent with requirements under the *PGPA Act* and CGRGs, an assessment plan and ad hoc Grant Opportunity Guidelines (GOGs) have been developed to guide the assessment process. In accordance with section 71 of the *PGPA Act*, in order to approve the grants you must be satisfied (after making reasonable inquiries) the expenditure is proper use of relevant money. Further information, including your Ministerial obligations under the PGPA Act, is provided at Attachment B.

Bellarine Community Health

We previously sought your agreement (MS19-001531 refers) to provide funding for the Ocean Grove Health and Wellbeing Hub via the local PHN. Subsequent additional information provided by your Office has indicated that there are two separate projects with more of a focus on capital upgrades, which prompted a reconsideration of the best approach. Noting that Bellarine Community Health (BCH) has previously been funded for the successful delivery of a capital grant, the Department now recommends that this funding be provided directly to BCH for the Health and Wellbeing Hub at Ocean Grove (\$4 million) and Community Health Centre upgrade in Portarlington (\$2 million). The grant agreement will require BCH to work closely with the local PHN.

Pharmaceutical Rehabilitation Services

\$450,000 was allocated in the 2019-20 Budget for this project, however the media release indicated that \$600,000 would be made available - refer Attachment D. After confirming with your Office the project should be funded \$600,000 and given this is a small amount, the Department will accommodate this within the existing Drug and Alcohol Program allocations. Funding will increase \$50,000 over each of the three years 2019-20 to 2021-22.

Wishlist – Sunshine Coast Accommodation Hub

Funding for this project has been allocated from 2020-21, but the organisation has requested that a relatively small amount of funding (in the order of \$100,000) be made available during 2019-20 to facilitate preparation for the project. As this small amount can be accommodated within existing allocations, the Department proposes to agree to this request. A number of other organisations and state governments have requested more significant rephasing of their funds and have been advised that this is not likely to be agreed.

Funding within your electorate

The CGRGs require any funding granted in your electorate to be recorded and advised to the Finance Minister as soon as practical. This is not required for grants that are across multiple regions but does include funding in this submission for the Bays Healthcare Group - Alexandria Park Community Services. A letter to the Finance Minister is included at Attachment C for your signature.

Media

In line with your media release of 30 June 2019 - Community Health and Hospitals Program funding underway, the Department can draft a media release to outline the next round of funding is underway, if required.

Sensitivities: The need for additional information from project proponents, or to negotiate details of more complex projects, may delay offering formal grant agreements. This will be managed as needed on a case-by-case basis.

Consultations: Consultations with the the Health Grants and Network Division, Population Health and Sport Division, Mental Health Division, and Financial Management Division have been undertaken and will continue as required.

Impact on Rural and Regional Australians: Rural health is a key focus area for consideration of funding through CHHP.

Mandatory Grant Rules and Guidelines & Other Requirements

The CGRGs require Ministers to comply with relevant legislative requirements in the PGPA Act and the CGRGs and officials are required to advise their Ministers on these requirements. In making your decision you will need to consider your mandatory obligations associated with approving grants presented by the Department. These include:

- a. If you approve expenditure under section 71 of the PGPA Act, in relation to a grant or group of grants, you *must* not approve the grant without first receiving written advice from Department staff on the merits of the proposed grant or group of grants before you make your decision. That advice *must* meet the requirements of paragraph 4.6 of the Commonwealth Grant Rules and Guidelines (CGRGs).
- b. If the proposed expenditure of relevant money relates to a grant, where you exercise the role of approver you *must* also record, in writing, the basis for the approval relative to the grant guidelines and key considerations of value with relevant money. The recommended basis and record for the approval, relative to the grant guidelines and the key consideration of value for money, are set out in this brief. If there is any alternative basis or considerations on which you are basing your decision you should record these in accordance with clause 4.11 of the CGRGs.
- c. If you approve a grant the Department has not recommended for funding (e.g. because it is ineligible or because it is not competitive or value for money), you must provide written advice of the basis of your approval for reporting to the Department of Finance in line with the CGRG annual reporting requirement in paragraph 4.13 of the CGRGs, i.e. by 31 March each year for grants approved in the preceding calendar year.

Consistent with section 71 of the *Public Governance, Performance and Accountability Act* 2013 (PGPA Act) you must not approve a grant unless, after reasonable enquiry, you are satisfied that these grants would be a proper use of relevant money.

If your approval is not given, or is made conditional on the applicant meeting additional obligations, please advise the reasons for your decision and any conditions placed on the approval, for follow-up by the Department.

For the majority of grants, once the grant is approved, the Secretary or their delegate, will approve the commitment of relevant money under s23(3) of the PGPA Act and enter into the arrangement pursuant to s23(1) of the PGPA Act or s32B of the *Financial Framework* (Supplementary Powers) Act 1997 (and 32C if applicable) as the case requires. For grants made under specific statutory legislation the brief will contain details of the relevant statutory framework and approvals.

The Department is responsible for ensuring forward year commitments are recorded in accordance with the PGPA Act. The Department will record any applicable amounts if you approve the grant/s recommended in this brief.

Pharmaceutical Rehabilitation Services to receive \$600,000

The Liberal National Government will invest \$600,000 through Pharmaceutical Rehabilitation Services in Beenleigh, to tackle drug and alcohol abuse.

Pharmaceutical Rehabilitation Services run a targeted programme with a focus on drug and alcohol treatment, preventative primary and chronic disease management and mental health.

Minister for Health, Greg Hunt said the funding would assist people battling the effects of substance abuse and boost the capacity of treatment in Logan.

"We know that people impacted by alcohol and drugs need to be able to access appropriate support when and where they need it, services are crucial to enable people with substance problems to get their lives back on track," Minister Hunt said.

"Pharmaceutical Rehabilitation Services are engaging with local GPs in Logan to assist them on drug and alcohol and Hepatitis C treatment methods. Our support will allow them to expand on this program and educate the local community."

Federal Member for Forde, Bert van Manen said alcohol abuse can have a devastating impact on families, especially children.

"We are seeing more admissions to hospital where alcohol is a primary cause, more deaths from substance misuse which is why our Government are investing in specialist treatment services."

"The funding will increase the treatment service offerings in Logan where historically there has been a large gap. Not only will the funding increase access to specialised health care, but will go towards upgrading facilities and a targeted education and awareness campaign," Mr van Manen said.

The Government is committed to tackling substance abuse in Logan with a \$600,000 investment in Pharmaceutical Rehabilitation Services.

The Liberal National Government's strong economic management ensures the continued investment of record funding into vital health initiatives including drug and alcohol treatment, mental health, life-saving medicines, Medicare and hospitals.
