

# Issues:

1. The Prime Minister wrote to you on 22 August 2019, regarding the transfer of responsibility and associated administered funding for two infrastructure programs from the Infrastructure portfolio to the Health portfolio. The programs transferring are the FFWSS program, with associated administered funding of \$150 million, \$22

2. The FFWSS program has identified 47 projects valued at \$139.23 million (Attachment B). The imp<sup>7</sup> remaining \$10.77 million (of the \$150 million) is to be settled at a later date with the Prime Minister's Office.

5. The Department will implement the grants as per the grants administration process which will include conducting organisational risk and financial viability assessments for new funding recipients.

6. Draft letters have been developed for you to send to grant recipients advising of the FFWSS <sup>\$ 22</sup> transfer to the Department of Health (Attachment D and E). You are being asked to

sign one of two letters depending on the grant recipient.

7. Attachment D relates to the FFWSS program and asks grant recipients (47) to provide simple information to facilitate the grant process.

9. In addition, you are being asked to sign a letter at Attachment F to relevant Members of Parliament advising them of the funding in their electorate.

## Background:

The FFWSS program was jointly announced by the Prime Minister and former Minister for Sport, Senator Bridget McKenzie in the 2019-20 Budget.

Grant recipients are identified in Attachments B and C.

# **Budget/Financial Implications:**

The transfer of the administered funding from the Infrastructure portfolio is within Budget Bill 3 so will not be received by the department until Additional Estimates, in early 2020. The Department will make arrangements to fund recipients earlier, in anticipation of funds transferring into the Health Portfolio from Department of Infrastructure, Transport and Regional Services.

Detailed costings, including annual splits by project, are being sought from the Department of Infrastructure, Transport and Regional Services for the \$150 million FFWSS program. It is understood that the funding is profiled \$20m, \$40m, \$40m and \$50m from 2019-20. **\$22**

Dear Minister Kerlach

The Deputy Prime Minister and Minister for Infrastructure, Transport and Regional Development, the Hon Michael McCormack MP, wrote to me on 20 June 2019 regarding the transfer of the Community Sport Infrastructure – Female Facilities and Water Safety Stream program (the program) from his Department to the Department of Health.

I have agreed to transfer responsibility for the program and associated administered funding of \$150 million to the Health portfolio, with you as the responsible Minister. I ask that you deliver the projects identified at <u>Attachment A</u>, totalling \$139.23 million, under the program. Arrangements for the remaining \$10.77 million will be settled at a later date, with my Office.

I ask that your portfolio work with the Department of Infrastructure, Transport, Cities and Regional Development to ensure delivery of the program does not duplicate the purpose or outcomes of existing programs.
