Issues:

1. The Department recently wrote to you regarding the transfer of responsibility and associated administered funding for the FFWSS s22 from the Department of Infrastructure, Transport, Cities and Regional Development (DITCRD) to the Department of Health (Attachment A). Since the transfer of responsibility, the Department has worked with your office and the DITCRD to consolidate and confirm the election commitment projects made under these programs. As a result, a number of administrative changes have been requested to these projects which do not align with the Prime Minister's correspondence of 22 August 2019 and 3 September 2019 (Attachment B and C).

2. To clarify the changes, a letter to the Prime Minister is attached seeking his agreement as outlined in Table 1 (**Attachment D**). If approved, funding will be adjusted under the programs in accordance with the addition and removal of projects as specified. If agreed, it should be noted that the unallocated funding under the FFWSS program will also increase from \$10.77 million to approximately \$16.34 million.

- 3. The letter also seeks agreement from the Prime Minister to transfer the delegation to manage the FFWSS s22 as it is anticipated that further administrative changes will be required to these projects. It is proposed that the Prime Minister gives you the authority to commit funds to new projects under FFWSS using the unallocated funding.

Timeframes:

The majority of the letters under the FFWSS \$22 have been issued to the proponents and relevant local MPs by you. The Prime Minister's approval to these administrative changes will facilitate the remaining letters to be issued without further delay

Background:

The Department has made available limited funding for grant recipients that identified a need to commence their projects in anticipation of the administered funding being transferred through the Additional Estimates process.

Budget/Financial Implications:

Consequently, the total program funding for FFWSS will decrease from \$150 million to \$148.1 million.

Department of Finance has confirmed Health will be able to effect a transfer of appropriation from DITCRD using Machinery of Government provisions. The Department will progress this transfer as a matter of urgency. This can be undertaken at a departmental level.

Relevance to Election Commitments / Budget Measures:

The FFWSS program was a 2019-20 Budget Measure (Budget Paper 2). The projects identified in both FFWSS \$22 were 2019 Election Commitments.

Sensitivities:

The Department expects grant recipients to seek clarification on timing of grant funding once they receive your letter confirming transfer of FFWSS s22 to the Health Portfolio.

In relation to the funding allocated to Petrie (\$2 million) the Department is waiting on advice from your office about the use of these funds in this electorate.

Consultations:

Compliance with Commonwealth Grant Rules and Guidelines:

The Grant Opportunity Guidelines for \$22 FFWS have been drafted to be consistent with the DITCRD \$22 and Sport Australia's Community Sport Infrastructure Grant Guidelines.
