MBS Review

Update, November 2019

Established in 2015, the Medicare Benefits Schedule (MBS) Review Taskforce (the Taskforce) is considering how the more than 5,700 items on the MBS can be better aligned with contemporary clinical evidence and practice, and improve health outcomes for patients. The Taskforce is also identifying whether there are any services that are obsolete, outdated or potentially unsafe.

Updates to the MBS as of 1 November 2019

Reforms to anaesthesia and colonoscopy MBS items and new eating disorder MBS items are in effect from today, 1 November 2019. These changes stem from recommendations made by the Taskforce, including consultation across the sector and discussion with peak groups and representatives.

In addition to these reforms, there are 12 new MBS telehealth items being introduced to address inequities in the provision of health care services. The new items will be available to general practitioners (GPs) and non-specialist medical practitioners and have the potential to deliver improved health outcomes to people living in rural and remote locations.

Stakeholder Forums

Since the last newsletter in September, the Department has supported a number of stakeholder forums and discussions, including:

- A forum for private health insurers and other key stakeholder groups in September 2019 in Melbourne. This forum offered a valuable opportunity for those involved in the administration and claiming of MBS items to understand the 1 November changes for anaesthetics, colonoscopy and for eating disorders. It was well attended, with more than 90 representatives attending this event. It is anticipated these updates will be regularly held in advance of implementation of changes resulting from the MBS Review.
- The Australian Medical Association Western Australia (AMA WA) invited the Department of Health and Taskforce Chair Professor Bruce Robinson to provide an update on the MBS Review in Perth. Sessions ran over two days in October, with separate sessions for GPs and Specialists. Dr Simon Torvaldsen, Chair of the AMA WA Council of General Practice and Chair of the Wound Management Working Group, introduced Professor Bruce Robinson at the GP breakfast session, which was well attended. The Department looks forward to future opportunities to engage with stakeholders on the progress of the Review.
