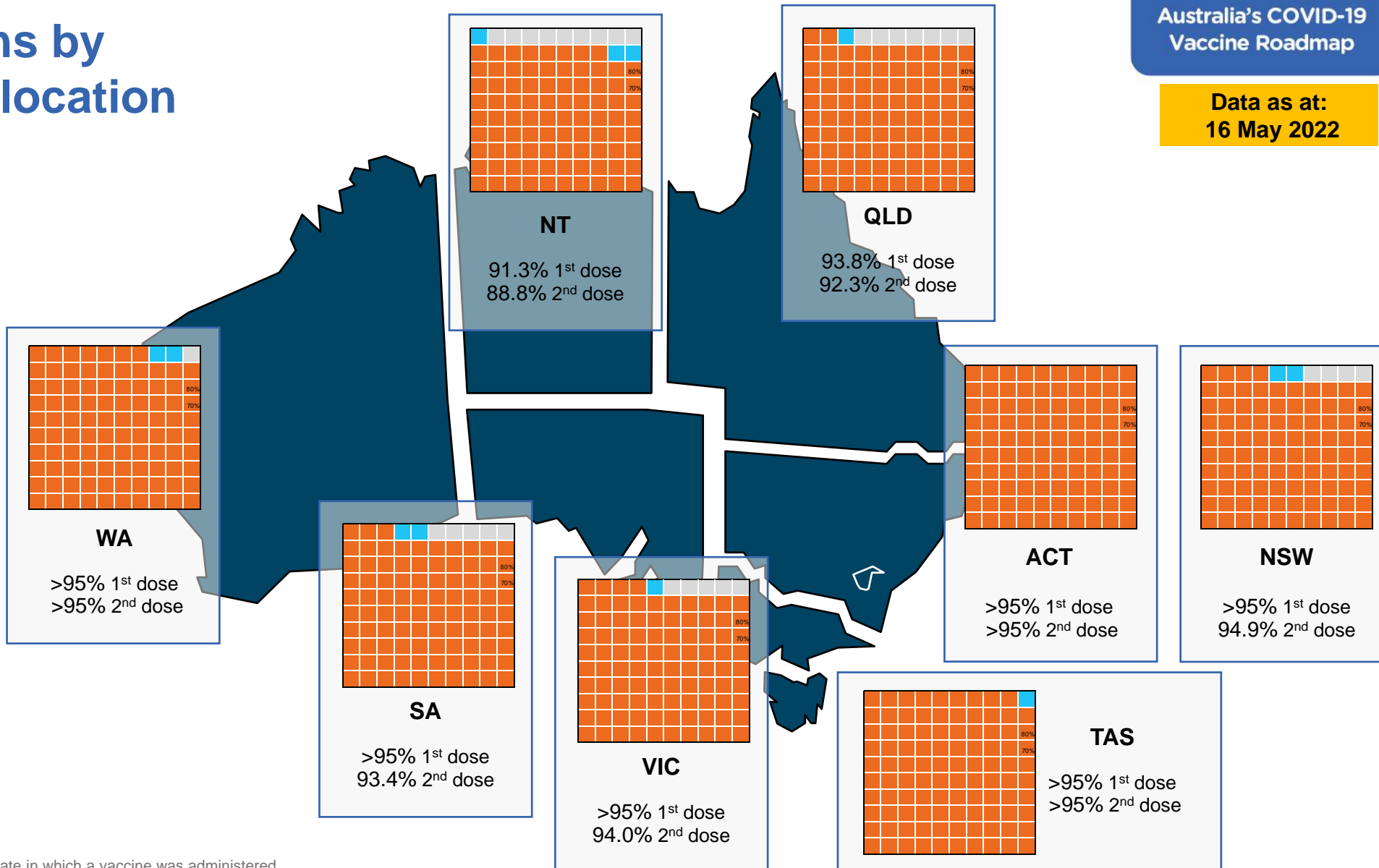

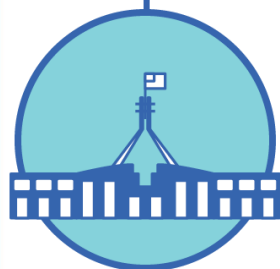

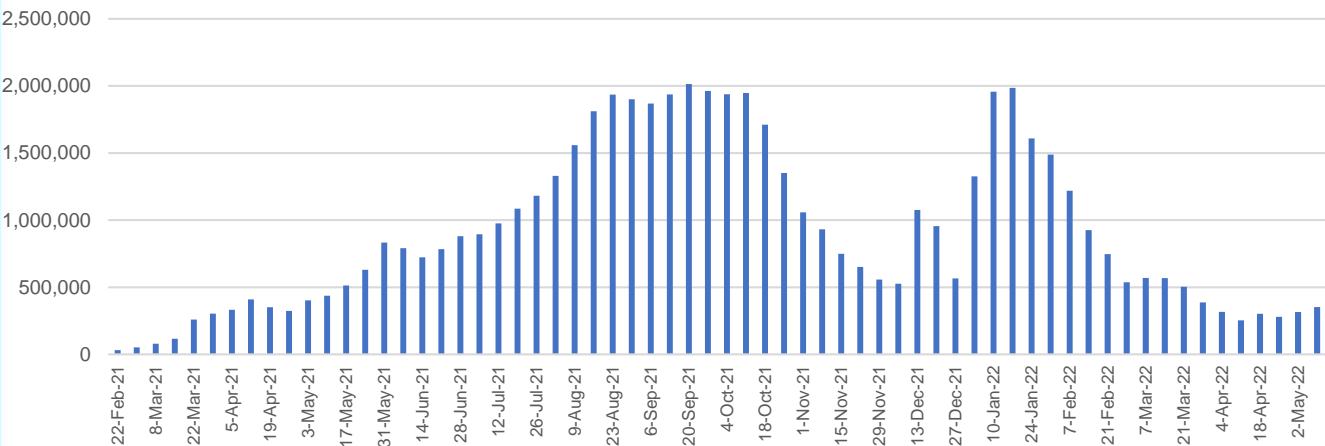

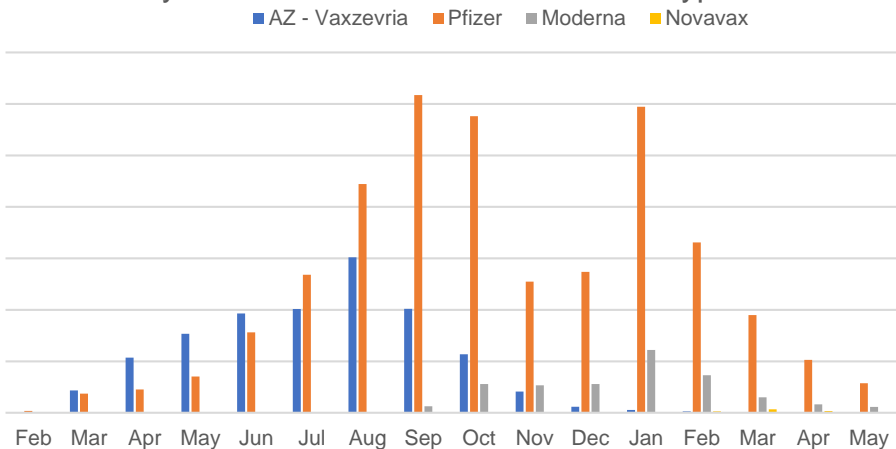

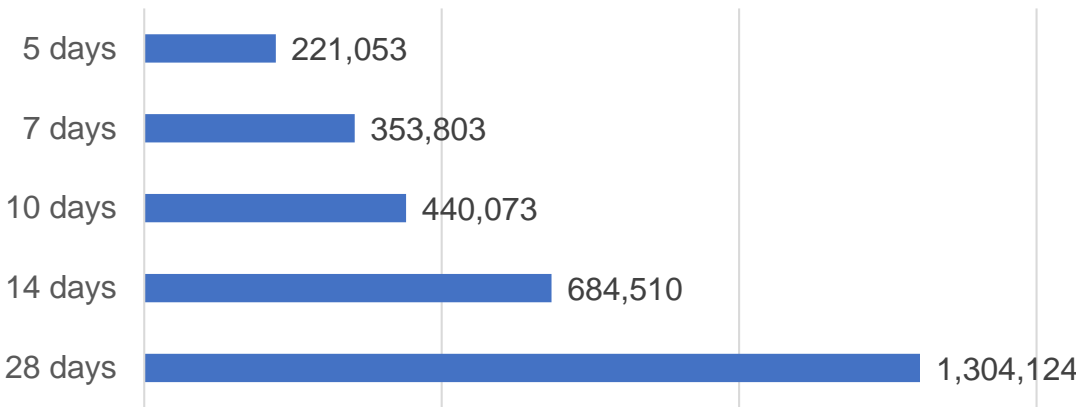
Doses Administered by Week



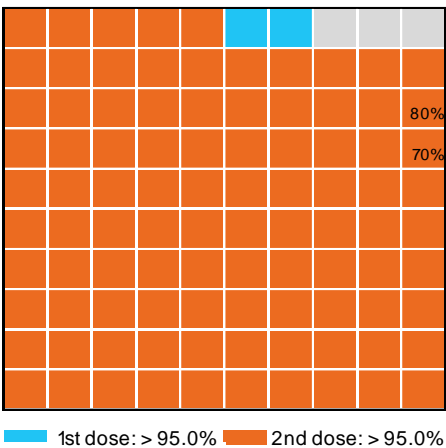
Doses by administration month and vaccine type

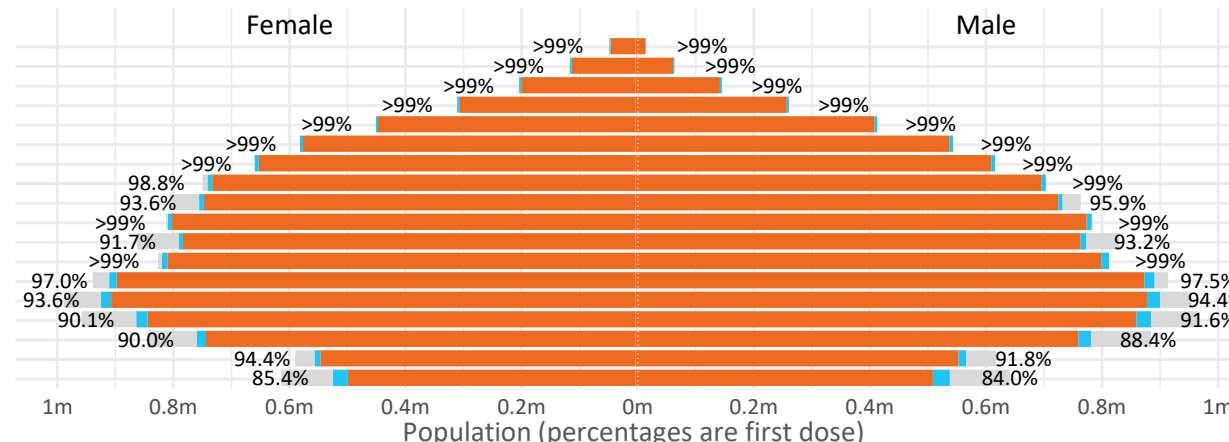

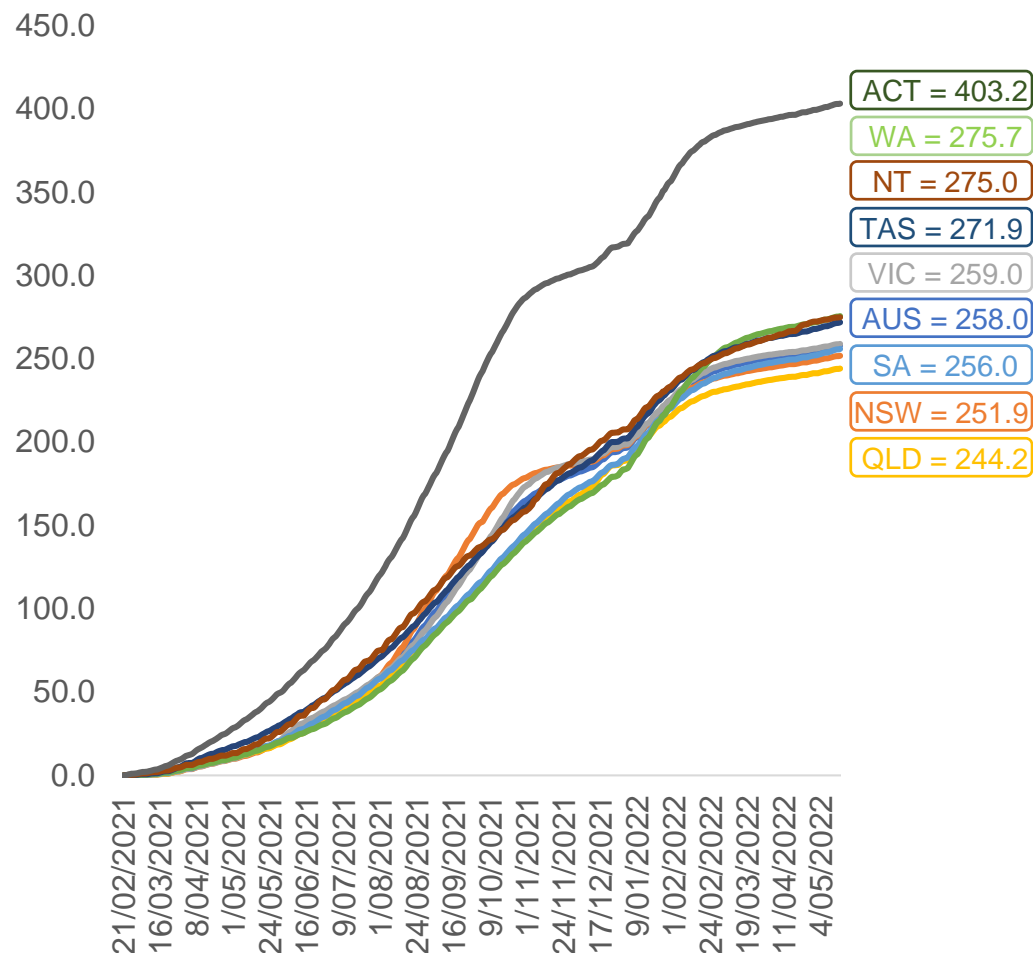

Cumulative total doses administered vs eligible state populations\*

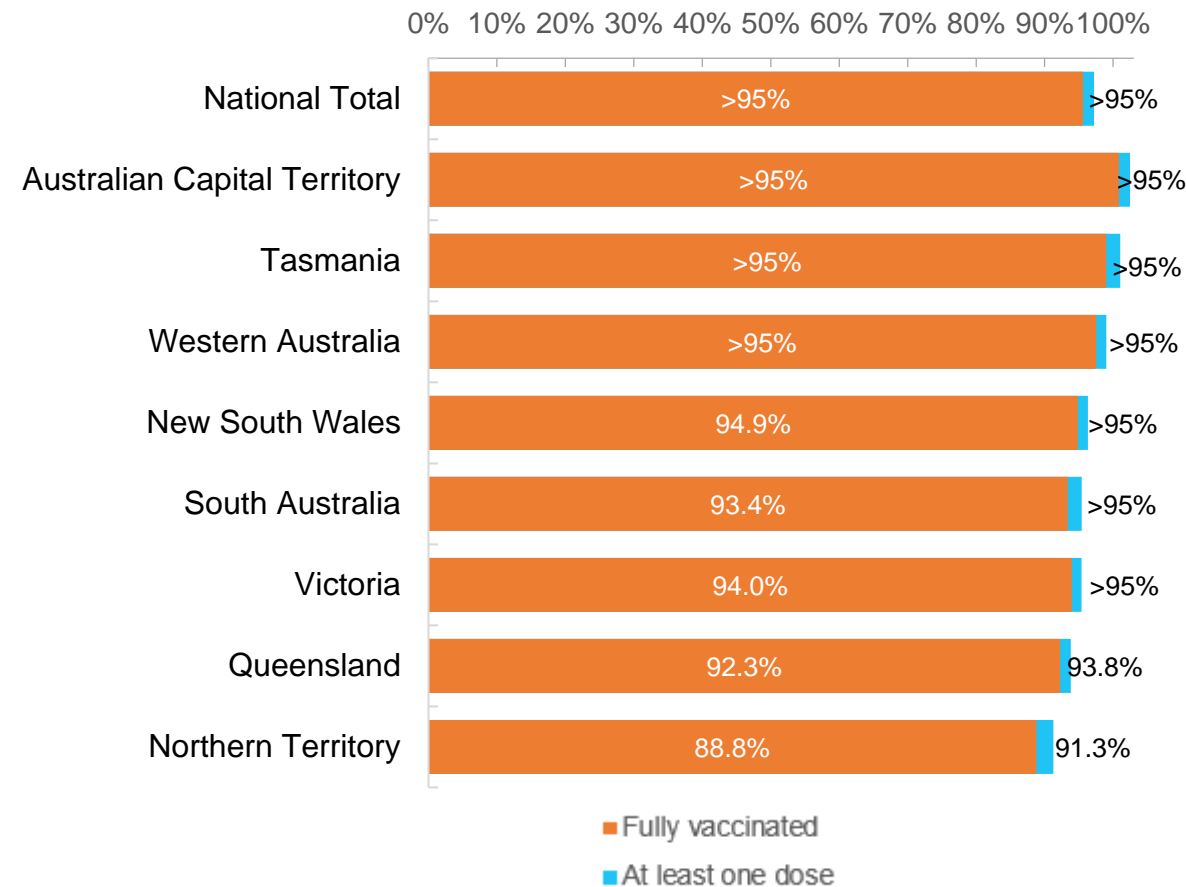

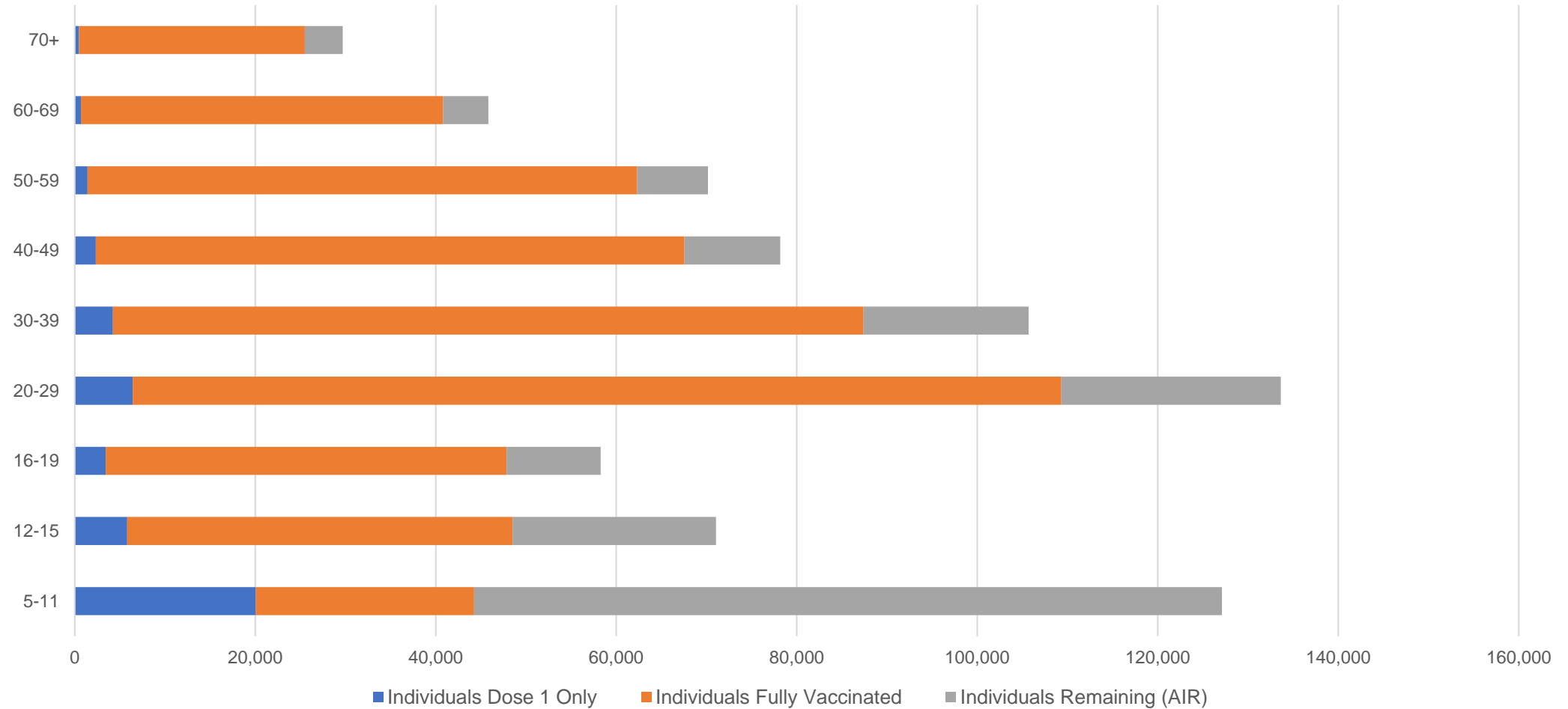

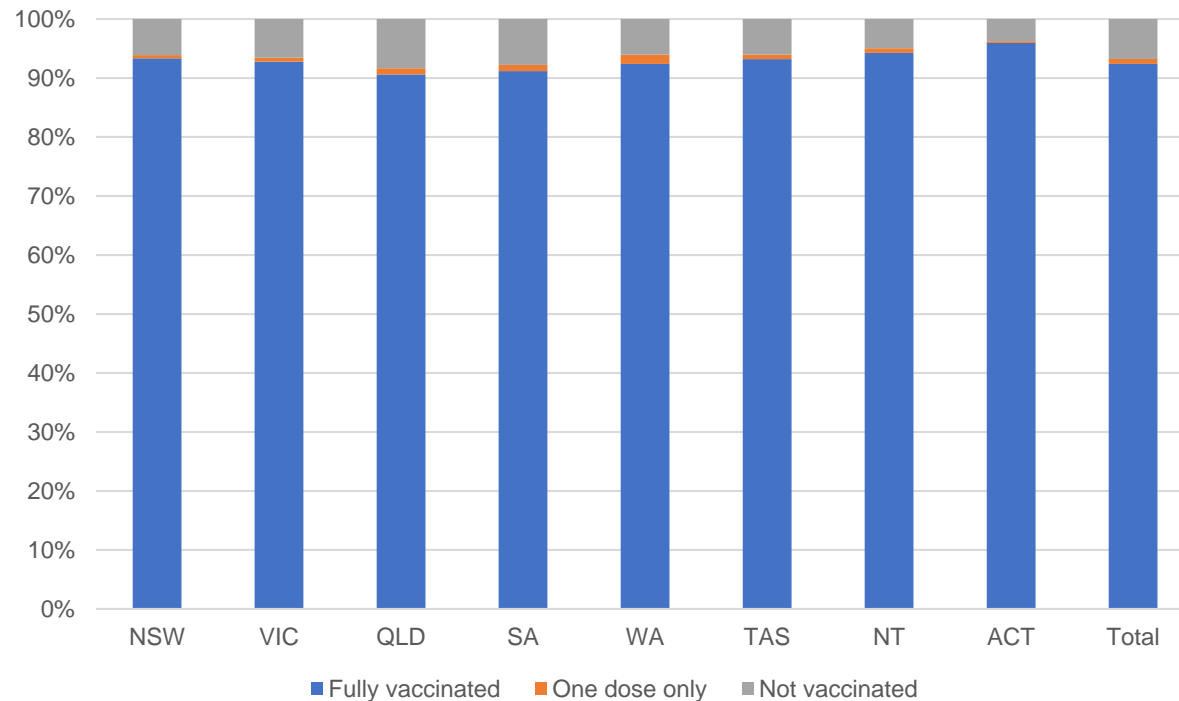

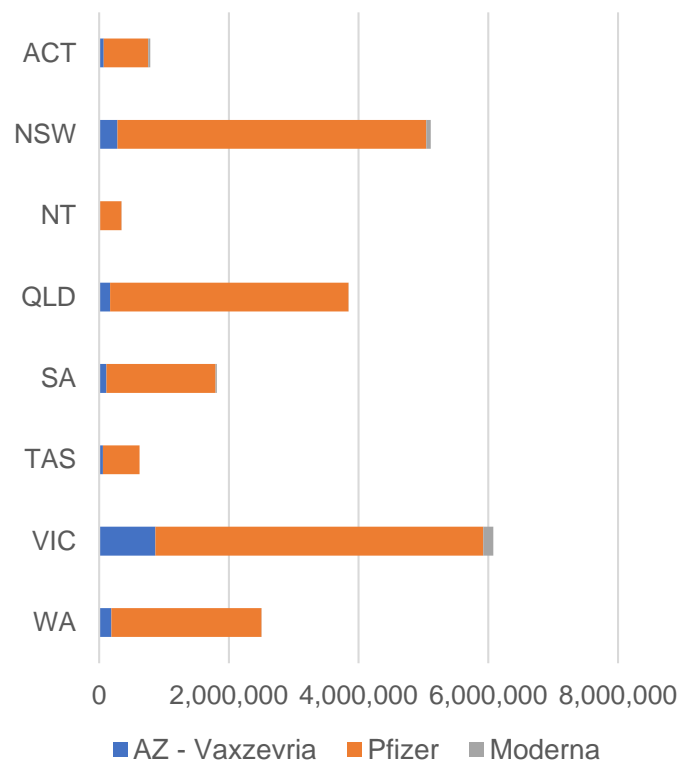

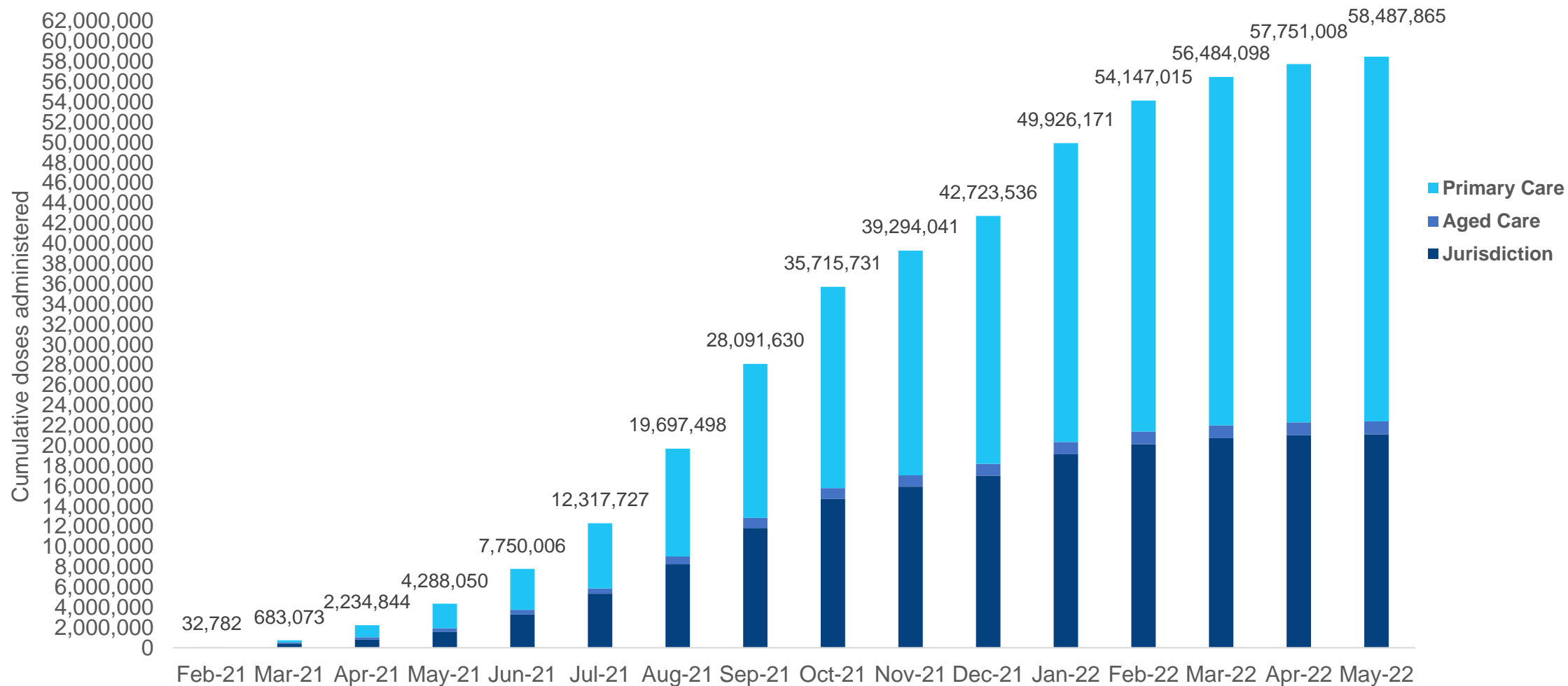

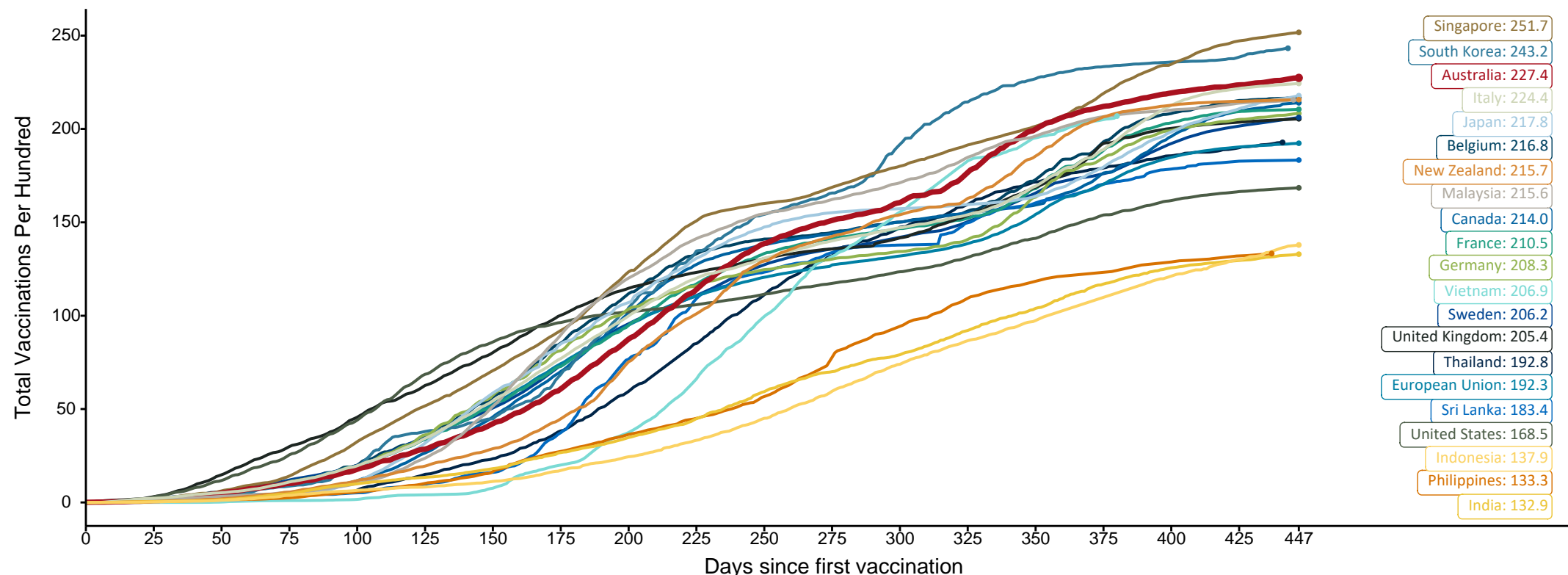

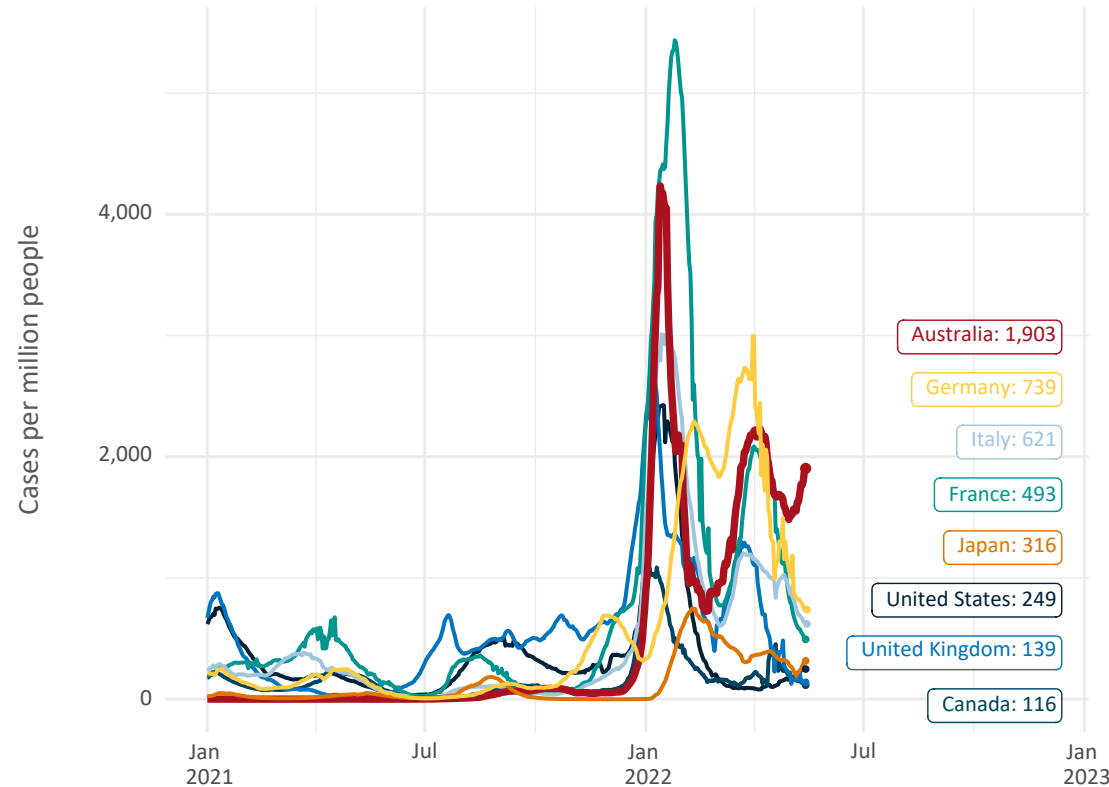

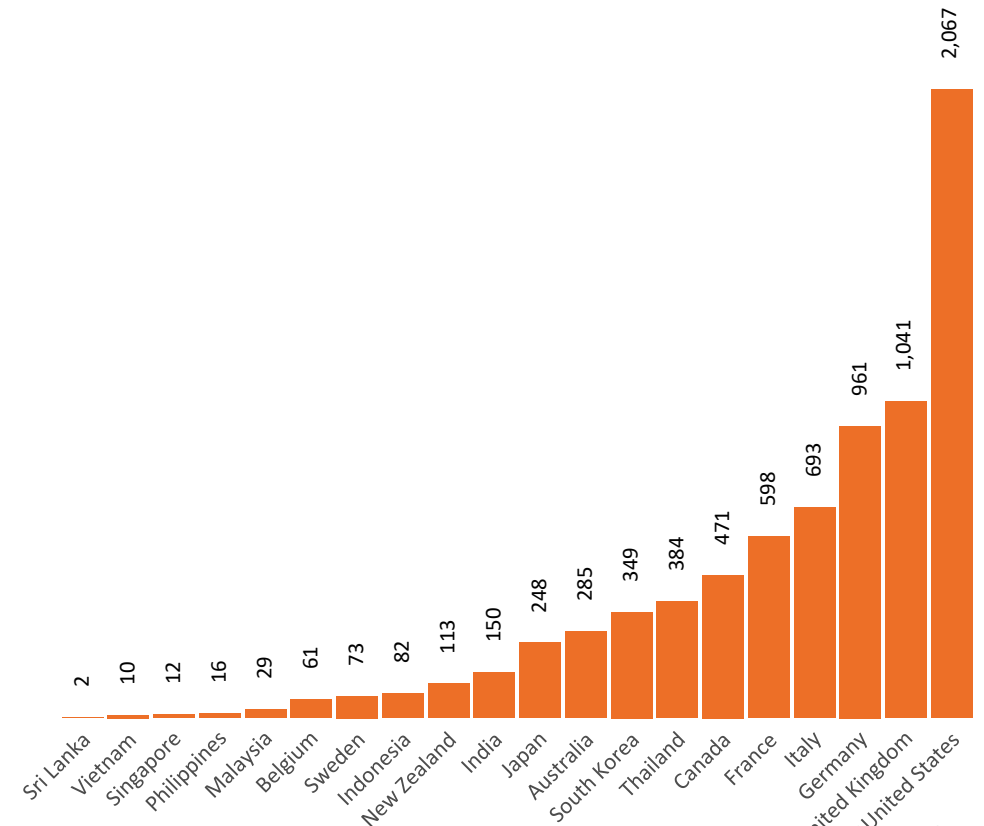
