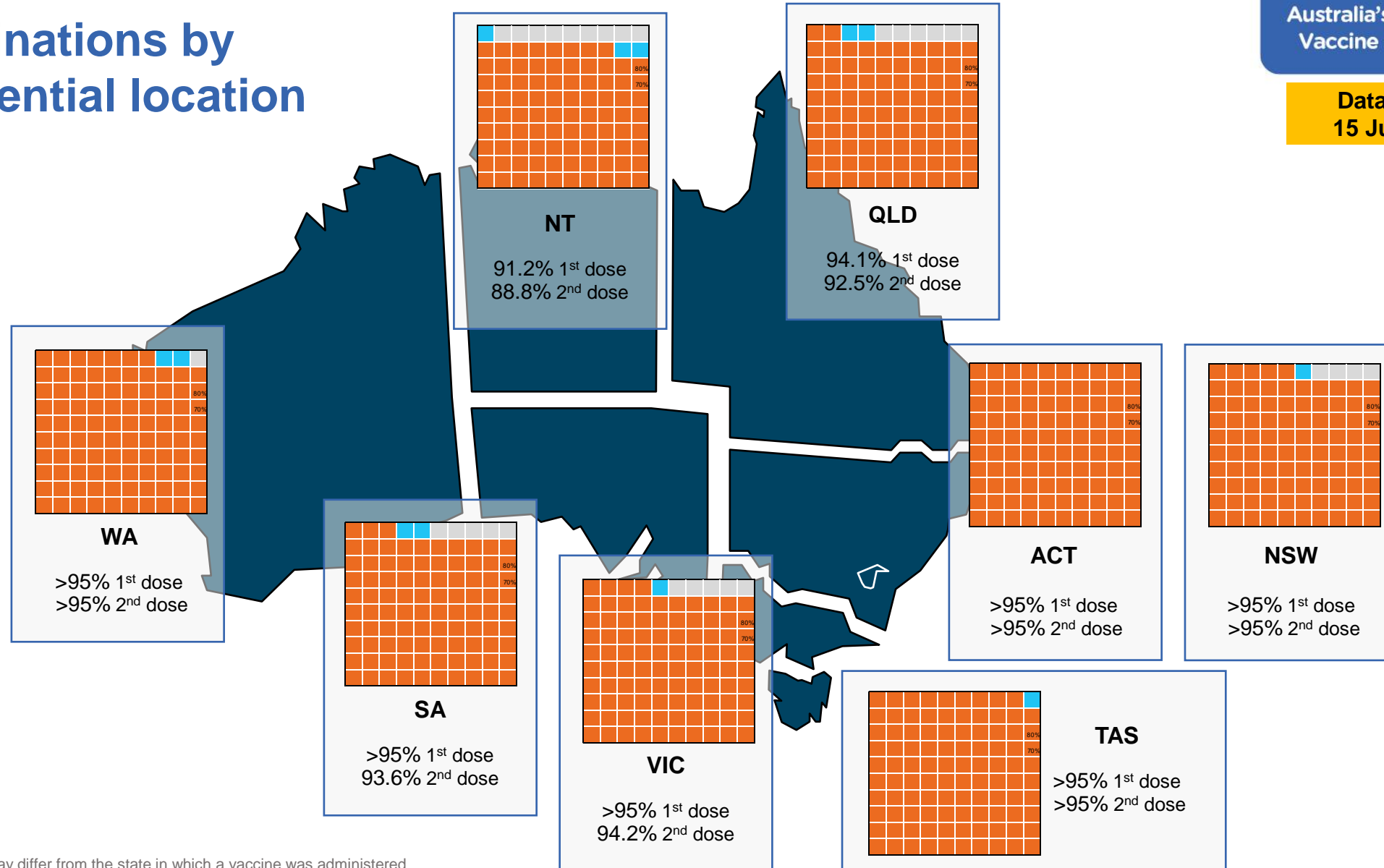

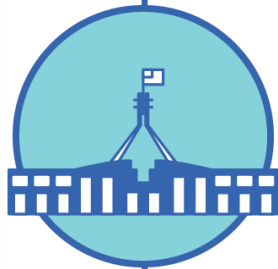

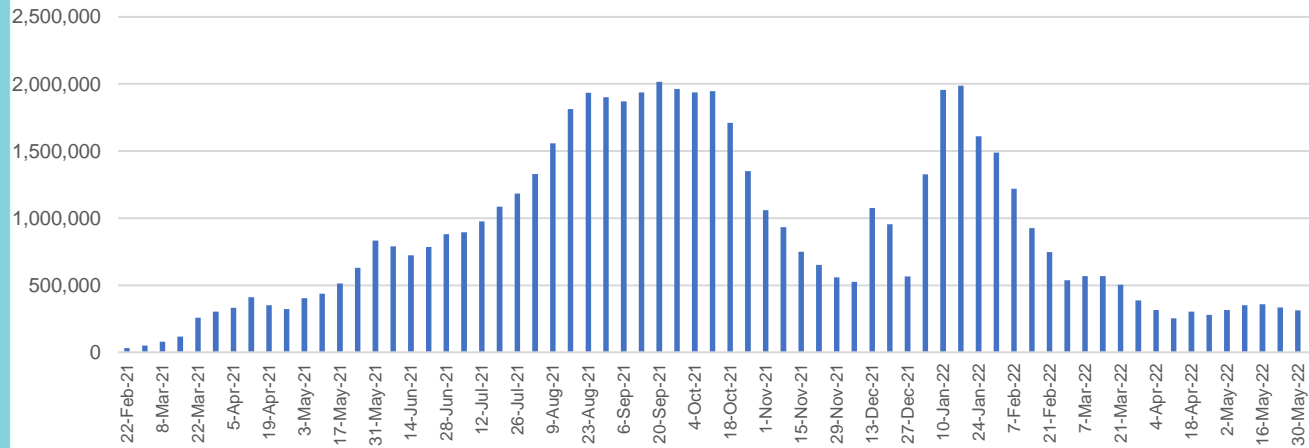

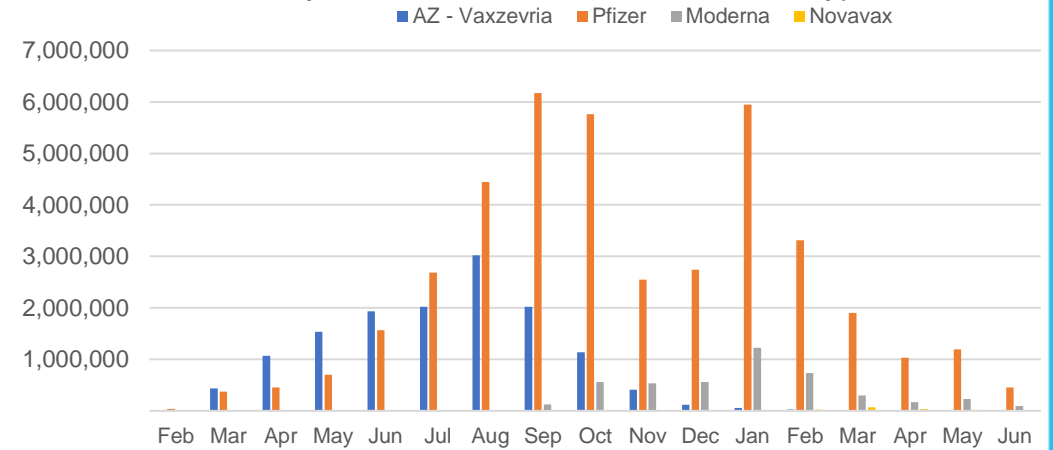

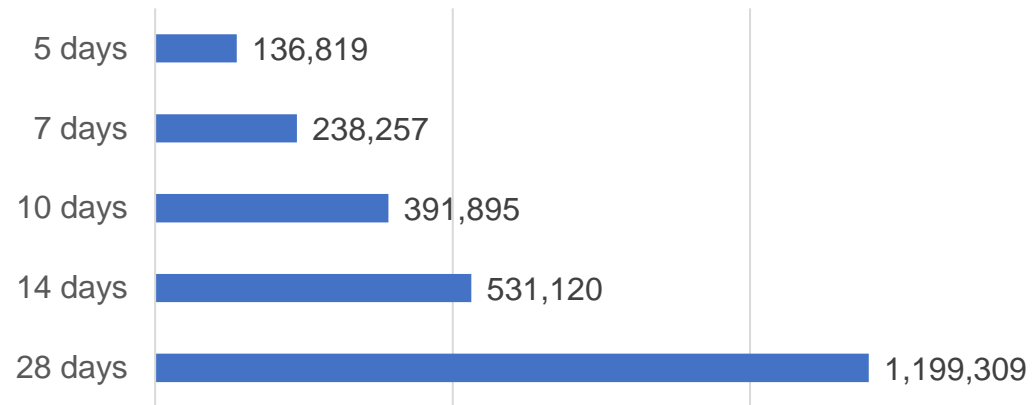
Doses Administered by Week



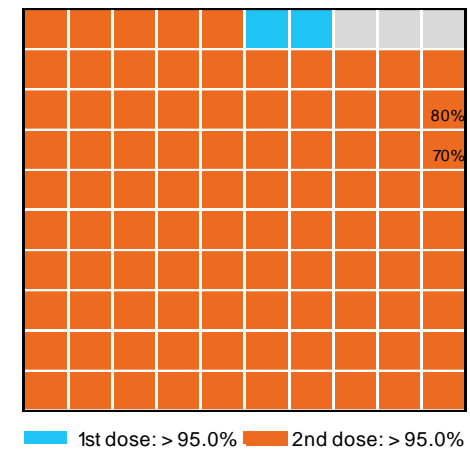
Doses by administration month and vaccine type

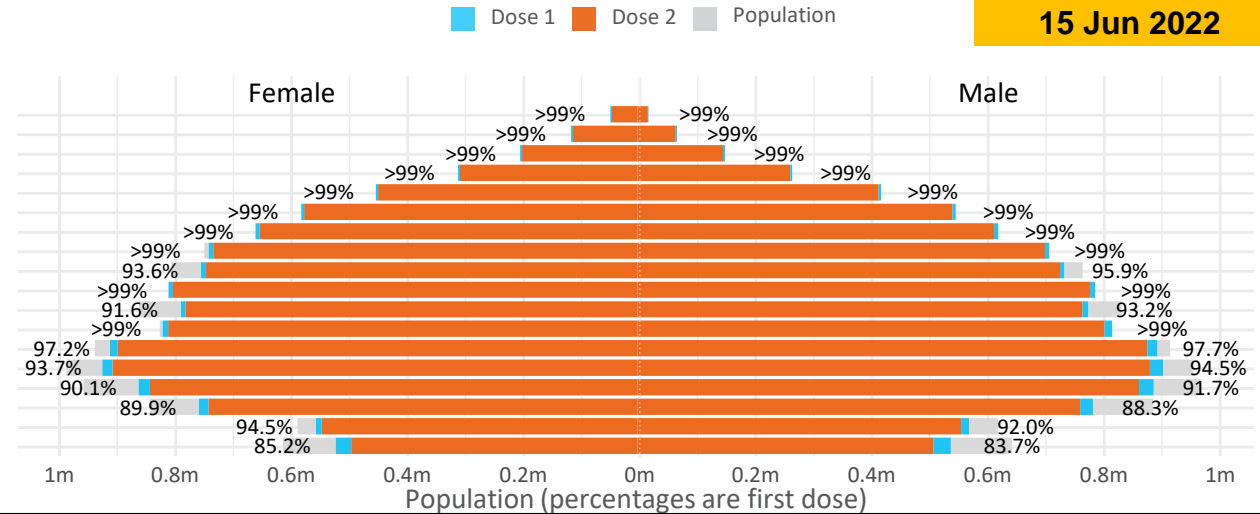

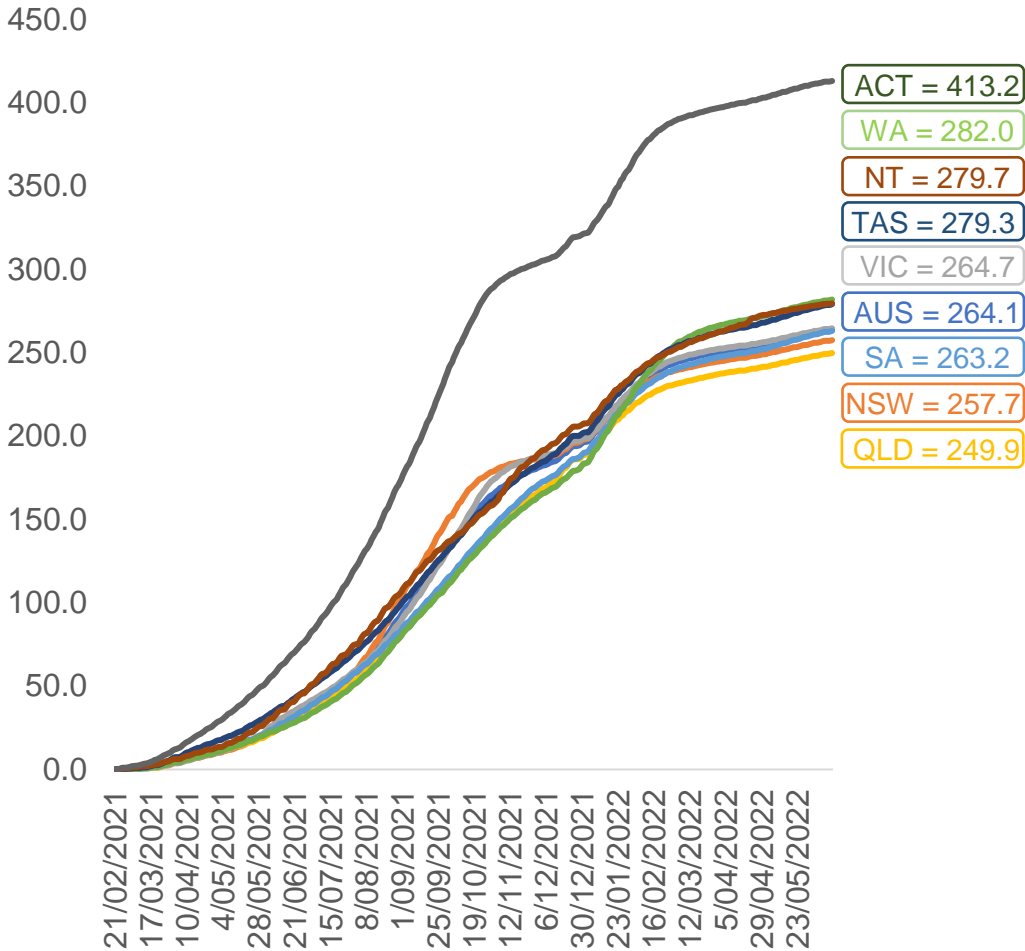

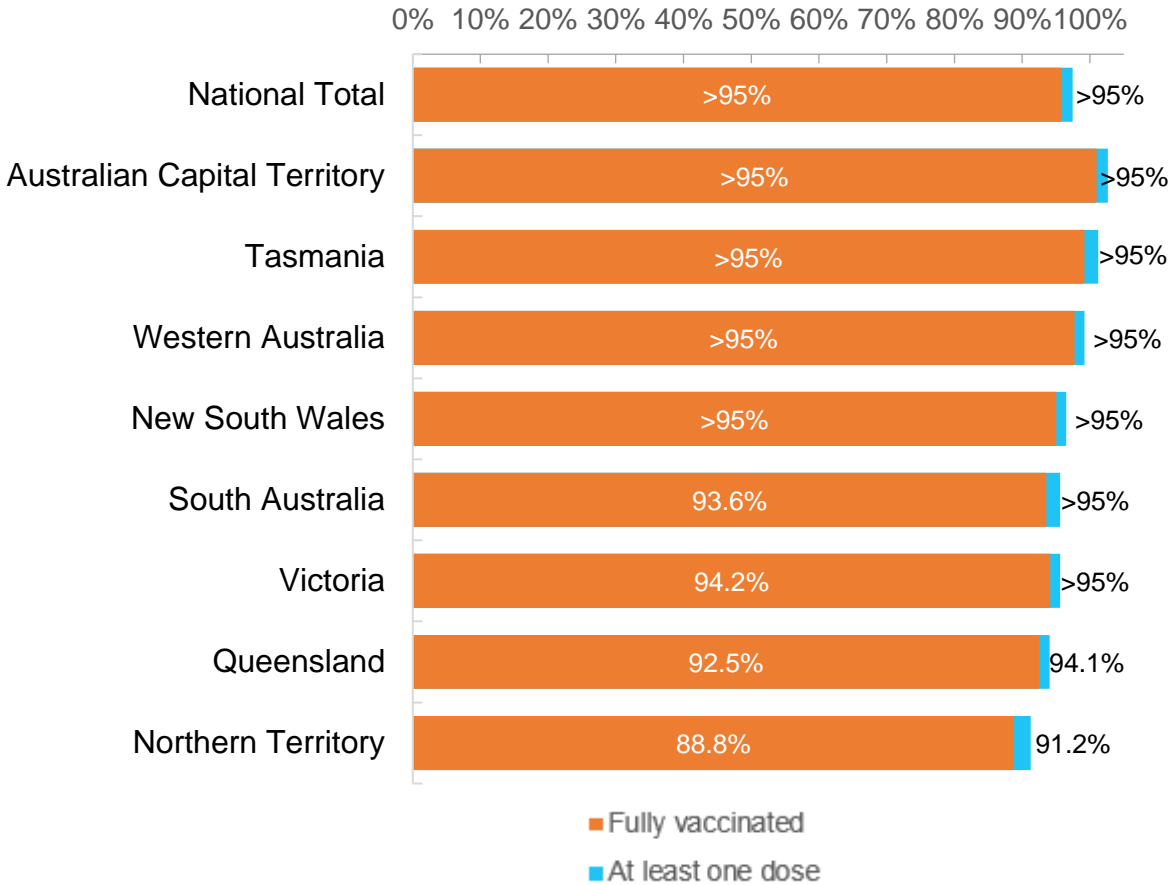
# Vaccinations by location

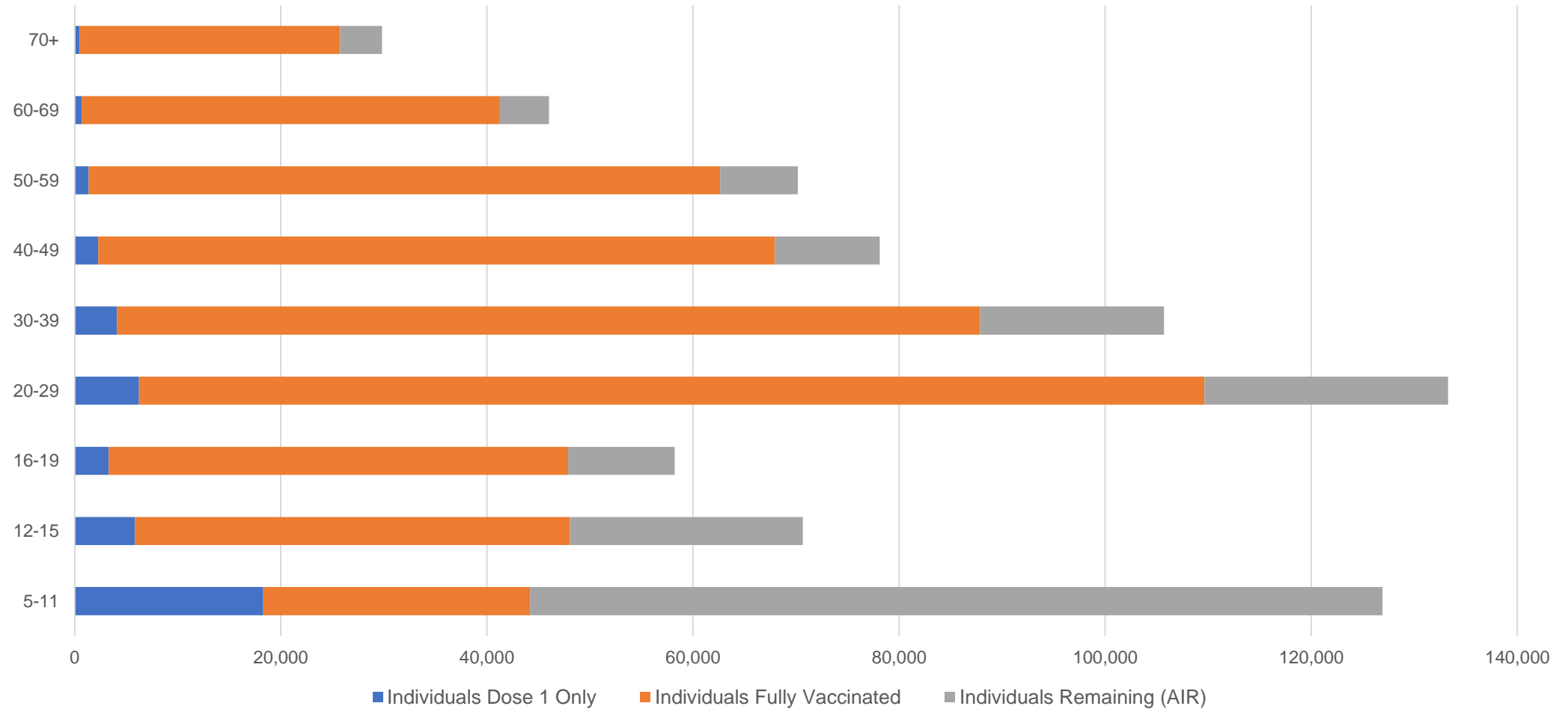

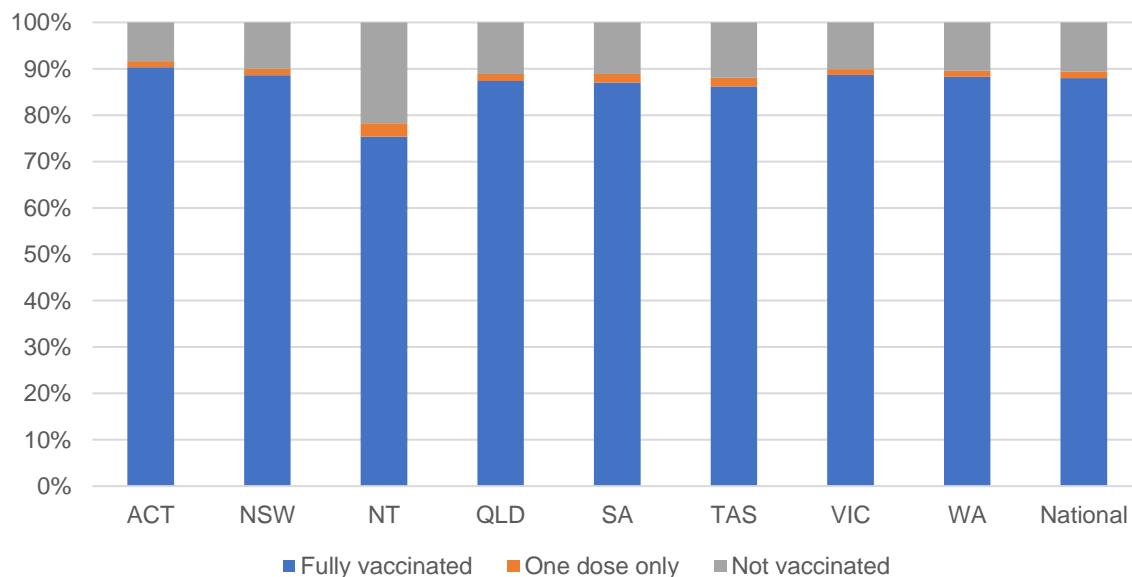

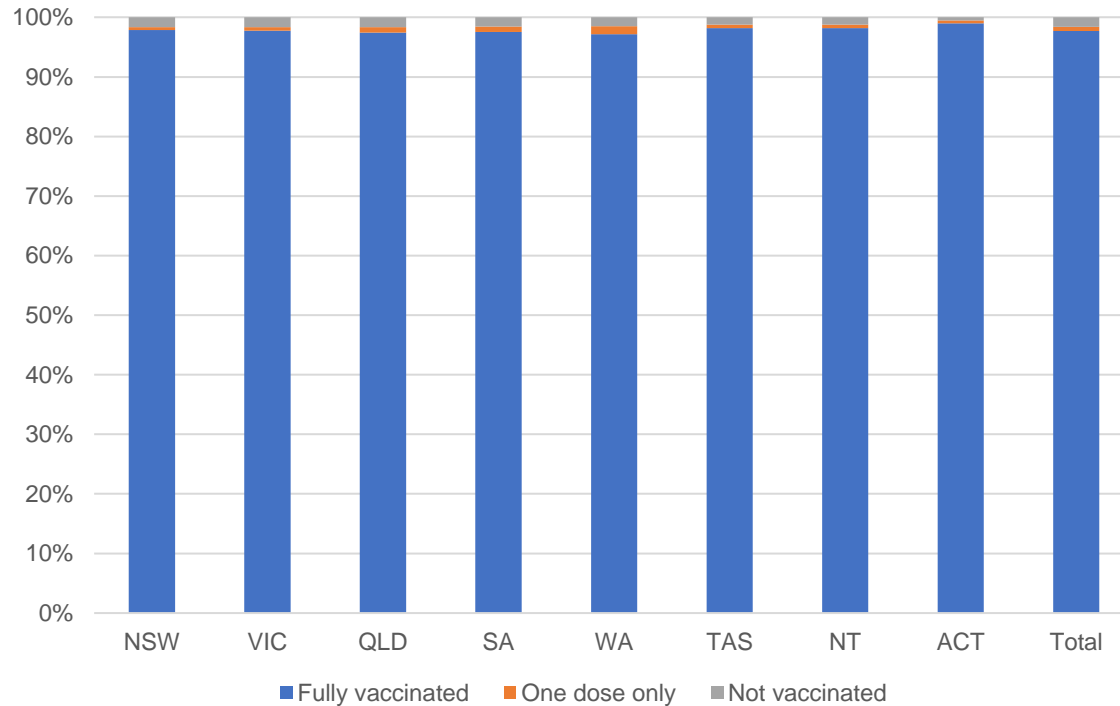

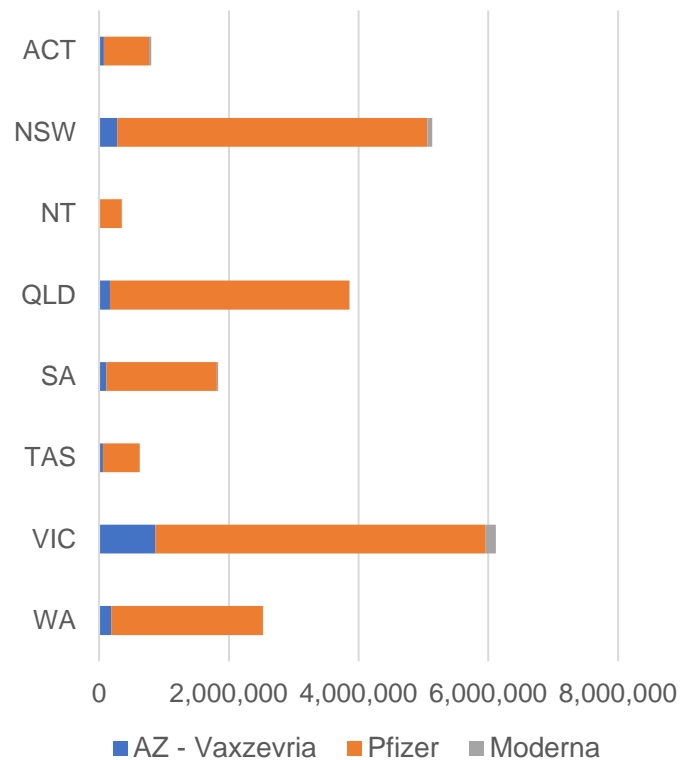

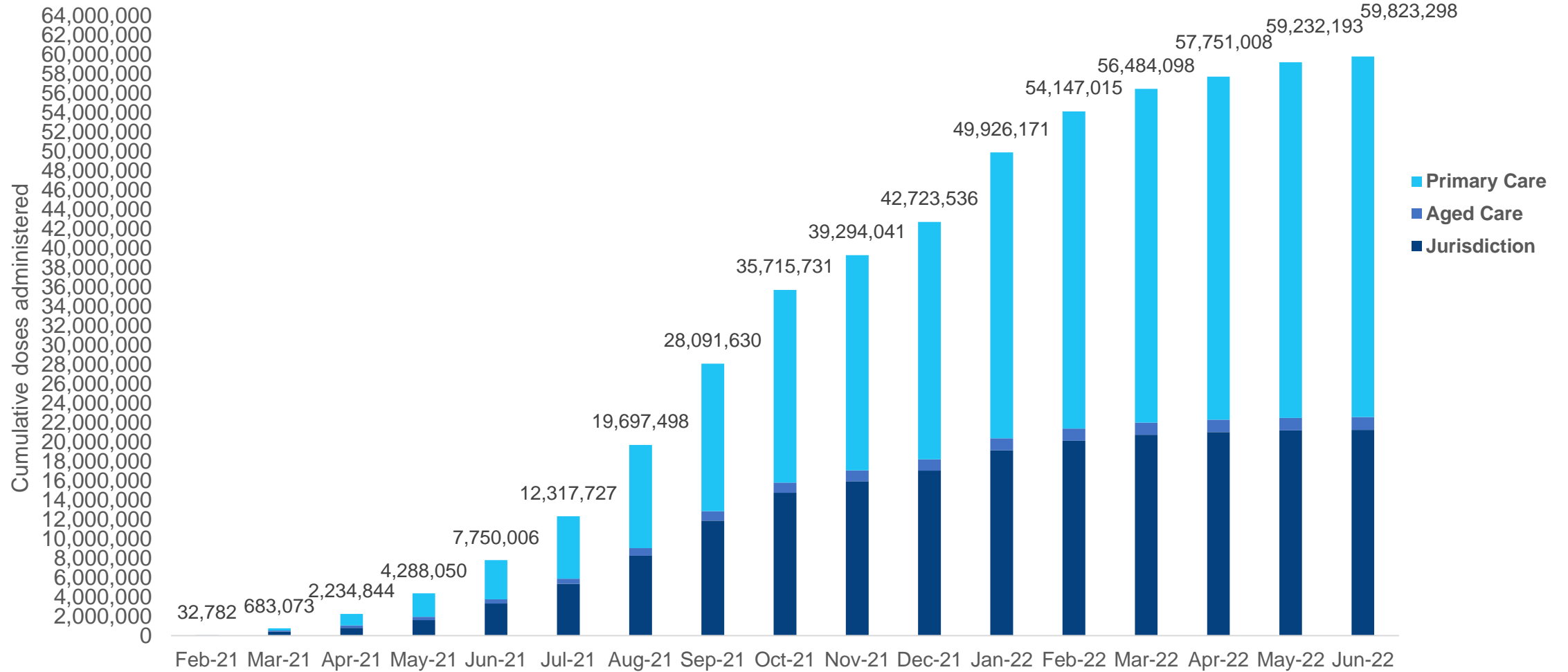

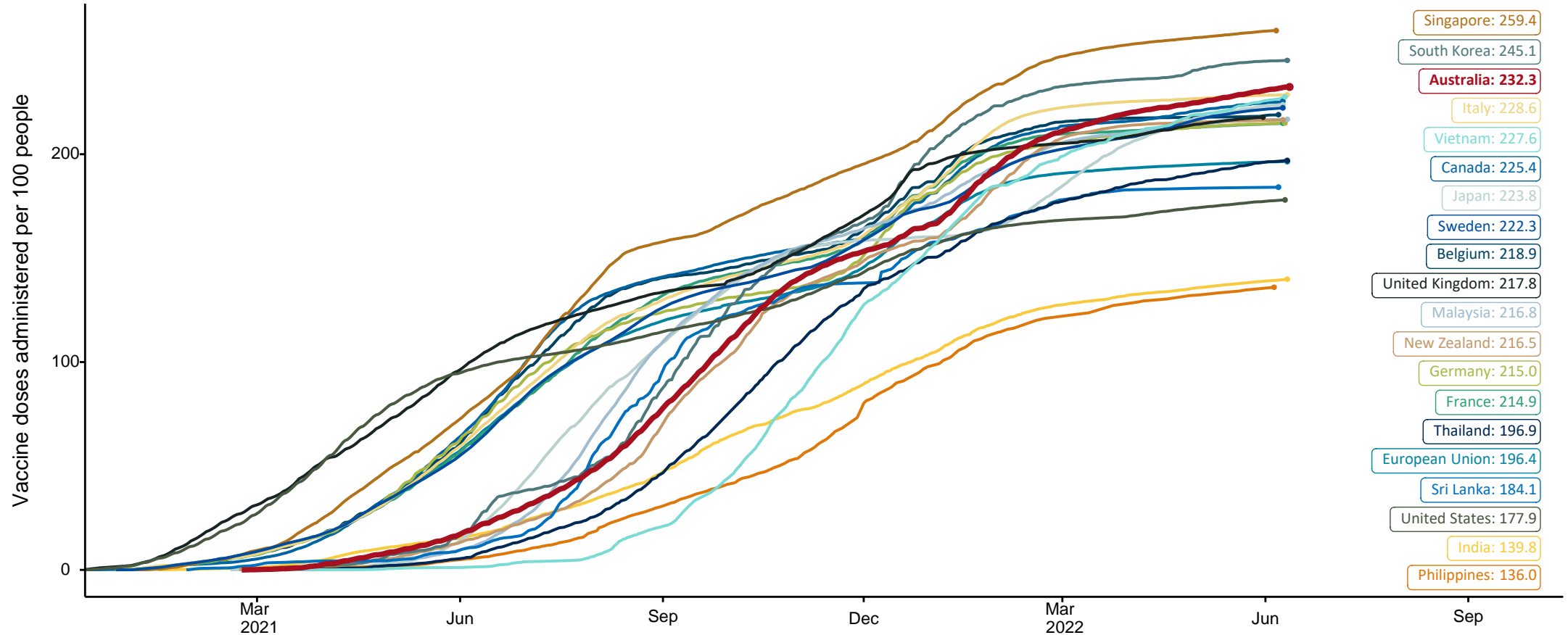
# Cumulative doses administered by channel

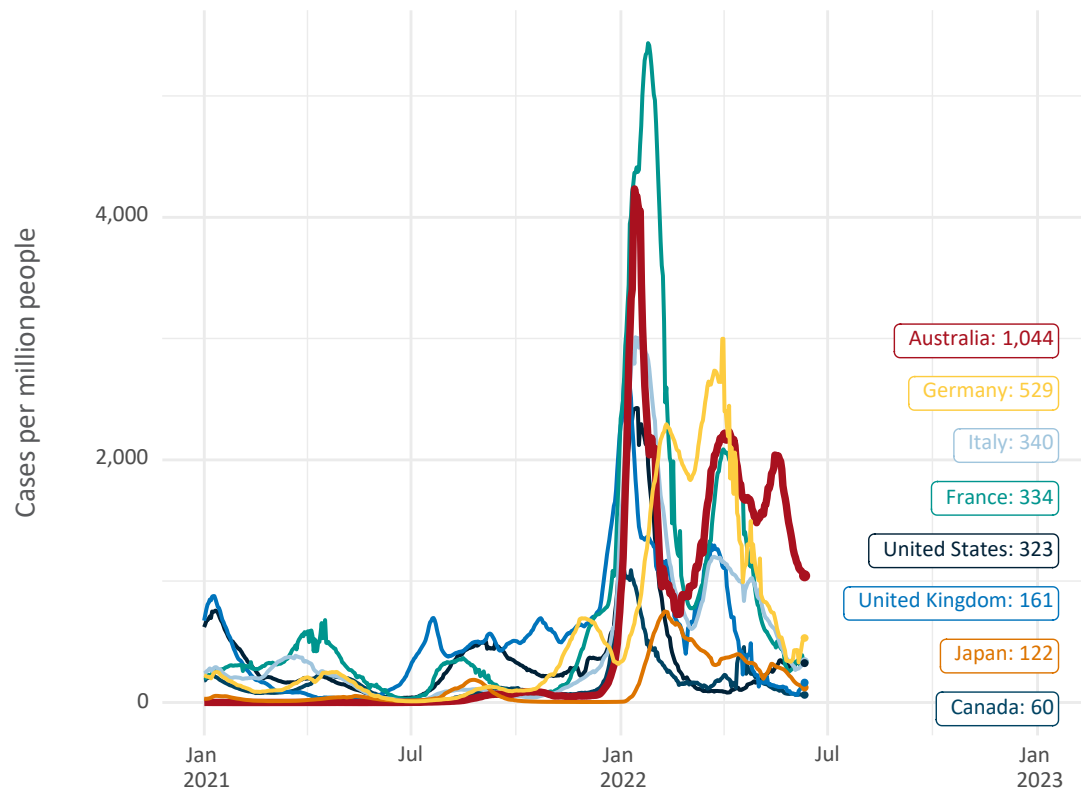

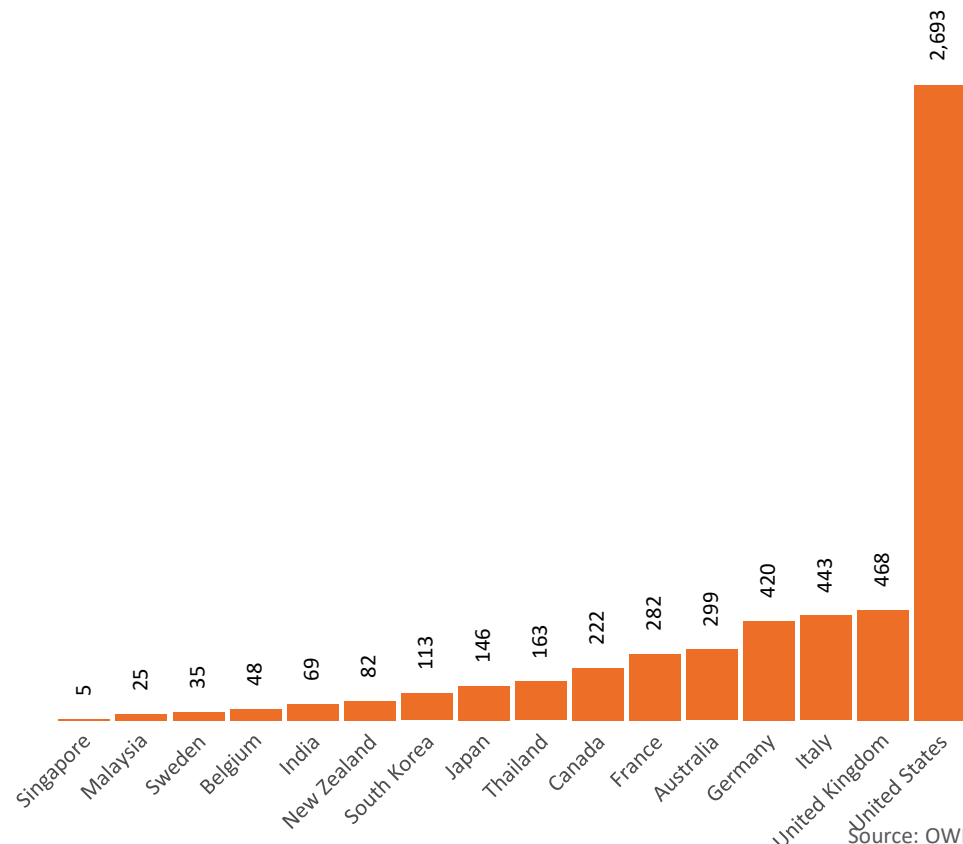
