BACKGROUND

- In June 2018 the Department provided \$150,000 (GST exclusive) to RMCG to provide a report into the economic impact of recreational shooting in Australia.
- Specifically, RMCG has been contracted to conduct research and provide a report on the following:
 - 1. The economic activity associated with recreational shooting. This will be reported in terms of Gross State Product/Gross Domestic Product and jobs. Indirect (flow-on) impacts will be included. National results will include consideration of substitution effects, using CGE assumptions (within an input-output model). Results will be reported for each state/territory and Australia overall. This is the economic 'footprint' of hunting activity in Australia.
 - 2. The impact of recreation shooting on health and wellbeing activity.
 - 3. The social and mental benefits that shooters experience as a result of participating in shooting.
 - 4. Demographic information on shooters.
- The report is due for submission to the Department in June 2019.
- The contract with RMCG is being managed by the Department.
- RMCG's services were procured directly. The procurement was exempt from a tender process under *Appendix A: 6. Procurement of research and development services* of the Commonwealth Procurement Rules due to the research nature of the project. This exemption was used 12 times by the Department of Health in 2017/18.
- It is common for the Australian Government to conduct economic impact assessments for certain sectors. For example:
 - Intergenerational Review of Australian Sport (2017);
 - The Economic Impact of Improving Schooling Quality (2017); or
 - The Societal Costs of Alcohol Misuse in Australia (2012).
