Product: Coloplast SenSura Mio One-Piece Shallow Convexity Drainable **Applicant:** Coloplast Pty Ltd **Date of Meeting:** 26 April 2022

1. Proposed Variation on the Stoma Appliance Scheme

The applicant, Coloplast, sought the addition of 2 variants to the current listing of the Coloplast SenSura Mio One-Piece Shallow Convexity Drainable (SAS Code 80039N) in subgroup 2(b) of the Stoma Appliance Scheme (SAS) Schedule. The product, including 12 variants, is currently listed at a unit price of \$6.578 which includes a price premium per unit of \$0.205, with a maximum monthly quantity of 30 units.

2. Variants to be added

The applicant requested the following 2 variants be added to the existing listing for SAS Code 80039N.

3. Background

This product was first listed on the SAS Schedule in September 2021.

4. Clinical Place for the Product

Not Applicable.

5. Financial Analysis

Listing 2 additional variants under the current SAS Code 80039N is unlikely to have a budgetary impact for the SAS.

6. SPAP Recommendation

The Panel recommended the addition of 2 variants to the current product range for Coloplast SenSura Mio 1 Piece Shallow Convexity Drainable (SAS Code 80039N) listed in subgroup 2(b) of the SAS Schedule at the unit price of \$6.578 (which includes a price premium of \$0.205 per unit), with a maximum monthly quantity of 30 units. The product codes to be added under the SAS Code 80039N are 13686 and 13687.

7. Context for Recommendation

The Panel provides advice on whether stoma products should be subsidised and, if so, the conditions of their subsidisation in Australia. Applications are considered in this context. Panel advice not to recommend listing or changes to a listing does not represent a final Panel view about the merits of a particular stoma product. A company can resubmit to the Panel following advice not to recommend listing or changes to a listing. The Panel is an advisory committee and as such its recommendations are non-binding on Government. All Panel recommendations are subject to Government approval.
