

## Public summary document

**Product:** Coloplast SenSura Mio One-Piece Soft Convexity Drainable

**Applicant:** Coloplast Pty Ltd

**Date of Meeting:** 26 April 2022

### 1. Proposed Variation on the Stoma Appliance Scheme

The applicant, Coloplast, sought the addition of 2 variants to the current listing of the Coloplast SenSura Mio One-Piece Soft Convexity Drainable (SAS Code 80041Q) in subgroup 2(b) of the Stoma Appliance Scheme (SAS) Schedule. The product, including 8 variants, is currently listed at a unit price of \$6.578 which includes a price premium of \$0.205 per unit, with a maximum monthly quantity of 30 units.

### 2. Variants to be added

The applicant requested the following variants be added to the existing listing for SAS Code 80041Q.

### 3. Background

This product was first listed on the SAS Schedule in April 2016.

### 4. Financial Analysis

Listing 2 variants to the current product range is unlikely to have a budgetary impact for the SAS.

### 5. SPAP Recommendation

The Panel recommended the addition of 2 variants to the current product range for Coloplast SenSura Mio 1 Piece Soft Convexity Drainable (SAS Code 80041Q) listed in subgroup 2(b) of the SAS Schedule at the unit price of \$6.578 which includes a price premium of \$0.205 per unit, with a maximum monthly quantity of 30 units. The product codes to be added under the SAS Code 80041Q are 13688 and 13689.

### 6. Context for Recommendation

The Panel provides advice on whether stoma products should be subsidised and, if so, the conditions of their subsidisation in Australia. Applications are considered in this context.
