

## Public summary document

**Product:** ConvaTec Sur-Fit Natura Urostomy Pouch

**Applicant:** ConvaTec Australia Pty Ltd

**Date of SPAP Meeting:** 26 April 2022

### 1. Proposed Listing on the Stoma Appliance Scheme

The applicant, ConvaTec Australia Pty Ltd, sought listing of one variant of the ConvaTec Sur-Fit Natura Urostomy Pouch in subgroup 7(a) of the Stoma Appliance Scheme (SAS) Schedule. The product (one variant) was proposed for listing at a unit price of \$3.504, with a maximum monthly quantity of 60 units.

### 2. Comparator

The applicant nominated ConvaTec Sur-Fit Plus (SAS Code 3756Q) as the comparator. The product is currently listed in subgroup 7(a) of the SAS Schedule at the unit price of \$3.504, with a maximum monthly quantity of 60 units. The comparator has 4 variants listed of various ring sizes: 32mm, 38mm, 45mm and 57mm.

### 3. Background

This was the Stoma Product Assessment Panel's (the Panel) first consideration of this product.

### 4. Clinical Place for the Product

The proposed product is an alternative for users requiring a two-piece urostomy pouch.

### 5. SPAP Comment

The Panel note that the sponsor ConvaTec advised a deletion request is to follow for the comparator, ConvaTec Sur-Fit Plus (SAS Code 3756Q). At the time of the deletion request the Panel will require the sponsor ConvaTec to provide information on the impact to patients of a reduced number of variant options of this product range.

### 6. Clinical Analysis

The Panel noted that the proposed product is a replacement for the comparator, Sur-Fit Plus (SAS Code 3756Q) and the sponsor ConvaTec stated that no further clinical evidence is warranted due to the new product being comparable to the predecessor.

### 7. Economic Analysis

The Panel noted that the proposed product is a replacement for the comparator, Sur-Fit Plus (SAS Code 3756Q) and the sponsor ConvaTec stated that no economic analysis is required due to the new product being comparable to the predecessor.

### 8. Financial Analysis

Listing of this product unlikely to have a budgetary impact for the SAS.

### 9. SPAP Recommendation

The Panel recommended that the ConvaTec Sur-Fit Natura Urostomy Pouch be listed in subgroup 7(a) of the SAS Schedule with one variant, at the unit price of \$3.504, with a maximum monthly quantity of 60 units.

### 10. Context for Recommendation

The Panel provides advice on whether stoma products should be subsidised and, if so, the conditions of their subsidisation in Australia. Applications are considered in this context. Panel advice not to recommend listing or changes to a listing does not represent a final Panel view about the merits of a particular stoma product. A company can resubmit to the

Panel following advice not to recommend listing or changes to a listing. The Panel is an advisory committee and as such its recommendations are non-binding on Government. All Panel recommendations are subject to Government approval.
