

## Public summary document

**Product:** Omnigon KomfortLite Support Belt

**Applicant:** Omnigon Pty Ltd

**Date of SPAP Meeting:** 26 April 2022

### 1. Proposed Listing on the Stoma Appliance Scheme

The applicant, Omnigon Pty Ltd, sought listing of the Omnigon KomfortLite Support Belt in subgroup 9(h) of the Stoma Appliance Scheme (SAS) Schedule. The product (10 variants) was proposed for listing at a unit price of \$71.01, with a maximum annual quantity of 3 units.

### 2. Comparator

The applicant nominated Omnigon Stoma Support Belt (SAS Code 3858C) as the comparator. The product is currently listed in subgroup 9(h) of the SAS Schedule at the unit price of \$71.01, with a maximum annual quantity of 3 units. The Panel noted the nominated comparator has a restriction (R2) indicating no increase in the annual allocation can be granted.

### 3. Background

This was the Stoma Product Assessment Panel's (the Panel) first consideration of this product.

### 4. Clinical Place for the Product

The proposed product is an alternative for users requiring a support belt.

### 5. Clinical Analysis

The Panel noted that the proposed product is a replacement for the comparator, Omnigon Stoma Support Belt (SAS Code 3858C) and the sponsor Omnigon stated that the product was easier to use with internal and external pockets. No further clinical evidence is warranted due to the new product being comparable to the predecessor.

### 6. Economic Analysis

The Panel noted that the proposed product is a replacement for the comparator, Omnigon Stoma Support Belt (SAS Code 3858C) at the same price as the nominated comparator. The product was accepted as being non-inferior to the comparator and as the request was for the benchmark price, no economic analysis was required.

### 7. Financial Analysis

Listing of this product is unlikely to have a budgetary impact for the SAS

### 8. SPAP Recommendation

The Panel recommended that the Omnigon KomfortLite Support Belt be listed in subgroup 9(h) of the SAS Schedule with 10 variants, at the unit price of \$71.01, with annual quantity of 3 units. The product will be listed with a R2 restriction.

### 9. Context for Recommendation

The Panel provides advice on whether stoma products should be subsidised and, if so, the conditions of their subsidisation in Australia. Applications are considered in this context. Panel advice not to recommend listing or changes to a listing does not represent a final Panel view about the merits of a particular stoma product. A company can resubmit to the Panel following advice not to recommend listing or changes to a listing. The Panel is an

advisory committee and as such its recommendations are non-binding on Government. All Panel recommendations are subject to Government approval.

**10. Applicant's Comment**

The applicant noted the SPAP recommendation.
