



Minutes for the RIGG group

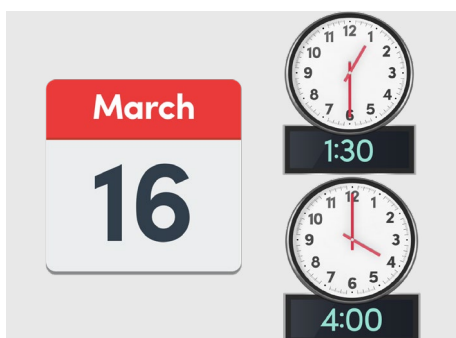


These are the minutes from the Roadmap Implementation Governance Group meeting.

He talked about keeping information private.



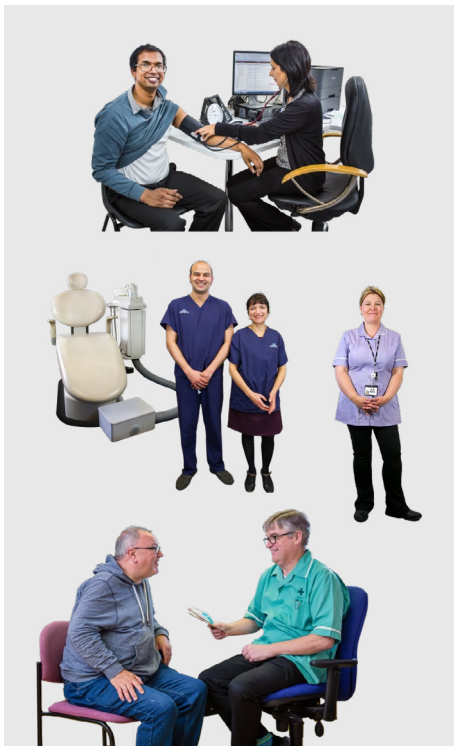
He asked if anyone had a conflict of interest.

- Local doctor
- Dentist
- Pharmacist
- Physiotherapist
- Community health nurse



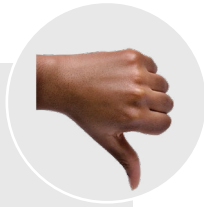
We wanted to know how you feel about going to your primary care workers.

You like it when your health worker

- Listens to you
- Treats you with respect



You do not like it when your health worker talks to your support person and not to you.



Some health workers did not

- Listen to what you said
- Understand your needs



You want more time to tell them about your health needs.



You want health workers to explain what will happen.



You want more help to get the right health care.

We talked about the Primary Care Enhancement Program.

We say **PCEP** for short.

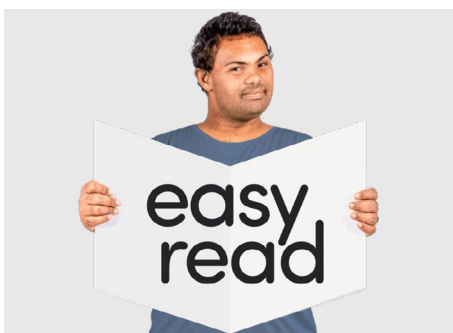


PCEP is being done by

- Department of Health
- Council for Intellectual Disability
- Primary Health Networks.



The goal of PCEP is to make better health care for people with intellectual disability.



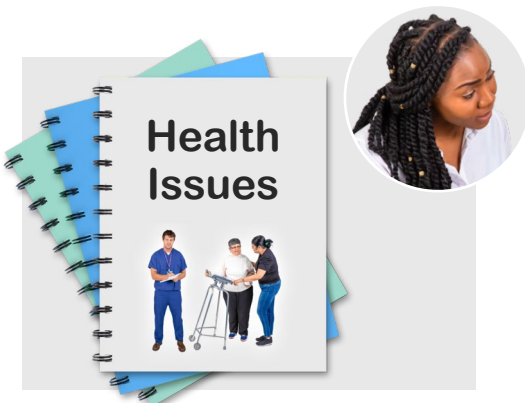
We made information for people with intellectual disability.



We also made some information and training for health workers.



A health worker and a person with intellectual disability will give the training together.



The health worker will talk about health issues for people with intellectual disability.



The person with intellectual disability will talk about how it is for them when they see health workers.



We asked for ideas about how to tell people about the PCEP training.



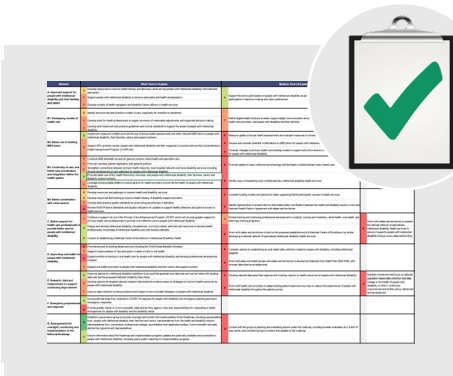
RIGG members had a lot of good ideas like

Roadmap

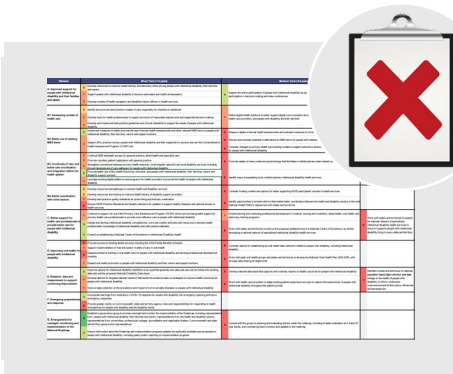


We talked about activities being done in the Roadmap.



The Department of Health made the dashboard.

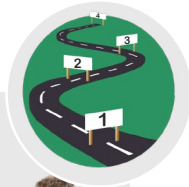
The **dashboard** is a way of showing what is already being done.



It also shows what is not being done yet.



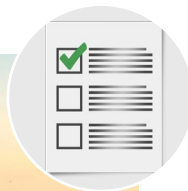
Members said it is a good way to show these things.

Rural and regional areas are areas outside the big cities.



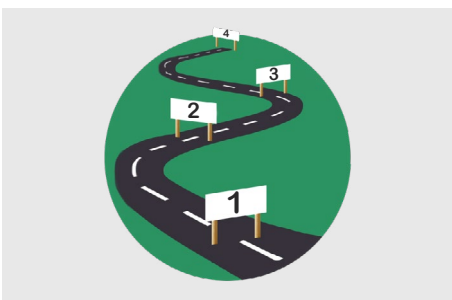
We need organisations to work with us on making the Roadmap happen.

It will help us choose what to do next.



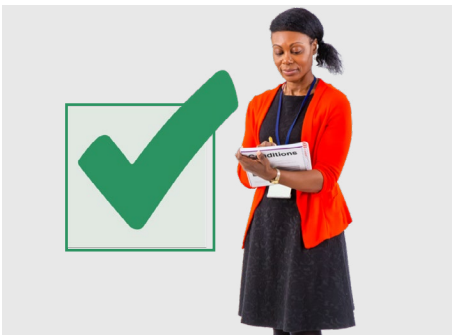
We need to think about good things already being done.

We should think about how they could work together.



We talked about **evaluation**.

Evaluation is checking if what we have done is working.



We need to find ways to check if people with intellectual disability have better health.

State and territory updates

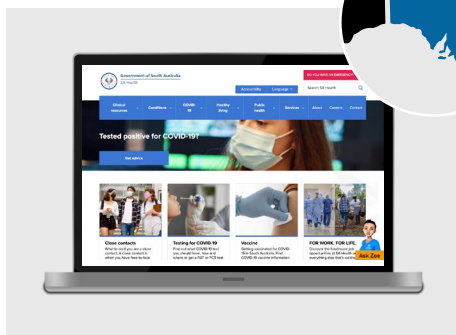


We heard from some of the states and territories.



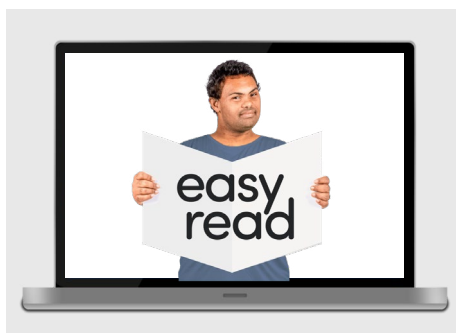
Queensland has a health passport for people with disability if they go to hospital.

It helps them to get the health care they need.



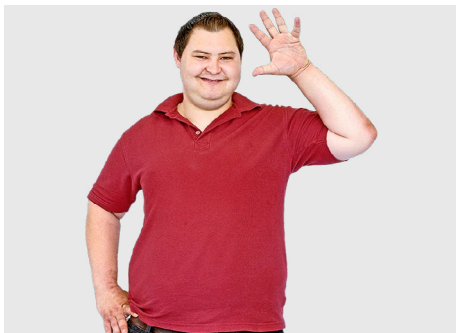
South Australia Intellectual Disability Health Service has a new website.

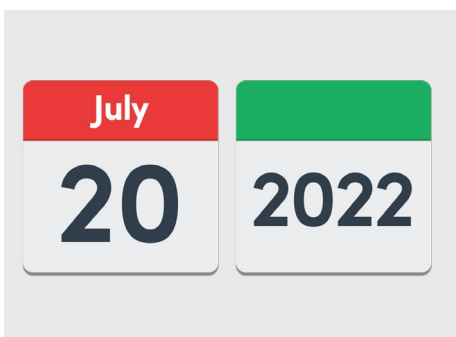


This website has Easy Read information to help people with intellectual disability get health care.
