The National CALD Ageing and Aged Care Strategy Review Survey

Overview

The Australian Government released the *National Ageing and Aged Care Strategy for People from Culturally and Linguistically Diverse (CALD) Backgrounds* (the CALD Strategy) to respond to the needs of older people from CALD backgrounds and better support the aged care sector to deliver care that is sensitive and appropriate to their diverse needs.

Comments are now being sought on the Review of the CALD Strategy and the development of the Diversity Framework.

The CALD Strategy is going to be replaced by a broader Aged Care Diversity Framework aimed to build on existing efforts to provide guidance for providers to embed better practice in their service delivery to better meet the diverse needs of older people.

Under the Diversity Framework, an action plan for CALD consumers will be developed.

Opportunity to have your say

Feedback on the implementation of the CALD Strategy is now being sought.

Why we are consulting

Since the release of the CALD Strategy, there have been reforms in aged care placing a strong emphasis on the concepts of greater choice and control being put in the hands of the consumer and the aged care system being accessible, equitable and inclusive for all older people.

A key mechanism for achieving this is the development of a new Diversity Framework for aged care, which is scheduled to be in place by the end of 2017, followed by the creation of a specific action plan for older people from CALD backgrounds. One of the building blocks for the development of this Diversity Framework and Action Plan will be reviews of the Government's progress against the CALD Strategy.

National Ageing and Aged Care Strategy for People from Culturally and Linguistically Diverse (CALD) Backgrounds - Principles

The Strategy is based on the following 5 principles:

- <u>Inclusion</u> The needs of older people from CALD backgrounds, their families and carers are included in the development of Australian Government ageing and aged care policies and programs on an ongoing basis.
- <u>Empowerment</u> Older people from CALD backgrounds, their families and carers are supported and have the knowledge and confidence to maximise their use of the aged care system.
- Access and Equity All areas of ageing and aged care understand the importance of and deliver culturally and linguistically responsive care.
- Quality Care and support services are appropriate to the needs of older people from CALD backgrounds, their families and carers and are assessed accordingly.
- <u>Capacity Building</u> Individuals from CALD backgrounds and CALD communities have the capacity to both articulate their ageing and aged care needs and be involved in the development of services and the workforce to meet these needs.

- Goal 5 Enhance the CALD sector's capacity to provide ageing and aged care services.
- Goal 6 Achieve better practice through improving research and data collection mechanisms that are inclusive of cultural and linguistic diversity in the ageing population.
